Gold smuggling gang busted

Detectives yesterday said they had busted a gold smuggling gang arresting 10 including its ringleader and seized 70 gold bars weighing eight kilograms and worth around Tk 3.6

Nine people of the gang except ringleader Nazrul Islam Liton, 46, were scheduled to fly for Malaysia Sunday evening, said Joint Commissioner Monirul Islam of Detective Branch (DB) of police at Dhaka Metropolitan Police (DMP) media centre in the capital.

The nine were arrested near the Boarding Bridge-2 at Hazrat Shahjalal International Airport with nine passports and currencies of different countries worth Tk 35 lakh, he

Acting on the information they had provided, the detectives arrested ringleader Liton raiding his house at Purana Paltan in the city a day later, he informed.

The law enforcers recovered 70 gold bars, Tk 3 lakh in cash and 5,000 Saudi riyals from Liton's possession.

The estimated price of eight kg gold bars was worth around Tk 3.6 crore, said DC (Media) of DMP Masudur Rahman.

Contempt rule

issued against him on the basis of a report published in English daily The Daily Star on May 18 under the headline "No rule of law".

Huda was relieved of the rule after he had expressed "sincere sorrow" and The Daily Star offered unconditional apology to the court through swearing affidavits.

He appeared before the HC bench of Justice Quazi Reza-Ul Hoque and Justice ABM Altaf Hossain as per a court order on May 18.

The newspaper published the actual statement of Huda on May 29, and apologised to the judiciary for misquoting him in its May 18 report.

The media should remain cautious about publishing reports so that the image and dignity of the judiciary is not damaged, Justice Reza-Ul Hoque said during yesterday's proceedings.

Justice Altaf Hossain said the statement of the former CEC had changed the public perception of the judiciary, and that such a statement was harmful for all. Huda had not made such statements when he was in the office of CEC for five years, the judge added.

Dr Kamal Hossain appeared for Huda and barrister Tanjib-Ul Alam argued for The Daily Star.

Elected uncontested to the House from Narayanganj-5, Nasim died in India on April 29.

Paying rich tributes to the late legislator, the leader of the House said there are some families and individuals who have been targeted by some vested quarters time and again since the tenure of Yahya Khan in Pakistan and the successive governments in Bangladesh after 1975.

"Their [families and individuals] small offences are always magnified. But there are many people who com mit major crimes, which are always overlooked by the vested quarters," noted Hasina.

She said if anyone commits a crime, that person will have to face trial. "And the law will take its own course.... But the nation will have to be careful so that no family is belittled politically and destroyed by conspiracies.

Describing Nasim's glorious role during the Liberation War and after the assassination of Bangabandhu, she said the nation will remember forever his rebellious role after the

assassination of Bangabandhu. The PM added: "He [Nasim] sacrificed his happiness, future and newly-wed wife only to avange the

murder of the Father of the Nation." ZIA BACKED KILLERS On the murder of Bangabandhu, she

said it is true that a member of the Awami League Khandaker Moshtaque Ahmed had killed Bangabandhu.

"But the killers of Bangabandhu --Col Faruk, Col Rashid, Col Huda, Dalim -- got full support from Zia [Gen Ziaur Rahman]," she mentioned.

In an interview with the BBC, Col Faruk had said when they went to Gen Zia, they got his full support in the conspiracy of killing Bangabandhu, recalled the PM.

top BNP leader had been leaked a day before the International Crimes Tribunal-1 delivered the judgement on October 1 last year, raising serious questions over the security of the highly protected tribunals.

Three days after the leak, detectives filed a case with Shahbagh Police Station against tribunal employees, cleaner Nayon Ali and office assistant Faruk Hossain, Salauddin's lawyer Fakrul Islam, his assistant Mehedi Hasan and several unnamed people under the Information Communication Technology Act,

2006. The police arrested Nayon and Faruk the same day. Nayon in his confessional statement on October 10 said he had started delivering the draft using a flash drive to Fakhrul Islam's office from September 15 last year and

earned Tk 500 to Tk 1,000 a day. The police on November 20 last year arrested Fakrul but could not

arrest Mehedi. Mohammad Shahjahan, investigation officer of the case, told The Daily Star: "The investigation is now at the

final stage, but we are waiting for the arrest of Mehedi Hasan."

Asked when they would submit the probe report, he said; "My higher authorities can say that." Contacted last week, Deputy

Commissioner of DB (South) Krishna Pada Roy, who is supervising the case, said: "I would not say it [investigation] is now at the final stage. Investigation is going on and it is not possible to tell the dateline.... We are trying to complete the investigation as early as possible," he said, adding, "You have to give us necessary time for conclusive disposal of the case."

He further said the evidence collected so far had proved the involvement of the three arrestees and Mehedi and they were looking for the latter.

Nasiruddin Mahmud said: "We [tribunal] are not satisfied with the progress of the investigation; actually, there is nothing to be satisfied with.

"The matter should be disposed of as early as possible for the sake of security of the tribunal," he added. Tureen Afroz said the leak was an

attempt to create a controversy over not only a specific case but also the entire war crimes trial proceedings. "So, the people involved in the incident must be detected," she said, adding, "But such delay is not expected." Shahriar Kabir, executive president

of Ekattarer Ghatak Dalal Nirmul Committee, said: "The investigation should not take eight months. It should have been done in seven to maximum 15 days." Such incidents will occur again and

the tribunal will fall under a security threat if the case is not dissolved properly, he added.

After the leak of Skype conversations between former ICT-1 chairman Justice Nizamul Huq and Belgium-based legal expert Ahmed Ziauddin in December 2012, war crimes trial campaigners had demanded an inquiry into the incident, but not much has apparently been done
