The Border Guard Bangladesh (BGB) headquarters yesterday issued a rejoinder to the caption of a photograph run by The Daily Star on June 2.

The rejoinder said: "It came to the notice of Headquarters BGB about publishing of a pictorial news on 02 June, 2014, in the 11th page of The Daily Star which was captioned "With the help of locals, BGB members remove landmines buried by Myanmar Border Guard Police at Bangladesh-Myanmar border yesterday. The landmines were buried between 50 and 52 border pillars at Naikkhangchhari in Bandarban.

Information of the captioned picture is not true. No such operation was conducted by BGB on that day. HQ BGB feels that, publication of such news is done intentionally with a view to hamper our ongoing joint efforts of rebuilding mutual trust and understanding between two neighboring countries. As such,

Headquarters BGB strongly protests the published news." OUR REPLY

The picture along with the caption was taken from Banglar Chokh, a photo and news agency. When the matter was brought to the agency's notice, it sent a correction to this newspaper saying that they had mistakenly posted the caption on their website on June 1 without mentioning it as a file photo.

The agency apologised for the inadvertent mistake.

India treated Pak PM like a schoolboy: Imran Khan

Pakistan Tehreek-i-Insaf chairman Imran Khan on Monday said his country's Prime Minister Nawaz Sharif was treated like a schoolboy when he visited India to attend Narendra Modi's swearing-in ceremony last week.

By not meeting the representatives of the Hurriyat Conference in New Delhi, the prime minister had struck a bargain on Kashmir, Dawn online quoted Khan as saying.

Khan raised questions like if Sharif could meet Indian leaders in Delhi, then why could he not hold a meeting with those representing the Hurriyat Conference.

Earlier Sharif's national security and foreign affairs adviser Sartaj Aziz had said that Sharif's India trip for Modi's swearing in was "in itself such a seismic event, the first time ever for a Pakistani leader, that it would have been unrealistic to expect any substantive breakthroughs.

Sharif met Modi on May 27 for the bilateral talks.

The two leaders discussed about issues including cross-border terrorism and agreed that terrorism was an issue of mutual concern and that they needed to address all conflicts to end the distrust between the

two sides. The Kashmir issue was dis-

cussed but not substantially. Sharif did not meet the Hurriyat leadership as it was a ceremonial visit to India, Aziz had said.

7-MURDER PROBE BODY

Nine N'ganj cops give depositions

The committee dealing with the gruesome seven-murder case in Narayanganj yesterday took deposition of nine police officials of the 12member probe body.

Earlier, three other officials of the probe body, formed by police to investigate the incident, gave their depositions before the members of the 12-member committee, headed by Shahjahan Ali Mollah.

With yesterday's deposition, the committee, formed following a High Court order, has taken depositions from individuals for the eighth time.

The then additional police super (administration) Sajjadur Rahman, withdrawn additional police super (crime) Shahidul Islam, additional police super (DSB) Md Zakaria, Fatullah Model Thana assistant police super Abdullah Al Mamun, assistant police super (Ka Zone) Azimul Ahsan, assistant police super (Kha Zone) Jibon Kanti Sarker, inspector of district police special branch (DB-1) Moinur Rahman, Narayanganj Sadar Model Thana OC Monzur Quader and Bandar Thana OC Akhter Morshed gave their depositions at the district circuit house.

As on every other day, Narayanganj District Bar Association organised a protest rally and formed a human chain in Narayanganj city, demanding punishment for the killers.

The bar association president, advocate Md Sakhawat Hossain Khan, alleged that attempts were being made to divert the case from its normal course.

Though the name of Shamim Osman has cropped up at different points of the investigation, he had not been interrogated yet, let alone being arrested, he told The Daily Star.

Management and Relief Minister Mofazzal Hossain Chowdhury Maya, had also not been quizzed, though his name also came up during the probe, he added. Shahidul Islam, father-in-law of the

Dipu Chowdhury, son of Disaster

murdered city corporation councillor Nazrul Islam, accused Dipu Chowdhury of mediating a deal between Noor Hossain and the Rab officials for Tk six crore.

Advocate Khan also said except the three Rab officials, no other people was arrested in connection with the killing and it raised suspicion that attempts were going on to divert the case.

"We are delighted that Prof Yunus has finally made it to Montreal to accept our award in person," Sonberg said.

"The work of social change is never easy. It requires intelligence, imagination, passion and commitment -qualities which Prof Yunus possesses in spades as well as much more, " she said.

The award was given to Prof Yunus in 2011, but he could collect it last week.

The award is being given since 2009 to recognise individuals or organisations who have made exceptional contributions to advancing equality, social justice and respect for human dignity.

government. He addressed the staff of the Department of Foreign Affairs, Trade and Development, and participated in an event with the Economic and Social Development Canada.

Yunus had a meeting with Canadian Finance Minister Joe Oliver, a microcredit enthusiast, and discussed the prospects of wider implementation of social business.

He also met Allison McCain, global president of McCain, in Toronto, and had talks about creating a social business fund in Canada.

Last year, Yunus launched a joint venture with McCain in Colombia called Campo Vivo, a social business to benefit farming families in Colombia.

premier Hasina with the Appellate Division of the Supreme Court in early 1999 in connection with her critical remarks about "granting of en masse bail" by the High Court Division.

The court asked the attorney general to submit a statement from the prime minister on her alleged remarks. The attorney general accordingly submitted a statement on February 17, 1999 to the Appellate Division explaining her remarks.

In the statement it was stated that her remarks were not intended to lower the dignity of the court or to interfere with the administration of the justice.

A full bench of the Appellate Division accepted the explanation of the premier and disposed of the contempt petition.

But the apex court observed that it expected more circumspection, understanding, discretion and judgement on the part of the prime minister because of the high office she holds in making off-hand remarks in respect of constitutional functionaries which have been alleged to be contumacious.

The story, however, did not end After one and a half years, three

contempt petitions were filed against then premier Hasina with the High Court Division for her remarks about granting of bail by the court. Hasina, in an interview with

BBC Bangla service on July 26, 2000, commented on the accountability of judges and lawyers for granting bail to criminals. She allegedly remarked that after obtaining bail from the courts, criminals further commit crimes and therefore, both the lawyers and judges should be accountable respectively for seeking and granting bail.

A High Court Division bench heard the three contempt petitions together and passed its judgement on October 24, 2000. It held views and made observations similar to the Appellate Division's.

"We are disposing of these three applications together in a similar manner and language with a note of desire that the Hon'ble Prime Minister shall be more careful and respectful in making any statement or comment with regard to the Judiciary or the judges or the Court of Bangladesh in future," the HC bench said.

After more than 14 years, Hasina has made some critical remarks against the HC for its order for arrest of the three Rab officials forced into retirement for alleged involvement in the abduction and killing of seven people in Narayanganj. Her Saturday's remarks appear a blow to the Supreme Court's expectation.

"When we were still investigating the matter ... and before that investigation was complete ... you tell us how come a High Court bench orders arrest of the three [Rab officers]?" she said in response to journalists' queries in a press confer-

Hasina continued, "When we struggle to take one step, some of them there take two/four steps and create such a situation that does not allow conducting a probe properly. It is a problem. I know my words are getting a bit harsh ... but what is real and true must be told."

Two days after the PM's remarks, Law Justice and Parliamentary Affairs Minister Anisul went a step further and cautioned against "judicial anarchy" and said judicial activism should not cross its boundary.

Ever since the tragedy, locals joined hands to have all the chemical stores and warehouses removed from Nimtoli area.

"A small shoe factory still runs secretly inside a house in Nimtoli," said Nasir Hossain, a stationary shop-owner who had lost his shop in the deadly fire. "When we came to know about it, the community put pressure and the factory owner promised to relocate it by July 31."

Gulzar and his brothers Mohammad Didar and Mohammad Faruk, who lost 11 members of their family in the incident, themselves are vocal against renting out spaces to chemical warehouses. "We did not know that they used

to keep chemicals there. The tenant told us that they want the place for storing plastic goods and we believed them naively," said Gulzar as he recalled the horror his family and many others suffered four years

"We want people to learn from our mistakes and be cautious about whom to rent out their places to. Landlords should also check on their tenants from time to time and see that they are complying with the rules," he told The Daily Star, urging the authorities to help relocate chemical warehouses from other parts of the

old town. Though the people of Nimtoli have collectively been able to prevent any chemical warehouses in the area, hazardous chemicals are still stored without any precautionary measures in other areas of Old Dhaka, especially Armanitola, Nabab Katra, Bangshal, Sat Rowza, Siddique Bazar, Babubazar and
