

## KILLING OF HINDU FARMER

# 7 BNP men charge-sheeted in Lalmonirhat

Police on Sunday pressed charges against seven BNP men in the case for killing a local farmer, Subol Chandra Roy, at Taluk Dulali village in Aditmari upazila on January 29.

The investigation officer (IO) of the case, subinspector Sheikh Shahin Kamal of Aditmari Police Station, submitted the charge sheet against them to the Chief Judicial Magistrate's Court's Judge Naresh Chandra Sarkar in the afternoon.

Of the accused, Gazi Uddin, organising secretary of Kamlabari union unit of BNP, and party activists of the same unit Islam, Saidul Islam, Dulal

Mia, and Saifuddin Mia of the same village got interim bail from the High Court, while Fazle Karim is still at large.

On January 29, a gang allegedly belonging to BNP and led by Gazi Uddin, swooped on Subol life. Chandra Roy, 50, of the village and his two sons Saiful Islam, Saifuddin and beat them mercilessly

on charge of casting their votes in the January 5 election, ignoring the polls boycott call.

Subol died on his way to Rangpur Medical College and Hospital on the same day.

Dhaneshwar Chandra Roy, younger brother of the victim, filed a murder case with Aditmari police station, accusing six local BNP men by name on February 3.

Meanwhile, due to the constant threat from the freed accused to withdraw the case, the victim's family filed a General Diary (GD) with the Aditmari police station seeking security of

A youth was murdered at Kaliabakri village in Damurhuda upazila of Chuadanga district yesterday morning, reports our correspondent. The deceased was identi-

fied as Mukul Hossain, 30,

son of Nur Islam, a freedom fighter of the village. Family members said Mukul went 'missing' after

he had left home at about 9:00pm on Monday. Local farmers saw the body of Mukul hanging

Follow-up Sit-in for arrear

Doctors and staff's at Thakurgaon Swasthoseba Hospital (diabetic) yesterday, the third day of indefinite strike, observed an hour-long sit-in programme in front of the Deputy Commissioner's Office.

Later they placed a memorandum to DC Mukesh Chandra Biswas regarding their demands including payment of salaries on regular basis with other dues.

The sit-in followed a discussion where several doctors and staffs spoke.

Earlier, the indefinite work abstention programme started on Saturday, demanding payment of nine months' arrear salaries.

Due to the strike, hundreds of patients including those needed eye and surgical treatment were suffering a lot. Many patients left the hospital without getting treatment, sources said.

The doctors and staffs said they had been passing hard days with their family members.

Salaries for nine months of doctors and staffs became pending in the last three years as the authorities did not make payments regularly showing various reasons, they said.

The staffs of the hospital were already burdened with huge loans. For this reason they cannot pay proper attention to duties and give better service to the patients, they said. We got our last salaries in March in the current year, they added.

The protesters threatened to continue their agitation and work abstention programme if they were not given all their salaries with other dues immediately.

According to hospital sources, about 15,000 registered diabetes patients are being treated under the hospital. Of them, 250-300 patients take treatment and service every day at the

# Gang leader of Laxmipur Didar Bahini shot dead

Locals allege death in police firing

A 'listed criminal' was shot dead by a rival gang at Kathalia village under Dighalia union in Sadar upazila of Laxmipur district early yesterday.

The deceased was identified as Ismail Hossain Khokon, 36, second-incommand of Didar Bahini, a notorious gang, and son of late Ali Ahmed of Titarkandi village in the same upazila.

Officer-in charge at Laxmipur Sadar police station Igbal Hossain said, a




In the case statement, Mehedi alleged that some Rab-14 members tortured Shahnur at the battalion's Bhairab camp in Kishoreganj.

He died at a hospital in Comilla on May 6 after being admitted there following a reference from the Brahmanbaria prison authorities.

Assistant Sub-Inspector Enamul Haq of Rab-14 led the team that picked up Shahnur from his home at Bogdohor village under Nabinagar upazila on April 29, the case statement reads.

Seven other unnamed Rab men and two civilians have also been made accused in the case.
