28 killed as militants raid Karachi

The bodies of the 18 victims of the Taliban assault -- including 11 airport security guards and four workers from Pakistan International Airlines (PIA) -were taken to a Karachi hospital where another 26 wounded people were being treated, a hospital official said.

After the siege, some 50 Civil Aviation Authority (CAA) and PIA employees who had been trapped inside the building all night were seen leaving. PIA spokesman Mashud Tajwar said no airline passengers were caught up in the incident.

Prime Minister Nawaz Sharif's office issued a statement "commending the bravery" of security forces and saying normal flight operations would resume in the afternoon, while Afghan President Hamid Karzai -- who is battling his own Taliban insurgency -condemned the attack in a statement.

The airport remained on high alert late yesterday with military patrolling the area as engineers carry out inspections on planes before outbound

flights resume, a CAA official said. The TTP said the brazen attack was its latest revenge for its late leader Hakimullah Mehsud, who was killed

in a US drone strike in November. TTP spokesman Shahidullah Shahid said the Pakistani government had used peace talks as a ruse, and promised more attacks to come in retaliation against recent air strikes in the tribal areas bordering Afghanistan. A statement later issued by the group

said the targets were selected "to have minimum public loss and maximum loss of government personnel", implying the TTP had not planned to attack any planes on the airport tarmac.

Talks to end the TTP's bloody sevenyear insurgency in Pakistan have been underway since February, after Sharif returned to power last year, but little clear progress has resulted and more than 300 people have been killed in militant strikes since then.

The assault will raise fresh concerns about Pakistan's shaky security situation, and questions about how militants were able to penetrate the airport, which serves one of the world's biggest cities.

Pakistan's military has carried out a series of airstrikes in the TTP's base in North Waziristan in recent weeks, killing dozens of people but holding back from a full-blown ground offen-

Security analyst Imtiaz Gul said the strikes had not hindered the TTP's ability to carry out massive attacks thanks to its penetration of major cities, particularly Karachi, through sleeper cells.

"This is clearly part of a campaign aimed at hurting Pakistan's strategic and economic interests. It sends a clear message to foreigners also: don't come to this country," he said.

A senior intelligence official added

that the city was an emerging base for the Taliban where they are able to both plan and raise funds for attacks.

"The Karachi based militants have been told to not carry smaller terrorism activity but only take up bigger terrorism acts which could create much hype," he said on condition of anonymity.

The Taliban makes use of allied groups like the anti-Shiite Lashkar-e-Jhangvi to carry out such attacks, he added.

Officials said the gunmen entered from two sides of the airport at around 11:00 pm on Sunday -- the terminal used for the hajj pilgrimage to Mecca, and an engineering section close to an old terminal.

An AFP reporter witnessed three huge blasts as suicide bombers detonated their explosives.

Smoke was seen billowing from the airport as fires raged close to planes parked on the runway, while militants clashed with the airport's security force who were backed by police, paramilitary squads and elite commandos.

In 2011, Taliban gunmen attacked the Mehran naval base, which lies close to the Karachi airport, destroying two US-made Orion aircraft and killing 10 personnel in a 17-hour siege.

The group also carried out a raid on Pakistan's military headquarters in the garrison city of Rawalpindi in 2009, leaving 23 dead including 11 troops and three hostages.

New Delhi also mulls offering visaon-arrival facility for the Maitree Express passengers, mentioned the sources.

On the Maitree Express, official sources said the train now operates twice a week, but India wants to make it thrice a week. In future the train could run every day.

According to railway sources, the Maitree Express had over 80 percent occupancy in the last three months. The train, which was introduced in 2008, takes over 10 hours to reach Dhaka after customs and immigration formalities at Gede in India and Darshana in Bangladesh.

The Dhaka-Kolkata bus service has Dhaka-Agartala bus service since ratification of the LBA. 2001.

The Maitree Express under the Indian railways leaves Kolkata on Tuesday and returns from Dhaka the following day. From Bangladesh, the train leaves Dhaka on Friday and departs Kolkata the following day.

According to a report run by the Times of India yesterday, Indian foreign officials are ready to discuss agendas including extending the route of Maitree Express from Dhaka to Chittagong.

For connecting North Bengal to Kolkata via Bangladesh, the option of using an old route via Hardinge Bridge on the river Padma will be discussed The new route can be from Kolkata to Ranaghat and then through Bangladesh up to Hili, from where passengers will travel to New Jalpaiguri, the report added.

Meanwhile, sources said though BNP Chairperson Khaleda Zia is no holding any official position, Sushma Swaraj might meet the former prime minister as the BJP government wants to put importance on maintaining relations with the BNP considering future elections in Bangladesh.

The local administration has knocked down a demarcation pillar installed by people intending to take over the ancestral home of poet Golam Mostafa in Jhenidah.

It has also told them not to try to occupy the poet's house in Monohorpur village of Shailkupa upazila.

Yesterday morning, Mohammad Ali Prince, Shailkupa upazila nirbahi officer, along with other officials went to the house and demolished the demarcation pillar.

The UNO said they had knocked down the pillar on the directives of Deputy Commissioner of Jhenidah Shafikul Islam.

On Sunday, The Daily Star published a report on land grabbers' attempts to occupy the poet's home. The house was built by the poet

himself on five bighas of land in Monohorpur village. Mostafa (1897-1964), who is considered to be an icon of Islamic

renaissance in Bengali literature, was born in the village and breathed his last in this very house in 1964. Recently, Sadar Uddin and Alauddin, two brothers, have come up

with the claim that they own 24 decimals of land of the house complex. According to the poet's children

More ammo recovered

recovered more ammunition at the Satchhari National Park in Chunarughat upazila of Habiganj on the eighth consecutive day of their drive.

The Rapid Action Battalion yesterday

The elite crime busters recovered one machine gun barrel, 633 bullets of machine guns and rifles and 54 antitank shells from one new bunker, said Sana Shaminur Rahman, camp commander of Rab-9 in Shrimangal, at a press briefing on the spot.

The Rab personnel also found four machine guns and oil used for cleaning firearms and two more empty bunkers on Sunday.

The firearms and ammunition recovered in the past one week had been sent to the Central Ammunition Depot in Dhaka and Bangladesh Ordnance Factories in Gazipur, said the Rab official.

However, the elite force could not

arrest anyone in this connection. The reserve forest, about three kilometres off the Indian state of Tripura, was used as a route by Indian separatist groups for smuggling arms, according to the investigations conducted after the 2003 arms haul in Bogra.

The Rab first laid its hands on 184 anti-tank rocket shells (40mm) and 153 rocket charges on June 3 inside a bunker at a hillock of the forest.

Six more empty bunkers were found on that day, Rab sources said. The next day law enforcers found two more bunkers piled with a cache of arms and

ammunition. Earlier, Rab Media Wing Director Habibur Rahman said the arms and ammunition recovered in the forest were apparently similar to those recovered in Chittagong in 2004 and

"Hoisting flags on rooftops has now turned into a competition among the young generation. One of my grandsons, who is studying in class III, forcefully took Tk 300 from me and hoisted a Brazil flag," said 74-year-old Ahsanullah.

Amzad Hossain and Ahsanullah may not stay up nights due to their advanced years but members of the young generation like salesman Abu Naimur Raju, car driver Rubel Mia and businessman Mohammad Ripon are eagerly anticipating night time vigils for their favourite Argentina and Brazil, even at the risk of compromising their jobs.

"I will drive my car half-day during the World Cup," said Rubel.

"Each World Cup comes once in four years, so I can sacrifice a few days to watch my favourite Argentina," said electronics businessman Ripon while Raju and his friends plan to get their hands on a projector to watch the matches on a giant screen.

5 HC judges' job

World Cup merchandise is big business now and businessmen ranging from street hawkers to posh retailers are cashing in on the fervour, especially after the underwhelming response to the ICC World Twenty20 at home. Items range in price from flags at Tk 10 to replica Brazuca balls available at Tk 2,200.

"We have already sold approximately 5,000 jerseys priced between Tk 600 and Tk 1200 and we have achieved 70 per cent of our sales target," said Inter Sports' account officer Abu Sayeed Riad, adding that sales of local replicas of the Brazuca ball has also been good.

"Initially we did not import a lot of jerseys in fear of low sales like during the ICC T20 World Cup but this time, we have had to meet demand by bringing in goods from other shops," said Nazimuddin, a shareholders of Sports Pavilion at Elephant Road.

Echoing Nazimuddin's sentiment, Omar Chisty Sunny, owner of Sports Centre at Twin Tower in Gulistan, said, "We are not prepared for such

responses from fans because we feared a repeat of the fans' disinterest like during the ICC World Twenty20. The reality is that the demand is ten times higher than our calculations."

Sunny said that approximately three crore local and imported jerseys from three wholesale markets -- Twin Tower, City Plaza and Gulistan Shopping Complex -- are expected to

Street hawkers like Mainuddin, Yeasin and Malek at Gulistan are doing brisk business, pocketing Tk 50 to Tk 80 from each jersey while flag vendor Abdul Kudddus is hoping to make Tk 25,000 profit from his stock of 1100

Such lucrative prospects have even made many reconsider their profession or line of goods. Fish vendor Nurul Islam of Rayerbazar and erstwhile CNG driver Shah Alam have both temporarily abandoned their regular vocations and joined the thousands of merchandise vendors, because the city just cannot get enough of Brazil 2014.

No probe report yet
