

## Justice BK Das passes away

Former advisor to a caretaker government, Justice Bijan Kumar Das passed away at a hospital in the capital yesterday morning. He was 71.

Justice Das left behind a son and a daughter, said a press release.

His body was taken to Supreme Court premises where lawyers and judges, including Chief Justice Md Muzammel Hossain and Attorney General Mahubbay Alam, paid tribute to him.

He was the chairman of Bangladesh Press Council from 2010 to 2013.

He had served as a judge of the High Court and also the Appellate Division for 12 years.

Earlier, former forest and environment minister Hasan Mahmud advised the media not to publish or broadcast any news of BNP Senior Vice Chairman Tarique Rahman, terming him immature and foolish.

"I will urge all the media 'please don't publish any immature and foolish speech of him' [Tarique]. The nation will benefit then," he said.

Hasan, also central publicity secretary of the Awami League, launched a personal attack on BNP chief Khaleda Zia and former president AQM Badruddoza Chowdhury.

The former minister described Badruddoza, also chairman of Bikolpodhara Bangladesh, as a plotter of the Zia killing and said Khaleda Zia instigated him in the assassination.

Hasan also made some remarks on Khaleda's outfit during her visit to Zia's mazar. The Daily Star refrained from writing those remarks considering those abusive.

After Hasan, independent MP Rustom Ali Farazi pointed out the sorry state of MP buildings on Manik Mia Avenue. "There is no atmosphere in and outside the buildings for living there," he said, without elaborating.

# C'wealth, UK keen to work with NHRC

Representatives of the Commonwealth and British high commission are keen to work with the National Human Rights Commission (NHRC) in addressing human rights violation by law enforcers, said Kazi Reazul Hoque, a member of NHRC, yesterday.

Hoque was talking to reporters at the commission's office in the capital, after a meeting with Julie Scott, head of Bangladesh, Sri Lanka and Maldives team, Foreign and Commonwealth Office; and Steve Dodds, second secretary (political) at the British high commission.

Hoque said they discussed the need for amending the law which limits the commission's power to summon police officers who are accused of violating human rights.

Currently, the NHRC receives funding from UNDP, Sweden, Switzerland and Denmark for different projects aimed at creating awareness and capacity building of the commission.

# Prosecutor Tureen accuses colleague again

A prosecutor at the International Crimes Tribunal has once again lodged a complaint against one of her colleagues allegedly over "professional misconduct", dealing a new blow to the sharply divided lawyers' panel.

Tureen Afroz filed the complaint against Mohammad Ali, a second one in three months, with the acting chief prosecutor yesterday, a day after Ali issued a press statement accusing Tureen of making "derogatory comments and false statements" against him in the media.

Tureen told The Daily Star that she had submitted the petition to Syed Haider Ali but Haider said he was yet to receive any such complaint.

In the letter, Tureen said Mohammad Ali made the allegations against her at a "press conference" on Wednesday. "Mohammad Ali continued with his unethical and unprofessional behaviour of maligning me personally, socially and professionally," claimed Tureen.

Mohammad Ali on Wednesday said he issued the statement "upon instructions" of Haider, but Tureen in her letter said Haider had no knowledge of the matter.

Mohammad Ali denied holding any press conference and said he just talked to some journalists at his office. He also accused Tureen of tarnishing his goodwill.

Tureen filed a similar complaint against Mohammad Ali in March.
