

All applicants must have at least a Bachelor Degree in any field of study. The minimum qualifying point is seven (07) for all applicants. The points are calculated as follows:

Applicants who have taken the A-Level examination must pass at least two (02) subjects with a minimum of grade D in each of these subjects.

\*Letter grades of O-Level and A-Level subjects are converted into grade points as follows: A = 4, B = 3, C = 2 and D = 1. Grade Point Average (GPA) is calculated by averaging the grade points of the best five grades of O-level and the best two grades of A-Level.
