# Dharla devours 100 bighas of cropland in Lalmonirhat

45 homesteads have also gone into the river in two days

Erosion by the River Dharla has taken an alarming turn in the last two days, devouring at least 45 homesteads and over 100 bighas of croplands at seven villages in Mogholhat and Kulaghat unions under Sadar upazila.

The affected villages are Badaitari, Kurul, Etapota and Majhitari in Mogholhat union, Shiberkuti, Char Kulaghat and Bongram in Kulaghat union.

The erosion-hit people have taken shelter on roads and highway, said local Water Development Board (WDB) sources.

A good number of homesteads, orchards and a vast tract of cropland in the area are also under threat of erosion, said Habibur Rahman, chairman of Mogholhat union parishad.

# Four of a family injured in BSF firing on Kurigram border

Four members of a family, including a child, sustained bullet injuries as Indian Border Security Force (BSF) opened fire on them on Khalisha Kotal frontier in Phulbari upazila on Sunday night.

The injured are Sheuli Rani Dash, 40, wife of Rintu Dash, 45, her daughter Srabanti Dash, 3, brothers Ajoy Chandra Dash, 20, and Debal Chandra Dash, 18, of the area.

They were admitted to the upazila health complex, said Border Guard Bangladesh (BGB) sources.

## Municipality, RHD in dispute over road billboards

Dispute between Lalmonirhat Municipality and the Roads and Highways Department (RHD) regarding responsibility of an important road passing through the town causes trouble for an ad firm that set up three billboards there.

Neptune Ad Firm set up the three billboards on Lalmonirhat-Burimari Highway at Mission Intersection in the town after taking permission from the municipality authorities a month ago.

But the RHD authorities in last week sent a letter to Neptune Ad

Firm, asking for removal of the billboards from the highway at their own cost, RHD official sources said. Kazi Moin Uddin, gen-

eral manger of Neptune Ad Firm, said, "We set up these billboards after getting permission from the municipality authorities and receiving all the relevant documents. But our firm is yet to start the business through display of ads due to interference from RHD staff. We submitted a letter to the RHD authorities concerned, seeking permission for using the billboards on the road last week."

Contacted, Lalmonirhat Municipality Mayor Reazul Islam Rintu, said, "I gave

Firm for using billboards on the road and informed the RHD officials of the matter. Municipality is the authority concerned regarding the matter but the RHD authorities challenged the municipality's permission and issued


