EXTRADITION OF NUR HOSSAIN

Dhaka waits for Delhi's response

Probe body members may fly to Kolkata, hope to quiz him

Bangladesh is awaiting an official response from India over the arrest and extradition of Nur Hossain, State Minister for Foreign Affairs M Shahriar Alam said yesterday.

"We've written to the Indian authorities, and are waiting for their response," he told newsmen at the capital's Sonargaon Hotel.

Hossain is the key accused in the sensational seven-murder in Narayanganj. Meanwhile, Shahjahan Ali Mollah, chief of the government-formed probe

body, has said the committee members may fly to Kolkata to quiz Hossain if the extradition takes time. The government, said the state minister, will let the media know about the

matter once it gets any feedback from India. "It usually takes time. We're working on it through maintaining diplomatic protocol," he added. His comments came a day after he told the BBC Bangla Service that

Bangladesh had initiated the process of bringing Hossain back home.

Shahriar said the government had received support from Interpol, which was necessary for the arrest of Hossain.

The intergovernmental organisation on its website published six charges brought against Hossain by the Bangladesh authorities.

Deal signed for building Padma bridge

The government yesterday struck a deal with China Major Bridge Engineering Company Ltd for the construction of the main part of Padma bridge.

The Chinese company has submitted a performance guarantee of 10.17 percent of the contract value worth Tk 12,133 crore with the United Commercial Bank Ltd.

Lieu Ziming, chairman of the Chinese company, and Shafiqul Islam, project director of the bridge project, penned the agreement on behalf of their respective sides at Ruposhi Bangla Hotel in Dhaka.

According to the agreement, the Chinese company will have to pay Tk 1,820 crore to Bangladesh by this June as advance payment, said a statement of the communications ministry.

Daily Star over the phone that initially it was a clash between two Bihari groups but non-residents of the camp were drawn into it after one of them was attacked. Yesterday, eyewitnesses told Detective Branch (DB) of

Police and journalists how Bihari homes were set ablaze in the presence of police. The fire killed nine members of a family.

Locals, cops were Qaisar behind killing of freedom fighters

Martyr's daughter testifies at tribunal

A martyred freedom fighter's daughter yesterday testified that she had seen Pakistani army killing her father and three other freedom fighters in Habiganj following a "signal" from Syed Mohammad Qaisar during the Liberation War in 1971.

Majeda Khatun alias Jamila Khatun, daughter of Akkas Ali of Mouzpur village under Madhabpur, Habiganj, said she had begged for her father's life touching Qaisar's feet in vain.

As the 26th prosecution witness in the case against Qaisar, Majeda gave a first-hand account how her father and three others were

picked up by Qaisar and his accomplices from their village, tortured at an army camp and finally killed upon Qaisar's signal.

Qaisar, a former state minister of HM Ershad's regime, faces 16 charges, including genocide, committed in Habiganj and Brahmanbaria during the nine-month-long war. The accused, who is now on bail, however, denies the allegations.

Majeda, during her 39-minute testimony, said Qaisar had taken part in the 1970's election from their locality but was defeated by Awami League candidate Asad Ali. "I saw him [Qaisar] when he had come to our locality to seek vote," said the 75-year-old witness.

"We will introduce a new link on our website. Voters will have to login with the link using their national ID card numbers. Then, they will see their names, voter numbers and polling stations," Motiar Rahman, deputy secretary of the EC secretariat, told The Daily Star.

The decision was made at a commission meeting at its secretariat yesterday, said EC officials.

"In many cases, we see people suffer or face harassment finding out their voter numbers and polling stations. The new system will ease their sufferings," Motiar said.




