approval and in next week the charge sheet may be submitted to the court, he added.


Woman's body recovered in Ctg

Qaisar's aides killed father

Freedom fighter's son testifies at war crimes tribunal

The son of a martyred freedom fighter yesterday testified that he saw the cohorts of war crimes accused Syed Mohammad Qaisar kill his father and three other freedom fighters in the district following a "signal" from Qaisar in 1971.

Renu Miah, son of Siraj Miah of Mouzpur village under Madhabpur upazila, Habiganj, told the International Crimes Tribunal-2 that Qaisar and his accomplices had also tortured his father before death and the accused rejected their earnest request to release him.

On Tuesday, Majeda Khatun, daughter of Akkas Ali, one of the four victims from

Mouzpur, gave a testimony almost identical to Renu's. She said she saw the Pakistani army kill her father and three other freedom fighters following Qaisar's signal. Qaisar, a former state minister of HM

Ershad's regime, faces 16 charges over crimes, including genocide, in Habiganj and Brahmanbaria during the war. The accused, now on bail, however, denies the allegations. Renu, the 27th prosecution witness in Qaisar's case, said his father and the three of

his fellow freedom fighters slept at their house on the night of the 11th of Bangla month Ashwin.

SCBA files review petition

The Supreme Court Bar Association (SCBA) yesterday filed a review petition with the Supreme Court against its guidelines for the High Court in granting anticipatory bail to people.

The Appellate Division of the SC issued some guidelines in a verdict on February 24 and expressed disappointment at an HC bench for "failure to follow its guidelines" in giving anticipatory bail to BNP leader Khandaker Mosharraf Hossain in a money laundering case. The Appellate Division

said the HC had to scrutinise the facts in the FIR with "expected diligence", and would not grant anticipatory bail "where the allegations are of heinous nature". If satisfied in all respects,

the HC will dispose of the anticipatory bail applications instantly without issuing any rule, and will not grant such type of bail to an accused for more than four weeks, the judgment said. "Anticipatory bails shall

not survive post-charge sheet stage." The HC judges will men-

tion the reasons for granting anticipatory bail to an accused and "shall give reasons for their satisfaction on this unravelling point," the apex court said. "Political threshold of

the [bail] petitioner or claimed rivalry, by itself, without further ado, shall not be a ground for entertaining an application".

HC upholds death sentence on seven

The High Court yesterday upheld a lower court judgment that sentenced seven persons to death in a case filed for killing six members of a family in Narsingdi in 2007.

The death row convicts are Akhtaruzzaman Biru, Dhud Miah, Sharif Bhuiyan, Shahid Mia, Fazlul Haq, Swapan Mia and Jahangir. They are all now in Narsingdi jail.

The HC has affirmed their death sentence, as the allegations brought against them for killing six people have been proved, Deputy Attorney General Bhishmadev Chakrabortty told The Daily Star.

According to the prosecution, Raisuddin, 52, his wife Salma Begum, 48, their son Rajib, 22, and daughters Yuona, 28, Swarna, 26, and adopted daughter Urmi, 8, were killed at their house at Bhelanagar in Narsingdi town on the night of May 17, 2007. The criminals slit the throats of Yuona and Swarna after rape and strangled four others.

Raisuddin's younger brother Shahjahan Bhuiyan alias Ratan filed the murder case NARSINGDI with Narsingdi Sadar Police

Station. Additional District and Sessions Judge AKM Abul

Kashem of Narsingdi on March 17, 2008 gave the death sentence to the seven convicts for the killing.

Yesterday, the HC bench of Justice Bhabani Prasad Singha delivered the verdict after hearing the appeals filed by the condemned convicts against the lower court judgment.

Earlier on January 19 this year, a two-judge HC bench delivered a split verdict over a lower court judgment that sentenced seven persons to death in the same case.

Senior judge of the bench Justice Shahidul Islam turned down the lower court verdict while junior judge of the bench Justice Abdur Rob upheld it. The judges then sent the case records along with their verdicts to the chief justice. Later, Chief Justice Md Muzammel Hossain sent those to

the HC bench of Justice Bhabani Prasad Singha for its final disposal. This bench yesterday dismissed the appeals filed by the convicts. Khabir Uddin Bhuiyan, a defence lawyer, told The Daily

Supreme Court against the HC verdict.
