Dissolve newly formed district, city units

Demands Rangpur BNP faction at hunger strike

Man killed allegedly by wife, housewife murdered after rape

A young man was killed allegedly by his wife and a housewife was murdered after rape in two upazilas of the district yesterday and Tuesday night. A woman chopped her

husband to death over a family feud at Laxmipur village in Baraigram upazila of the district yesterday morning.

The deceased is Selim Hossain, 26, son of Abul Hossain of the village.

Police later detained the housewife Jesmin.

Police quoted locals as saying that the couple used to quarrel with each other over trivial matters. At one stage of their altercation yesterday, Jesmin chopped Selim with a cleaver, leaving him dead on the spot.

Being informed, police recovered the body and sent for autopsy.

Away in Lalpur upazila, a housewife was killed after raped by a gang of criminals at Berilabari village of the upazila on Tuesday night.

Police recovered the body of the victim, Minoti Begum, 30, wife of late Moinul Islam of the village and sent it to Natore Sadar Hospital morgue for autopsy.

Police quoting locals said criminals picked up Minoti when she came out of their house to respond to the call of nature and took her to a nearby mango orchard.

They violated Minoti there and strangled her to death, police said.

Mahfuzzaman Ashrafi, assistant superintendent of police (Baraigram circle) said police detained local four youths for integration.

Medicine shop owners jailed

Two medicine shop owners of Panchagarh district have been sentenced to different jail terms for selling injections of anesthetic without any prescription. The convicts are Zakir Hossain, 25, owner of 'Ma Pharmacy' at Masjid market in the district town and Mizanur Rahman, 22, owner of 'Mizan Pharmacy' at Jagdal Bazar in Sadar upazila. Of them, Zakir was awarded one year jail and fined Tk 1,000 while Mizanur got a six-month jail. Detective Branch (DB) of police in separate drives arrested Zakir and Mizanur yesterday and the day before on charge of selling injections without any proper prescription of doctors.

600 kg hilsa seized

Members of Border Guard Bangladesh (BGB) seized 600 kilograms of Hilsa fish worth Tk 6 lakh from Amrakhali area in Benapole yesterday morning. 26 BGB Benapole Company Commander Rafiqul Islam said on secret information, a team raided the border area and seized the fishes while those were being smuggled to India at 8:30am. Sensing the presence of the border guards, the smugglers managed to flee. Later, the seized hilsa was deposited to Customs House godown. A case was filed in this connection.

Welding worker electrocuted

Wife burned to death by Khansama health complex in Dinajpur in poor health

Patients of Khansama upazila under the district are deprived of treatment facilities as the upazila health complex is plagued with various problems including lack of doctors and staff, unhygienic environment and absence of ambulance service.

Surprisingly though, all the 12 posts of doctors at the 31-bed hospital meant for 1.72 lakh people of the upazila are now vacant.

Ashraful Alam Mukul, a medical officer of Bhabki union health service centre, has been deputed to the upazila health complex recently.

Visiting the health complex a couple of days ago, Being informed by this correspondent saw locals, victim's family medical wastes and pieces of rotten food littering in and round the health complex that has virtually 25 beds, instead of 31.

The environment of the health complex is far from being congenial for the Mohammad treatment, said Rafigul Islam, visitor of a patient there.


