#### BCL leader 'threatens Subhan abetted killing of my father, five uncles

Man testifies at war crimes tribunal STAFF CORRESPONDENT

A prosecution witness yesterday testified that 11 people, including his father and five paternal uncles, were killed after the Pakistani army led by Jamaat-e-Islami leader Abdus Subhan took them away from their village in Pabna Sadar during the liber-

ation war. Ali Rana Sheikh, the 17th prosecution witness in Subhan's case, said Subhan ordered the Pakistani army to kill one of his uncles.

"I witnessed the killing," Rana told the International Crimes Tribunal, as he described the abduction, torture and subsequent killings of his family members and co-villagers.

Rana was the second witness to testify about the killing of the 11. Earlier, Akkas Sheikh, brother of one victim, gave deposition about the same killings.

### Poll probe body asked to enquire

The electoral enquiry committee has been asked to investigate allegations of a police officer being threatened by ruling party lawmaker Shamim Osman on the day of the Narayanganj-5 by-polls.

"We have sent the matter [threat allegation] to the committee today [Sunday] for an investigation into it," Mihir Sarwar Morshed, returning officer of the by-polls, told The Daily Star yesterday.

"After getting the committee's report, we will take further steps on this issue," he said. Shamim is alleged to have verbally abused and threat-

ened Bashir Uddin, an assistant superintendent of police in Narayanganj, when the law enforcers foiled a bid to cast false votes for Shamim's brother Selim Osman at the byelection.

Bashir later filed a general diary in this connection. As per Representation of People Order (RPO), the enquiry

committee will submit its report within three days, Sirajul Islam, acting secretary to the Election Commission, said. The two-member enquiry committee, led by a joint dis-

trict judge, was formed before the election to prevent and control polls-related irregularities. Jatiya Party nominee Selim Osman won Thursday's bypolls, defeating renegade Awami League leader and inde-

pendent candidate SM Akram by 16,742 votes. Huge numbers of fake votes were cast by supporters of Selim Osman, according to news reports and election observers.

Selim Osman ran for parliament from Narayanganj-5 constituency on a Jatiya Party ticket. His brother Shamim is the Awami League MP from Narayanganj-4.

The Narayanganj-5 parliamentary seat fell vacant after their brother Nasim Osman died.
