QAISAR'S WAR CRIMES TRIAL Tribunal refuses to take witnesses' statements as evidence

The International Crimes Tribunal-2 yesterday rejected a prosecution petition for considering the statements of five prosecution witnesses given to the investigation officer as evidence in the war crimes case against former state minister Syed Mohammad Qaisar.

Moving the petition, Prosecutor Rana Dasgupta said three witnesses died after giving statements to the investigator, while two witnesses, including exminister Enamul Haque Mostofa Shaheed, "are too sick" to come to the tribunal to testify. "So, their statements should be taken as evidence," he said.

Defence counsel SM Shahjahan opposed the petition, saying that as the three died before submission of the probe report, they should not have been named as witnesses.

EC gets conflicting reports

The Election Commission has found inconsistencies in the numbers of electorates in some 90 constituencies in the January 5 national polls after scrutinising the figures it received separately from the returning officers and the presiding officers.

After the vote, the presiding officers, individuals in charge of the polling stations, sent one set of the figures to the returning officer, the official responsible for a constituency, and another set to the EC.

Later, the returning officer complied the figures it received from the presiding officers of her/his constituency and forwarded the total number to the EC.

EC's senior assistant secretary Farhad Hossain told The Daily Star that the range

would be no more than 20 to 30 voters, and that the insignificant numbers would not affect the election results. "It may have occurred due to migration

of the discrepancies in each constituency

of voters from one constituency to another," he said. The EC has recently sent letters to the respective returning officers to remove

the inconsistencies and send fresh numbers again, said the commission sources. The 90 constituencies are spread

throughout 25 districts, including Satkhira, Bramhanbaria, Tangail, Mymensingh, Sherpur, Bogra, Rajshahi, Nilphamari, Panchagar and Thakurgoan. In the 10th parliamentary elections,

153 MPs were elected uncontested, while voting was held in the remaining 147 constituencies.

Construction work of the Padma bridge begins this month and it is expected to open for traffic by 2018, said Communications Minister Obaidul Quader yesterday in parliament.

"Meantime, the construction of approach roads and other construction works for the bridge have already started by spending Tk 2,500 crore, while total estimated cost of the two-level Padma bridge construction will not exceed US dollar three billion," he said.

Replying to lawmakers' queries, the minister said the estimated cost for the construction of main bridge is Tk 12, 100 crore while

Law enacted for journo welfare

Insolvent, wounded, sick journalists to get financial assistance

Parliament yesterday passed the 'Bangladesh Journalists Welfare Trust Bill 2014' to ensure welfare of the insolvent, wounded and sick journalists and dependants of deceased journalists.

Information Minister Hasanul Haq Inu piloted the bill before the Jatiya Sangsad for its passage.

A 13-member board of trustee with the information minister as its chairman and information secretary as its vice-chairman will be formed under the law. The government will appoint its managing director who will also act as the member secretary of the board.

Other members of the board are principal information officer, a director general level officer to be nominated by the prime ministers' office, a finance division officer with the rank and status of not below a joint secretary, director general of Bangladesh Press Institute, joint secretary (press) of the information ministry, two representative from


