They are Nur Muhammad Shahidullah of Dhaka College, Adib Hasan and Md Sanjid Anwar of Mymensingh District School Sajid Akhtar Turjo of BL Government High School in Sirajganj, Asif-e-Elahi of Sylhet Government Pilot High School, and Mutasim Mim of Rajshahi College.

WAR CRIMES TRIAL VERDICT LEAK

SQ Chy's lawyer denied bail

The High Court yesterday rejected a bail petition filed by AKM Fakhrul Islam, a lawyer for convicted war criminal Salauddin Quader Chowdhury, in a case lodged for leaking the draft verdict against Salauddin.

The HC bench of Justice Md Rezaul Haque and Justice Gobinda Chandra Tagore delivered the verdict after hearing arguments on the petitions. During hearing, Attorney General Mahbubey Alam

vehemently opposed the bail petition, saying that Fakhrul had tarnished the image of the judiciary by leaking the draft verdict in war crimes case against Salauddin. Meanwhile, Fakhrul's lawyer Khandker Mahbub Hossain

prayed to the court to grant bail to his client, saying that Fakhrul's name was not mentioned in the first information report of the case and he would not leave the country. M Masud Rana, another lawyer for Fakhrul, told The Daily Star that they were yet to decide whether they would

move an appeal before the Supreme Court against the HC verdict. The draft verdict was leaked a day before the International Crimes Tribunal-1, on October 1 last year, sentenced

Salauddin to death for committing crimes against humanity and genocide during the 1971 Liberation War. The ICT authorities then filed the case with Shahbagh Police Station against two tribunal employees--cleaner Nayon Ali and office assistant Faruk Hossain; and advocate

Mehedi Hassan, an assistant of Fakhrul.
