

Death anniversary

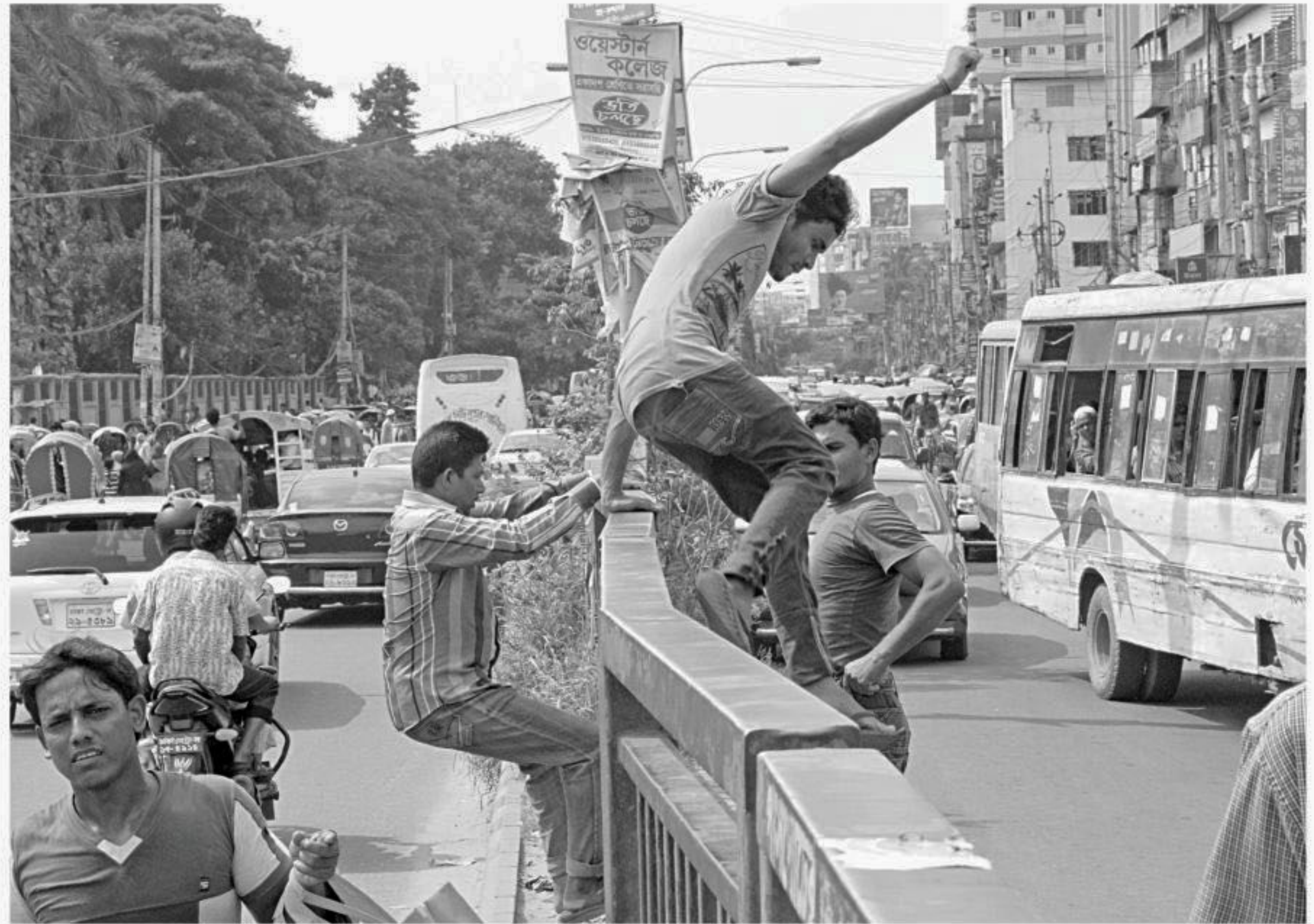

The first death anniversary of eminent jurist and constitution expert Dr Muhammad Zahir will be observed on Friday.

His family will arrange a Qurankhwani and a doa mahfil.

He taught company law at Dhaka University and was a senior advocate of the Supreme Court, the convener and member of several company law reform committees in Bangladesh, and was elected a member of the Court of Arbitration at the International Chamber of Commerce in Paris, France.

He authored the renowned analytical legal publication, "Company and Securities Laws", which is widely being used as a book of reference in South Asia.

RADAR PURCHASE GRAFT CASE AGAINST ERSHAD Senior special judge's court to hold trial now

A senior special judge's court of Dhaka will now conduct the trial of the radar purchase graft case against HM Ershad and three others.

Judge Md Jahurul Haque of the special court yesterday asked Ershad and the other accused to appear before it on August 20. The court also fixed the same date for hearing arguments from the prosecution.

Earlier on June 11, Judge Abdur Rashid of the Special Court for Dhaka Division expressed his reluctance to preside over the case trial against Ershad and the others.

The court also ordered transfer of the case to Jahurul Haque's court, which had previously sent it to Rashid's court in 1994. On May 4, 1992, the then Bureau of Anti-Corruption filed the case against Ershad; Sultan Mahmud and Mamtazuddin Ahmed, former air force chiefs; and AKM Musa and Shahazad Ali, directors of United Traders Ltd.

Charges against Shahazad were later withdrawn. Musa has been absconding since filing of the case. According to the prosecution, Ershad in collusion with the others allegedly caused a loss of Tk 64.04 crore to the state exchequer by purchasing two radars from the US instead of France for the air force while he was in power.

COP, WIFE MURDER Trial begins

The trial in a police official and his wife murder case began at a Dhaka court yesterday with deposition of the complainant.

The bodies of Mahfuzur Rahman, an inspector of the Special Branch of Police, and his wife Swapna Rahman were found at their Chamelbagh residence in the capital on August 16 last year.

Their daughter Oishee, who had taken her O-level exams, surrendered to Paltan police the following day.

Oishee, 19, and her two friends--Asaduzzaman Johnny, 27, and Mizanur Rahman Roni, 25, now in custody--were charged with the killing and produced before the court yesterday.

Moshiur Rahman alias Rubel, Oishee's paternal uncle, in his deposition, told the court that he came to Dhaka from his Mymensingh residence on August 16 last year after hearing the couple's death news.

The following day, he filed the case with Paltan police without mentioning any suspects, Rubel added.

In a question of a defence lawyer, Rubel told the court that no son or daughter could kill their parents.

GRAFT CASES AGAINST KHALEDA SC to hear her petitions July 13

The Supreme Court yesterday fixed July 13 for hearing petitions of BNP Chairperson Khaleda Zia seeking a stay on a High Court verdict that cleared the way for a lower court to continue trial proceedings in two corruption cases against her.

The trial court is set to start recording statements of prosecution witnesses in the two cases -- Zia Orphanage Trust and Zia Charitable Trust corruption cases -- today.

However, as the SC has fixed a date for hearing Khaleda's petitions, the trial court cannot proceed with the cases today, her lawyer Khandker Mahbub Hossain told The Daily Star.

"We will submit a petition to the lower court tomorrow (today) to adjourn the proceedings of the cases, saying that the matter is now pending with the Supreme Court," he added.

The Anti-Corruption Commission filed the cases. Meanwhile, ACC lawyer Khurshid Alam Khan told The Daily Star that there was no legal bar for the lower court to run the proceedings of the cases, as the SC did not pass any stay order on the proceedings.

On June 19, the HC rejected two writ petitions filed by Khaleda questioning the legality of appointment of Bashudev Roy as judge of the Special Judge's Court-3 of Dhaka which indicted the BNP chief and eight others in the corruption cases.

Khaleda on July 7 filed two separate petitions with the SC seeking stay on the HC verdict.

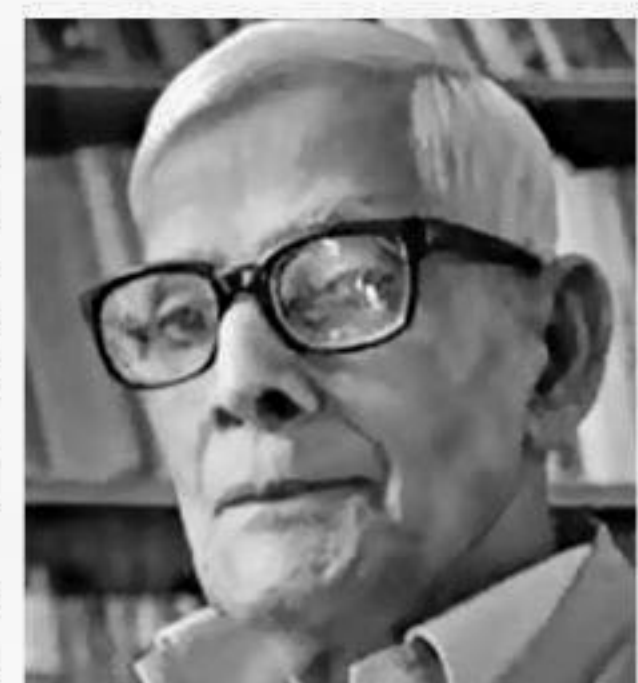
The programme was organised by Bangladesh College and University Teachers Association, Dhaka University unit, in the seminar room of the Business Studies Faculty.

Fazlul was involved in progressive politics, and served four phases in jail during the 24 years of the Pakistan rule, he added. DU Vice Chancellor Prof AAMS Arefin Siddique and Dr Afsana Karim, Fazlul's daughter, also spoke.

Roundtable supports GM crops

Participants at a roundtable stressed allaying misconceptions about genetically modified (GM) crops by educating farmers and wider spectrum of population about new opportunities offered by the agricultural biotechnology.

Eminent scientists, experts, regulators and journalists took part in the roundtable on Bt. Brinjal, a GM crop. The USAID organised the roundtable at a hotel in the capital amidst recent debate over introduction of GM crop in Bangladesh.

By releasing the seeds of Bt. Brinjal among some selected farmers late last year Bangladesh became the first in South Asia to introduce cultivation of GM food crops.

While some participants raised some concerns about GM crops, the scientists and experts explained the science behind the techniques genetic engineering and stressed the need for sharing knowledge about the new science among the general people.

With USAID Economic Growth Office Director Ramona El Hamzaoui delivering welcome address, Mark Lynas, a visiting fellow of Cornell University, and Dr Frank Shotkoski, Director of Agricultural Biotechnology Support Project discussed at length on myths and realities of GM crops.

Director General of Bangladesh Agricultural Research Institute (BARI) Dr Md Rafiqul Islam Mondal, Dhaka University Biochemistry Professor Dr Zeba Islam Seraj, ex-member of Planning Commission Prof M A Sattar Mandal, and BARI Biotechnology Division head Dilafoza Khanam, among others, gave expert opinions at the roundtable.
