

Two held with smuggled gold at Dhaka airport

Customs Intelligence officials detained two persons with 83 gold bars weighing over 9.6kg at the capital's Hazrat Shahjalal International Airport yesterday morning.

Md Alauddin, 31, and Mohammad Shahjahan, 38, coming from Doha and Dubai respectively, were crossing the green channel of the airport, said Mustafizur Rahman, deputy director of the Customs Intelligence.

Sixty-four gold bars weighing 7.4kg was found in Alauddin's handbag, and, later, 19 gold bars weighing 2.23kg was seized from Shahjahan, said the official.

Strike adjourned for one week

Three patients die in KMCH; KU students demand case withdrawal

Leaders of the Khulna unit of Bangladesh Medical Association (BMA) last night adjourned their indefinite strike at all private and public hospitals, diagnostic centres of the district for the next one week.

The announcement came at 10:00pm.

The medical practitioners had started an indefinite strike on Monday morning, protesting the abduction of a fellow physician by some Khulna University students past

In the meantime, three patients have died in Khulna Medical College Hospital (KMCH) since Monday night, with their families accusing the doctors of not giving proper treatment, a claim denied by the hospital authorities.

Every day two or three patients die usually, said Dr Abdus Samad, superintendent of KMCH, adding that there was no negligence on their part.

On Wednesday night, some KU students vandalised Gazi Medical College Hospital and picked up duty doctor Tanver Ahmed Bappa, alleging that their friend, Amit Roy, who was injured in a road accident, was not treated properly. Amit died en route to Dhaka. Police rescued Dr Bappa from a hotel near the university the next day.

Meanwhile, the university students yesterday demanded withdrawal of the case filed against their peers over the abduction of Dr Bappa and vandalism on Wednesday.

20 RMG workers hurt in clash with cops

They demand arrears from shutdown garment company in N'ganj

At least 20 workers of a garment factory were injured in a clash that ensued when police tried to stop them from blocking Dhaka-Narayanganj link road yesterday.

The workers of Radical Design Ltd, a company closed for six months, took to the streets and tried to block the road in Shibu Market area demanding payment of arrears.

The authorities kept promising them to pay their arrears but did not keep their words. Inspector Rezaul Karim of Industrial Police said several hundred workers vandalised vehicles around 3:30pm.

When police tried to disperse the demonstrators they started throwing brick chips at the law enforcers triggering the clash.

Later, police brought the situation under control by firing 12 bullets, said police.

On June 15, Bangladesh Knitwear Manufacturers and Exporters Association (BKMEA), fearing labour unrest in the zone due to the closed factory, sent a letter to State Minister for Labour and Employment Mojibul Haque Chunnu.

A garment inspector in the zone recently filed a case with the labour court asking to pay the arrears of the worker's salary selling the assets of the Canadian owner of the garment.

Rajuk Chairman GM Zainul Abedin Bhuiyan yesterday unconditionally apologised to the High Court for not complying with its directives over the allocation of plots to three land owners. After appearing at the court, Zainul offered the apology

through his lawyer as per its earlier directives. The court accepted his apology and exempted him from personal appearance before it in connection with the three contempt of court petitions filed against him.

It also adjourned the hearing on the petitions for one week after its next annual vacation. The court will go on a vacation from July 25 and will reopen on August 1. Following three petitions, the court on July 19, 2012

directed the Rajuk authorities to give a plot of five kathas at Purbachal New Town Residential Project in three months to each of Dilip Kumar Mukharjee, Nirmal Kumar Das, and Kashinath Ghosh, who were affected after their lands were acquired by Rajuk in 1997. Since Rajuk did not execute the directives, the three men filed

three contempt petitions with the HC in November last year.
