Govt wants to withdraw CID

Probe agency fails to make progress due to non-cooperation from other agencies

STAFF CORRESPONDENT

The government yesterday moved the High Court for exempting the Criminal Investigation Department from probing the sensational seven-murder case.

The court is expected to decide on the matter today. In his petition, Attorney General Mahbubey Alam cited

legal restrictions on inquiries into a case by two agencies simultaneously. "Separate probes may end up in varied findings, contra-

dicting each other on some points. No matter how small the differences are, it may destroy the trial," he told The Daily Star. He submitted the petition on the advice of the Appellate Division of the Supreme Court.

Replying to a question, he dismissed the suggestion that the move was meant to save influential people or quarters.

The petition by the chief legal officer of the country comes at a time when investigation of the grisly killings has seen some significant progress, with two agencies -- CID and the Detective Branch of Police -- probing the sevenmurder of Narayanganj.

The CID had been investigating the case as per a High Court order.

The move also comes more than two months after Narayanganj ward councilor Nazrul Islam, senior lawyer Chandan Sarker and five others were abducted and killed allegedly by Rab men for money.

Three sacked Rab officers, now in jail in connection with the case, have already confessed before a Narayanganj court that they were involved in the April 27 abduction and murder. The government earlier transferred the case from

Fake medicine factory busted

Owner jailed

Rab members yesterday busted a medicine factory in the capital's Topkhana for producing spurious antibiotics, including those for children, and jailed its owner for two years.

Owner Aminul Ehsan, 40, had been running the unauthorised business on the ground floor of his four-storey building over the last three years.

The mobile court led by Executive Magistrate of the Rapid Action Battalion Anwar Pasha also fined the owner Tk 2 lakh. If he fails to pay the fine, he will have to serve a sentence of three more months.

"Aminul used his experience as an employee of a pharmaceutical company and had been running the heinous business for 10 years," the magistrate said.
