Poor catches of hilsa in peak season frustrate fishermen

Despite being the peak season of hilsa, fishermen are getting frustrated due to poor catches of the popular fish in the coastal rivers.

Meanwhile, the prices of the fish have gone beyond purchasing capability of the common people due to its poor netting, report correspondents.

Belayet Hossain Gazi, a hilsa catcher of Char Hadi area under Dashmina upazila of Patuakhali district said he sold a hilsa at Tk 700 which he netted after four days of fishing in the

Tentulia River yesterday. We are passing hard days with my family of five due to

poor hilsa netting, he said. After the 8-month long

ban on jakta netting was withdrawn on June 30, we started fishing but got no hilsa in the river, he said.

Abdur Rahman, another fisherman of the same area, said he was very frustrated as no hilsa was found at the peak season. Heavy rainfall is favourable for hisla netting but in vain, he added.

Md. Alamgir Hossain, a fisherman of Char Wadel under Baufal upazila, said that he caught only two hilsa in the last 10 days.

Siraj Majhi, a fisherman, arranged a doa mehfil on his fishing boat near his house at Char Wadel yesterday to pray to the Almighty for getting hilsa in the river.

"I passed 12 days on the river for hilsa but in vain," he said.

Sources said this time last year, some 20 to 30 trawlers loaded with hilsa came to KB Fish Landing Station, main hilsa selling centre of Bagerhat, every day.

But the picture is quite different this season due to poor catching of the fish.

He added that the netted hilsa are also not good in

Sheikh Idris Ali, president of Upakulio Matsyajibi Samity, said fishermen are now facing financial hardship due to poor hilsa caches.

He said during this

period in previous years, four to five truckloads of hilsa were sent to Jessore, Magura, Faridpur, Khulna, Rajshahi, Kaliganj, Jhenaidah and Kushtia from the fish landing station, adding that due to scantly supply, the fish can not be sent to the districts this year.

Besides, the fish export to India from the landing, station has registered a fall this year compared to the last year's for the same reason, said the fish trader.

While visiting the main fish markets in Khulna, Bagerhat and Satkhira, this UNB orrespondent found hilsa traders passing very idle time.

Another fish trader Arup Kumar said the market price of hilsa is three times higher this year compared to the last year's. The biggest size hilsa fish

weighing more than one kg each sells at Tk 45,000-50,000 per maund while those were sold at between Tk 35,000 and 40,000 last

Small size hilsa fish equivalent to 700 grams sells at Tk 35,000 per maund while it was between Tk 15000-2000 last year, he said.

Heavy rain coupled with onrush of hillwater has triggered flash flood in vast areas of Sunamganj including the district headquarters.

Flood Control Cell of Sunamganj WDB said the Surma was flowing 57cm above the danger level near the district yesterday.

Floodwater engulfed low-lying areas of the district town and Sadar and Tahirpur upazilas, rendering 500 families marooned. Besides, three other

BCL at IU besieges VC office

Bangladesh Chhatra League (BCL) activists at Islamic University unit yesterday besieged the vicechancellor's office for two hours, protesting a syndicate meeting scheduled to be held on July 11 over the recruitment of some class one, three and four employees.

Sources said BCL had submitted their candidates list to the IU authorities and were putting pressure to recruit accordingly.

The BCL men want the authorities to approve and recruit their candidates through the syndicate meeting on July 11.

A group of BCL activists, led by Shamim Ahmed, convener of IU unit, went to the administrative building around 2:30pm yesterday and chanted slogans against Abdul Hakim, vice-chancellor of the university, for fixing the syndicate meeting without considering their demands.

They also blocked the university main gate and stopped plying of university transports.

Later, following the assurances of the authorities, the BCL men called off their agitation around 4:30pm and left the administrative building.

Docs at Khulna hospitals postpone strike

Medical practitioners at both public and private hospitals in the district on Tuesday night postponed their indefinite strike for a week following a meeting with the local administra-

Leaders of Khulna unit of

Bangladesh Medical Association (BMA), Bangladesh Private Medical Practitioners Association (BPMPA), Bangladesh Private Clinic and Diagnostics Owners Association (BPCDOA), lawmaker of Khulna-2 constituency Mizanur Rahman Mizan, administrator of Khulna District Council Sheikh Harun-ur-Rashid, among others, were present at the meeting.

The strike was withdrawn following an assurance by the MP of looking into the matter and taking steps to resolve the problems, said Dr Sheikh Baharul Alam, vice-president of Khulna chapter of BMA.

On Monday, the medical practitioners called the strike to press their threepoint demands-- arrest and exemplary punishment of the Khulna University students involved in Dr

Tanvir Ahmed Bappa abduction incident, investigation into the attack on some employees of Gazi Medical College Hospital, and ensuring security of doctors and employees at all government and private hospitals.

On the night of July 2, some students of Khulna University vandalised windowpanes, glasses, doors and valuable medical equipments of GMCH and abducted duty doctor Tanvir, claiming that the medical authorities failed to ensure better treatment for Amit Roy, a first year student of the university.

Police, however, rescued Tanvir from a hotel near the KU campus the next morn-

Amit, who was injured in a road crash, was rushed to KMCH. He was later shifted to GMCH. He succumbed to his injuries around 11.30pm on Wednesday while being taken to Dhaka for better

treatment. "We will observe 48-hour strike from July 16 if the attackers and abductors of doctor Tanvir Islam Bappa were not arrested before July 15", said Dr Sheikh Baharul

BCL assaults headmaster for not bowing to demand

A BCL leader and his aides assaulted the headmaster of a local high school on Tuesday, allegedly for not giving him permission to hold a week-long furniture fair at the school ground at Birunia Bazar in Bhaluka upazila.

He also threatened Md Helal Uddin, headmaster of Kongsherkul High School, of dire consequences if he filed any case regarding the incident.

The BCL men had been trying to get the permission for the last couple of days, but the school authorities said they could not allow it as the construction work of a school building was going on there.

Sources said a gang of 40 to 50 BCL men, led by Sarwar Jahan, nephew of local Awami League lawmaker and Maidul Islam, president of Birunia Union unit of BCL entered the headmaster's room around 11:30am

and asked him to issue a permission for

holding the furniture fair at the school field. As Helal Udddin refuted to do so,

Sarwar, Maidul, Lorence, Anarul and Bubul among the 40 to 50 BCL men beat him up and took him to Birunia Bazar area for further harassment. Hearing Helal's hew and cry, locals rushed in and rescued him from the clutches of the attackers and admitted him to Bhaluka Upazila Health Complex.

Several locals told this correspondent that marking the 'Urs' of Muskhi Darbar Sharif in adjacent Gafargaon upazila, gambling is organised in the name of furniture fair at Birunia every year. Local political leaders, police and other local influentials earn a handsome amount of money from the fair, they said.

Condemning the attack, they also demanded immediate arrest of the attackers.

25 trafficked kids brought back

Indian Border Security Force (BSF) handed over 25 Bangladeshi children, who were trafficked to India three years ago, to Border Guard Bangladesh (BGB) on Tuesday night. Nayek Subedar Hafizur Rahman, in-charge of BGB Benapole outpost said Indian police rounded up the children soon after they were taken to the neighbouring country about three years back. They languished in different Indian jails, till a human rights organisation rescued them and took them to its own shelter home and informed Bangladesh Woman Lawyers Association (BWLA). BWLA took the initiative to bring them back home.

Death in custody, 5 cops sued

Four policemen of Dasar Police Station under the district have been sued for the death of a youth in custody. The accused are Officer-in-Charge Emdadul Haque, Sub-Inspector Mir Nazmul Hasan, and constables Forhad Hossain and Salauddin. Reba Begum, mother of the victim, Shahin Mollah, filed a case with the Chief Judicial Magistrate's Court, Madaripur, on Tuesday afternoon. In the case statement, she stated that a team of police led by Sub-Inspector Mir Nazmul Hasan, detained Shahin from Dasar-Medakul bridge area on June 8 and tortured him. Shahin fell sick and died on the way to hospital, she said in the statement. The court took the case into cognisance and asked the director of Rapid Action Battalion (Rab)-8 to submit a report to the court after proper investigation into the incident.

Md Maidul Islam, accounts assistant of Patuakhali Local Government Engineering Department (LGED) office, has remained traceless since his abduction on June 26


