Swechchhasebak League goon killed by BCL goons

At RU, two leaders attack each other

A hired goon of Swechchhasebak League in Sylhet city was killed by the hired goons of Bangladesh Chhatra League in Akhalia area on Monday night because of rivalry over collecting extortion money from the easy bike stand at Madina market.

Police said the deceased, Abdullah Alias Kochi, 22, was a carpenter.

His rivals, Gulzar Ahmed and Sumon

Talukder, who are locally known as BCL goons, stabbed him and his friend Sunny near Dhopabari bridge around 9:30pm before fleeing, said local shop owners who witnessed the incident.

The two were taken to Osmani Medical College Hospital where Kochi was declared dead.

Kochi was a follower of the city unit Swechchhasebak League publicity secretary hospital.

Amin Ahmed, proprietor of Al Amin Construction Company Ltd, filed the case on December 30, 2006 against Tarique and Apu on charge of extorting over Tk 1 crore from him. Following this, Tarique was arrested on March 7, 2007 but later got bail in the case.
