Passing of proposed law urged

The government should formulate the proposed Antidiscrimination Act- 2014 soon to ensure rights of the deprived communities especially the dalit, said discussants at a roundtable yesterday.

The proposed law should include all underprivileged communities -- harijans, adivasis, hermaphrodites (hijras) and sex workers -- so that the state can take necessary and effective steps for their welfare, they added.

The remarks came at a programme organised by the daily Prothom Alo in its office in the capital with assistance of Bangladesh Dalit Parishad and Parittran, an NGO.

The Law Commission has recently submitted the proposed law to the law ministry. It suggests that any victim of discrimination or anyone else on their behalf can lodge a written complaint with the National Human Rights Commission (NHRC) or with the court.

Expedited move worries Bangladesh JS body

Expressing concern over Narendra Modi government's serious efforts to expedite the river interlinking project, a parliamentary body yesterday said they would ask the water resources ministry to collect every detail about it from India.

The parliamentary standing committee on the water resources ministry also said it would suggest that the government take proper measures at all levels to settle the much talked-about issue so that it did not harm Bangladesh's environment.

"We have come to know from media that India's new government has allocated Rs100 crore in its budget to expedite the river interlinking project, which will harm us. We will therefore ask the ministry to get a clear picture of it," Romesh Chandra Sen, chief of the committee, told reporters after the meeting at Jatiya
