Potato price jumps as smuggling on amid lax watch

Potato price has now doubled in the local market here as a good quantity of potatoes is being smuggled into India through Nagartari area of Mogholhat border in Lalmonirhat Sadar upazila every day during the Ramadan.

An organised smugglers syndicate is using the route for smuggling potatoes into India due to lax vigilance by Border Guard Bangladesh (BGB), locals alleged.

Around 50 to 60 metric tonnes of potatoes are being smuggled into India every day, locals said.

Just a week ago, one kg of good quality potatoes was sold at Tk 15, medium quality potatoes at Tk 12 and low quality potatoes at Tk 9 in the local market. But now one kg of good quality potatoes is being sold at Tk 30, medium quality potatoes at Tk 24 and low quality potatoes at Tk 20 in the market.

Potato traders Abdul Miah and Nazrul Islam at Mogholhat Bazar said there is a huge supply of potatoes in the local market and the price would not be doubled if it is not smuggled into India.

As a group of smugglers are buying potatoes at a high rate, the local traders are selling potatoes at a high price in

the retail market, they said. Hamidul Islam of Nagartari border village said he earns Tk 30 for taking one sack of potatoes (each sack contains 80 kgs of potatoes) to the zero line of the border from the local market by his bicycle.

At least 300 locals are engaged in this work and each of them can earn Tk 500 every day, he added.

Abdus Sattar, a member of a smuggler syndicate, claiming to be a "source" of BGB, said potato farmers are getting reasonable rates for their produce as potatoes are being smuggled into India.

BGB members are overlooking the

potato smuggling in the interest of farmers, he said, adding that he and many other people are involved in potato trading in the border area. However, Nayek Subedar Khademul Islam, camp commander of

the Mogholhat BGB, said the BGB never allows anybody to smuggle potatoes into India. Dodging the BGB's vigilance, smug-

glers can send potatoes into India through the border, he said.

Locals urged the authorities concerned to stop the potato smuggling in order to keep the potato price in the local market stable.

aged 13, with shrapnel in his chest; his cousin Motasem, 11, injured in his head and legs, and Mohammad Abu Watfah, 21, who was hit by shrapnel in his stomach.

A man who had been near them reached the hotel terrace first, scrambling up a steep sandy bank. A skinny man in his 30s, he groaned and held up a T-shirt already staining red with blood where he was hit in the stomach. He fainted and was carried to a taxi waved down in the street as he grew pale and

The children were brought up next. Pulling up the T-shirt of the first boy, journalists administering first aid found a shrapnel hole, small and round as a pencil head, where he had been hit in the chest. Another boy, a brother or cousin, who was uninjured, slumped by the wall, weeping.

The injured boy cried in pain as the

wound, wrapping a field dressing around his chest. He winced in pain, clearly embarrassed too as a colleague checked his shorts to look for unseen femoral bleeding. A waiter grabbed a table cloth to use as a stretcher, but a photographer took the boy in his arms to carry him to the ambulance.

Researchers are being dispatched to investigate the hole, which has confounded scientists with its dramatic appearance.

Some have speculated it could have been made by a meteorite striking earth, an underground explosion, or is a sinkhole caused by collapsing rock, the Siberian Times reported.

One imaginative online commenter claimed it could even be evidence "of the arrival of a UFO craft" to the planet.

The area's name, Yamal, translates as the "end of the world" and the remote peninsula reaches into the Arctic Ocean.

It holds some of Russia's largest gas reserves and the crater appeared less than 20 miles from the biggest gas field, Bovanenkovo.

The dark colour of the crater's sides was said in a Zvezda TV report to indicate "temperature processes" or burning.

Whatever caused it, it is large enough to comfortably fit several military helicopters in the entrance.

Experts from the Centre for the Study of the Arctic and the Cryosphere Institute of the Russian Academy of Sciences will take samples of soil, air and water.

It also found "un-examined" blood being given to a cancer patient at the Day Care Centre.

The blood bank is just 300 yards from the Directorate General of Health Services (DGHS) responsible for monitoring the activities of blood banks and transfusion centres.

According to the licence rules, an authorised blood bank must recruit doctors, nurses and technicians to test blood for at least five diseases -- AIDS, hepatitis B, hepatitis C, syphilis and

malaria -- before a blood transfusion. But Rogi Kallan Blood Bank, which obtained its licence in 2009, had been running without any doctors and nurses and used to make fake test reports with

forged signatures of physicians. The blood bank's owners -- Rabiul

Islam, 40, Ripon Uddin, 35, Saidul Islam, they monitor hospitals, clinics and blood blood bank, Rogi Kallan Blood Bank and offences, while lab operator Iqbal and renewal of licence, he said. Kabir, 22, was sentenced to a year in prison.

Being tipped-off, the mobile court carried out the drive. It saw Kalu Mia collecting blood from a drug addict.

The owners have committed crimes by running the blood bank in an unhealthy environment without the availability of doctors, nurses and efficient technicians round the clock and live-saving equipment, the magistrate said.

The blood bank had operated even before obtaining the licence, local people said, with a big signboard hung on the building along the main road, which houses the storage.

Majnu Sheikh, son of Tajul, the cancer patient from Manikganj, told a correspondent of The Daily Star, who was present there during the raid, that his father had been undergoing cancer treatment at Mohakhali Cancer Hospital for the last one month and on

Wednesday doctors told the family to arrange for an immediate blood one bag of blood of positive groups for transfusion.

"Within a few minutes, a man came to 700 but sold one bag at Tk 1,000 to Tk me and said he would manage blood," he said, adding that he had given Tk 1,700 to the man for blood.

Regarding blood collection from drug addicts, Abdul Aziz, one of the owners, said people usually did not come to the blood bank on their own and so they used to get blood donors through agents like Kalu.

"We are aware that most of the donors are drug addicts but we have nothing to do since 'normal' people do not come here," he said.

He, however, claimed that technicians usually carried out some "essential tests"

before selling blood.

Another owner Rabiul Islam said the

blood bank usually collected and sold

For example, following the insistence of the observer, the board decided to seek an explanation from the then MD as to why 106 proposals involving Tk 1,354 crore loan were included in the minutes without any discussion at the 327th board meeting in December last year.

It was decided that the issue would top the agenda of the 329th meeting held in April this year and will be placed at the 330th meeting the same month for approval.

But the minutes skipped the agenda, prompting the observer to intervene and ask the board to look into the issue.

and distorted agenda without explaining what it was asked to do. Under the headline of "Confirma-

tion of the minutes of the 328th meeting of the Board of Directors," the first agenda reads: "While the item came up for discussion, the Observer recalling the minutes of the 327th meeting of the Board of Directors of the Bank wanted to know the reason for inclusion of additional
