

# Two shot, mugged

Muggers shot two people in two incidents and took away around Tk 3 lakh from them in the capital yesterday.

Three youths on a motorbike waylaid Manjurul Alam on Ring Road at Shyamoli around 2:00pm, the victim told reporters at Dhaka Medical College Hospital. They shot him in the right leg and snatched Tk 2.5 lakh, he said.

Meanwhile, around five muggers shot trader Mostafa Kamal of Lalbagh in the both legs near Kamalapur Railway Station and took away around Tk 50,000, said Mostafa at DMCH. DMCH police outpost in-charge Mozammel Haque said the two were undergoing treatment at DMCH.

committee to wage anti-government movement in the capital last year, Khaleda on February 10 announced that she would disband the party's Dhaka city unit and announce a new one. But it took her over five months due to internal conflict and grouping inside the party.

Party sources said Abbas did not like Soheli's inclusion as member-secretary in the new committee. Instead, the former mayor of Dhaka lobbied for MA Quaium as his running mate.

Abbas replaced Khoka while Soheli replaced Salam. But both Khoka and Salam were made advisers in the new committee.

Khoka's inclusion in the new committee has also annoyed Abbas as conflict and grouping have been prevailing between the duo for long. Conflict between Abbas and Khoka was also a major reason for Khaleda's delay in announcing the committee, said the party sources.

A joint convener of the new committee said, "On advice of Abbas, Khaleda Zia agreed to approve a 31-member committee. But at the

last moment, some BNP leaders including Fakhrul persuaded her to include Soheli and around 20 other leaders, mostly loyal to Khoka, in the committee which has irked Abbas."

Party insiders said three BNP leaders Khairul Kabir Khokon, Mohammad Shahjahan and Abdus Salam Azad were excluded from the final list of the new committee ignoring Abbas's request for retaining them, which also displeased him.

Disappointed Abbas did not meet any BNP leaders and even the media on Saturday.

Apart from Abbas, BNP standing committee member Rafiqul Islam Mia, Abdul Awal Mintoo, Abul Khair Bhuiyan, Moazzem Hossain Alal, Abu Sayeed Khan Khokon, MA Quaium, among others, also got displeased for their posts in the new committee, party insiders said.

Wishing anonymity, a senior BNP leader said it would have been more prestigious for him if he was made just a member instead of a joint convener in the committee.

The railway authorities yesterday sold 3,749 tickets for eight intercity trains of July 24, said Abul Kalam Azad, station manager of Chittagong Railway Station. The same number of tickets would be sold today for July 25, he added.

# Ershad cancels India visit

Jatiya Party Chairman and Prime Minister Sheikh Hasina's special envoy HM Ershad yesterday postponed his scheduled visit to India.

Exact reasons behind the postponement of his five-day visit could not be known.

Talking to The Daily Star, JP Secretary General Ziauddin Ahmed Bablu said, "Sir [Ershad] has been admitted to Combined Military Hospital in the capital as he has been suffering from chest pain. The doctors advised him to take bed-rest without movement. That's why his India visit has been postponed."

But a close aide of the former autocratic ruler who was forced to step down from power in 1990 amid mass movement, said, "Sir [Ershad] did not go to India as the Eid is nearer. He will visit the neighbouring country after Eid."

Ershad was scheduled to fly to New Delhi around 5:20pm yesterday to discuss bilateral issues with a number of leaders of the Indian government alongside looking for a school for his son Eric Ershad's admission there.

bars in an aircraft in an abandon condition and later, after its landing, aircraft cleaners or other such employees take the gold out of the airport and handed those over to them safely.

Meanwhile, customs intelligence officials detained one Mohammad Iqbal along with 50 gold bars weighing around 5.83kg at the airport around 2:30am, said Moinul Khan, director general of the custom intelligence.

Iqbal landed at the airport with the gold worth around Tk 2.91 crore from Dubai by a Qatar Airlines flight early yesterday, said the official.

Another team of customs officials arrested Amirul Islam, a passenger of Malaysian Airlines, with eight gold bars weighing 4.4kg from his shopping bag at the airport around 2:10am, said Sampriti Paramanik, assistant commissioner of customs.

Police has arrested Nasir Khan, proprietor of Meghna Trade International, and broker Jainul Abedin, who was known as chairman of Bangladesh Migrants Foundation, in these cases, they mentioned.

Of the 22 returnees, only three people received compensation from their two recruiting agencies -- Idea International, and East Bengal Overseas.

But the remaining 19 are yet to receive reimbursement from two other agencies -- Morning Sun Enterprise and Meghna Trade International, said Mosharaf Hossain, another demonstrator.

The victims had to take loans from different sources before their migration to Iraq. Of them, eight returnees had to take a loan of Tk 80,000 each from the government's Probashi Kallyan Bank.

Now the bank authorities are creating pressure on them to repay the loans, said Bokul Hossain Mondol, another victim.

"I don't have any regular income. How can I pay the bank loan when I struggle to manage food for my family?" he added.

Contacted, Expatriates' Welfare Minister Khandker Mosharraf Hossain said the ministry couldn't do anything until the investigation into the alleged recruiting agencies comes to an end.

Asked whether the bank would waive the workers' loans, the minister replied in the negative.
