

Roadside trees felled on excuse of traffic safety

Neither tender invited, nor official permission sought

The Roads and Highways (R&H) Department felled more than 100 trees on Barisal-Dhaka highway with an excuse for smooth traffic movement before and during Eid vacation.

While visiting Barisal-Bhughata portion of the

highway recently, this correspondent found that the labourers employed by the R&H Department cut down the trees through trunks at many places and branches of big trees at some points without inviting tender.

Mizanur Rahman, work assistant of R&H Department, claimed that only the branches of some

korai, shishu, mahogany, chambol and rain trees were felled on Barisal-Bhughata portion of the highway for safe movement of buses and other passenger-carrying motor vehicles during Eid rush.

Contacted, Md Nasiruddin, sub-assistant engineer of R&H Department admitted to

felling of some trees though trunks and branches of some others on emergency basis to ensure safe journey of home-goers before and during Eid holidays.

However, the R&H officials in Barisal said no tender was invited to do the job due to 'shortage of time.'

Sukumar Biswas, director of the Department of Environment (DoE) at its Barisal office, said felling of roadside trees without tender or coordinated decision of Roads and Highways, environment and forest department is prohibited under the existing laws.

Md Khaled Shahed, executive engineer of R&H in Barisal, said the branches of some roadside trees felled to ensure smooth movements of buses and other vehicles during the coming Eid festival.

"We did the job on an urgent basis without inviting tender as per directive of our of head office," the executive engineer said, adding that he was not aware of cutting down the trees on the Barisal-Bhughata portion of the highway.

Moslemuddin's 'fruitful' venture

Moslemuddin of Heyali village in Sadullapur upazila under the district is now happy owner of a quality mango orchard, using the bank of his pond for the purpose.

"After retirement from my service of the then BDR, I started mango plantation in 2002. I collected 26 varieties of quality mango saplings from different areas and planted those around the bank of a 2.34-acre pond. The trees started bearing fruits three years ago," Moslemuddin said.

He took technical help and other

support from the upazila agriculture officials to make his initiative a success.

"In the first year I earned Tk 40,000 from sale of mango. I expect Tk one lakh this season," he said.

The varieties available in the mango orchard include *amropali*, *haribhanga*, *lengra*, *surjupuri*, *gopalbhog* and *fazli*.

"There is high demand of such varieties. Fruit traders from distant places visit my garden and procure matured green mangoes," said the orchard owner.

Visiting the orchard on Tuesday,

this correspondent saw huge quantity of late variety mangoes hanging in the trees. Most of the early varieties have already been sold out.

Abdul Quddus, a fruit trader of Pirganj upazila, however, said this year mango trading sees a little setback as customers often shy away from mango in fear of formalin.

"Moslemuddin has set a good example for the fruit growers. Earlier he received a government prize for his contribution to tree plantation campaign," said Obaidur Rahman, upazila agriculture officer of Sadullapur.

Ex cops held on extortion charge

Two former policemen were arrested at Talgasi Bazar in Shahzadpur upazila of Sirajganj district on Saturday on charge of collecting illegal toll from the traders. The arrestees are Abdul Hye Sarker, 68, former sub-inspector of Sirajganj district special branch and Ainul Haque, 50, former constable of the branch. Officer in-charge of Shahzadpur police station Hasan Shamim Iqbal said locals caught the duo around 6:00pm when they demanded Tk 20,000 from a number of traders, including oil trader Matiur Rahman and former UP chairman Abdul Jabbar. They were later handed over to Shazadpur police, said the OC. The arrestees were collecting illegal toll from the traders in guise of special branch members, he said.

Housewife murdered

A housewife was murdered allegedly by her husband at Sahata village in Barhatta upazila of the district early yesterday. The deceased is Minara Begum, 26, wife of Ekhlash Mia of the village. Police quoted locals as saying that the couple engaged in an altercation over cooking meals for Sehri around 2:30am. At one stage of their hot exchange of words, Ekhlash hit Minara with a lethal weapon on her head, leaving her dead on the spot and fled the scene. On information, police covered the body and sent it to Netrokona Sadar Hospital morgue for an autopsy. A case was filed with Barhatta Police Station in this connection.

Youth held on rape charge

A youth was arrested at Barapoit village in Sadar upazila of Habiganj district on Saturday on charge of raping a minor girl. The arrestee is Sabuj Miah, 19, son of Tara Miah of the village in the upazila, said Ibrahim Ahmed, sub-inspector of Habiganj Sadar police station. Sabuj violated the girl around 6:30pm on Saturday when she was going to her grandmother's house, said family sources. Hearing the hue and cry, locals rescued the victim from the spot and sent her to Habiganj Sadar Hospital. Following a case filed by the mother of the girl, police arrested Sabuj at 9:30pm, said the SI.

Grocer hacked to death

A grocer was hacked to death at his shop in Kellabandh-Baniyapara area of the city on Friday afternoon. The dead is Abul Hossain, 55, son of late Kachhim Uddin of the area. He ran a flexi-load business besides grocery in front of his house. Arifuzzaman Apel, son of the deceased, said "Local criminal Ferdous, son of Shamser Ali of the same area, came to the shop to recharge his mobile phone on Thursday night. He quarreled with him over delay in recharging". As a sequel to the conflict, Ferdous, his father Shamser Ali and their accomplices went to the shop around 3:00pm on Friday and attacked Abul Hossain with sharp weapons, leaving him dead on the spot, said Apel. A murder case was filed, accusing 10 people, including Ferdous and his father Shamser Ali, said police.

65 hurt in B'baria clash

At least 65 people were injured in a clash between two rival groups of CNG-run auto-rickshaw drivers at Bitghar village in Sarail upazial yesterday. Of the injured, 52 were admitted to Brahmanbaria Sadar Hospital while the rest given first aid. Police and locals said, an altercation took place between two drivers of CNG-run auto-rickshaw---Rukku Mia of Memberbari and Liton Mia of Sardarbari---over driving serial of the auto-rickshaw and its fare four days back. As a sequel to the conflict, the supports of the rivals attacked each other with lethal weapons yesterday afternoon, leaving at least 65 people from both sides injured. On information, police rushed to the spot and fired 44 rubber bullets and 12 tear gas shells to bring the situation under control, said OC Md Arshad of Sarail police station.

ONRUSH OF WATER FROM UPSTREAM

35 chars out of 90 in Lalmonirhat flooded

At least 35 out of 90 chars (landmasses emerged from riverbed) of the Teesta River in the district got flooded due to onrush of water from upstream on Saturday evening.

The worst affected areas include Char Quader, Char Maniram, and Char Kuchlibari under Patgram upazila; Char Gaddimari, Char Dawabari, Char Sindurna, Char Madhya Gaddimari, Char Paruliya, Char Chhawani, Char Saniyazan, and Char Purbo Sindurna under Hatibandha upazila; Char Sholmari, Char Kalikapur, Char Kakina, Char Votmari, Char Nader, Char Jamirbari, and Char Rudreshwar under Kaliganj upazila; Char Gobordhan, Char Narsingh, Char Nayarhat, Char Kutirpar, Char Balapara, and Char Chanderhat under Aditmari upazila; Char Kalmari, Char Milonbazar, Char Tajpur, Char Khuniyagachh, Char Rajpur, Char Gokunda, Char Kurul, Char Kulaghat, Bowalmari Char, Char Kharuya, and Char Nagartari under Lalmonirhat Sadar upazila.

Croplands in the affected char lands have gone under water and many people have started leaving their submerged houses for safer places.

While visiting Char Dawabari in Hatibandha upazila yesterday this correspondent found over 100 families along with their belongings heading for safer places.

One Yasin Ali Mollah of the area said he had shifted his family and the corrugated iron roof of his house to a safer place. Some other people living in the char land have also shifted the roofs of their house to safer places, he added.

Montezar Rahman of Char Sholmari under Kaliganj upazila said they face the same situation during the rainy season every year and have to take shelter at safer places.

Water Development Board (WDB) office sources said, the Teesta was flowing one centimeter above the danger level at Dowani point in Hatibandha upazila yesterday morning.

SEQUEL TO ACID ATTACK

20 hurt as AL factions in Kushtia clash again

At least 20 people, including a woman, were injured when police fired gunshots to disperse two clashing factions of ruling Awami League at Gopalpur village in Sadar upazila on Saturday night.

Critically injured Mozammel Haq, 40, Beauty Khatun, 20, Ahmed Ali, 25, and Bisharat Ali were admitted to Kushtia Medical College Hospital.

At least four incidents of infighting occurred since July 6, as a sequel to previous enmity between the two groups, one led by Sawpon Biswas and the other by Golam Mustafa of

the village.

Police said supporters of both the groups were locked in an altercation at Jhodia Bazar around 8:30pm, over the recent acid attack on three members of Ayub Ali's family, a supporter of Swapon Biswas.

At one stage, both the group equipped with sharp weapons attacked each other triggering a chase and counter chase in the area.

Being informed, police rushed to the spot and fired several blank gunshots to disperse the two factions, to bring the situation under control.

At least 20 people were injured during the incidents.

Mir Shariful Haq Janak, officer in-charge of Islamic University Police Station, said police fired around 15 blank shots to bring the situation under control.

None, however, was injured in police firing, added the OC.

Earlier, criminals threw acid through an window of Ayub Ali's house around 10:30pm when his widowed sister Saleha Khatun, daughter Sonia Khatun, 20, and son Titumir Hossain, 13, were asleep, allegedly following an altercation between Ayub Ali and Golam Mustafa.

Sonia and Titumir are still undergoing treatment at hospitals.
