A war crimes suspect, believed to be the deputy commander of Bagerhat Razakar Bahini, has been arrested in connection with crimes committed against humanity during the Liberation War, 1971. Police said they arrested Sirajul

Islam alias Siraj Master at Dema union in Bagerhat around 11:00pm yesterday. He was allegedly a close aide to AKM Yusuf, Jamaat leader and founder of notorious auxiliary force Razakar Bahini in 1971. Syed Sayedul Haque Sumon, a

prosecutor, told The Daily Star that the International Crimes Tribunal-1 issued the arrest warrants against three war crimes suspects, including Siraj, on June 10.

Police already had arrested the other two.

Gaza paramedics 'brothers' bonded by horrors of war

At a dingy Gaza ambulance station, paramedics struggle to stay awake during 24-hour shifts that see them coming under fire and dealing with the deaths of civilians and even colleagues. The men describe themselves as a

family, bonded together by experiences that are difficult to comprehend. They have collected body parts and

dead children; they have been trapped between Israeli shelling and Hamas sniper fire; and several of them have been wounded. Shift supervisor Jihad Selim has been a paramedic for 17 years and has

no regrets, despite having worked through three wars and the violence of the second Palestinian intifada, or uprising (2000-2005). But he wouldn't want to see his

children follow in his footsteps. "The things we see are very hard," he

told AFP. "We go into a house and we find a body torn into pieces, someone picks

up a hand and gives it to you and says 'take it'. "But these are things we're used to." Adel al-Azbut, 30, is similarly stoi-

cal about the horrors they encounter on a daily basis. "To be honest, I just get on with it,"

he says. "If I see pieces of a body, my profes-

sional responsibility requires that I just

deal with situations like that and do it in a professional way."

Adding to the pressure is that fact that they all have families at home, and many admit that their deepest fear is getting an emergency call from their own home.

Azbut decided he wanted to be a paramedic during the second intifada, impressed by the work done by first responders treating people in the Gaza Strip. "The best thing for any human

being to be able to do is to help another human being," he says.

"I'm honoured that I'm someone who is able to help people."

In the background, the phone rings constantly. Often it is nothing more than chil-

dren, bored at home, who ring the emergency service's toll-free number for fun. "The worst thing that ever hap-

pened to us was them making our number toll-free. Now in Gaza, if you want to make sure the sound on your phone is working, you call our number, " Selim says ruefully.

But often it is far more serious. Families living in flashpoint border areas sometimes make desperate calls in the hope of being evacuated by ambulance, but Selim can't send anyone without first coordinating with the International Committee of the Red Cross.

The move comes amid widespread allegations that a large number of government officials fraudulently obtained freedom fighters' certificates over the past few years to extend their service period by one year.

In November 2012, the government extended the retirement age of freedom fighters from 59 years to 60. Earlier in April 2010, their retirement age was extended by two years from 57. Following the 2012 extension, the

number of freedom fighters in government services stood at around 11,000. Of them, those in the final years of

their service now were at best 15 or 16 years old during the Liberation War. To identify fake freedom fighters in

the civil bureaucracy, the government's first consideration was the age of the officials at the time of the Liberation War in 1971.

The minister said the government would not consider anyone as a freedom fighter if he was below 13 at the time of

the war, as that would be "unrealistic". Over the past five years, some 11,150 people from different professions got freedom fighters' certificates, sources said.

The Anti-Corruption Commission is currently investigating the allegation that some other top government officials obtained fake freedom fighters' certificates at the fag end of their service life during the tenure of the Awami League government.

They include Khandakar Shawkat Hossain, expatriates welfare and overseas employment secretary, Niaz Uddin Mia, health secretary, KH Masud Siddiqui, Liberation War Affairs secretary, AKM Amir Hossain, Public Service Commission secretary, Molla Waheeduzzaman, privatisation commission chairman, and Md Abul Kashem Talukder, former joint secretary of Liberation War Affairs (now an OSD).

"After identifying the fake freedom fighters we will also find out those who helped them obtain the certificates. I have already taken the initiative and I will finish it," the minister told The MA Majid, Nur Islam, Belal Hossain Daily Star.

Contacted, former cabinet secretary Ali Imam Majumder said providing false documents is a criminal offence.

"The public servants who provided forged documents and are still in their jobs will face both departmental and legal action. But those who have already retired will face legal action only, as departmental action is not applicable to them," he added.
