## JUSTICE DELAYED, NOT DENIED

3 pharmaceutical owner-officials jailed over children's death from toxic syrup more than two decades back

In the first-ever instance of conviction for drug adulteration in the country, a court yesterday awarded 10 years' rigorous imprisonment to an owner and two officials of Adflame Pharmaceuticals.

Adflame director Helena Pasha; Mizanur Rahman, manager and her brother, and Nrigendra Nath Bala, production officer, were also fined Tk 2,00,000 each under the Drug (Control) Ordinance, 1982.

Adflame's Paracetamol syrup Flammadol containing toxic chemical diethylene glycol was responsible for the deaths of a number of children between 1982 and 1992.

The case statement brought charges of killing 76 kids. "The accused have committed a

heinous crime against the society, children and humanity as well," said the Dhaka Drug Court's judge, Abdur Rashid, in his verdict.

They deserved the highest punishment, he added. "For that reason, they have been handed down the maximum sentence [under the ordinance]."

## Winner one, win for all

Prof Hanif the unsung hero

Hundreds of children died from renal failure between 1982 and 1992, but the reason for the disease had been unknown until a brave physician revealed that toxic paracetamol was causing the deaths. Instead of using propylene glycol, five

pharmaceutical companies used lethal but cheap diethylene glycol in producing

paracetamol syrup, kidney specialist Prof Mohammad Hanif had said in 1992. The pediatrician,

who since 1982 had seen children die,

**Prof Hanif** arranged a test of Adflame's Flammodol at a US laboratory. The sample tested positive for diethylene glycol, leading to prosecution of four out of the five companies. The other firm, City Chemical, was never prosecuted allegedly for its warm relations with the then BNP government.

Over the course of two decades, Rex Pharma secured an acquittal in 2003. Cases against Polychem and BCI Bangladesh have been stayed since 1994.

The trial in the Adflame case resumed in

## Truce calls fall on deaf ears

Israel pounded targets across the Gaza Strip and Hamas continued it's rocket fires yesterday as top US and United Nations diplomats pursued talks on halting the fighting: to help that has claimed more than 600 lives.

UN chief Ban Ki-moon yesterday demanded that Israel and Hamas halt the spiralling violence as he led diplomatic efforts to end bloodshed that has killed 620 Palestinians.

Following top-level truce talks in Cairo, the UN secretarygeneral headed to Israel to deliver his message in person as the 15-day conflict showed no sign of easing.

"My message to Israelis and Palestinians is the same: : Stop fighting, start talking and take on the root causes of the conflict so that we are not at the same situation in the next six months or a year," he said.
