

**CONCEALING WEALTH INFO
ACC sues
ex-RHD chief
engineer's son**

Former chief engineer of Roads and Highways Department Faizul Haque's son was sued yesterday for concealing the information of wealth worth over Tk 1.6 crore.

Deputy Director Mirza Zahidul Alam of Anti-Corruption Commission lodged the case against SM Faizul Haque with Ramna Police Station in the capital.

Faizul Haque's income tax return file showed that he earned total Tk 1.37 crore during his business, agriculture, house rent and others between 2001 and 2012.

But ACC investigation found that Faizul amassed moveable and immovable property worth total Tk 2.28 crore during the period and of the amount Tk 1.6 crore

**ADULTERATED VERMICELLI
2 held from

Law enforcers yesterday arrested two people on the High Court premises following the court order after they appeared before it seeking anticipatory bail in a case filed on charge of producing adulterated vermicelli.

The case was earlier filed against Nasir Uddin and Mohammad Ali for producing adulterated vermicelli in an unhygienic environment and selling it in Kamrangirchar area in the capital, Sheikh Mohsin Alam, officer-in-charge of Kamrangirchar Police Station, told The Daily Star.

Later, the duo went into hiding.

An HC bench of Justice Md Rezaul Haque and Justice Gobinda Chandra Tagore yesterday morning rejected bail petitions of Nasir and Ali and asked police on duty to arrest them in the case.

A ticket seeker, Mohammad Atique, said, "I've been searching for a cabin ticket for the last two days at Sadarghat launch terminal."

A traveller on Dhaka-Patuakhali route, Hedayet Hossain, said it was not possible to get a cabin during Eid rush without lobbying.

However, people who have got tickets have paid almost double the fares.

"Usually, the fare for a single-seat cabin is Tk 1,100 and a double-seat cabin Tk 2,200. But I have to pay Tk 2,000 for a single-seater," said Anjan Saha, who will travel to Barisal on July 26.

Badiuzzaman Badal, adviser of Bangladesh Inland Waterways (passenger carrier's) Association, said, "We have a total of around 1,300 to 1,500

cabins daily. But the demand is more than double."

Deck tickets, however, are sold before boarding the vessels.

TRAIN, BUS TICKETS
Meanwhile, Bangladesh Railway yesterday continued distributing advance tickets for the third consecutive day at Kamalapur Railway Station amid allegations that scalpers were active, as tickets ran out within few hours after start of the sale at 9:00am.

"I've been waiting here for around 10 hours. The counter staff are saying tickets have already been sold two and a half hours after the sale opened," said Raihan, a ticket seeker of Teesta express, an intercity train running between Dhaka and Dewanganj of Jamalpur.

Regarding the allegations, Bangladesh Railway Director General Tafazzal Hossain said, "Suppose there are 800 tickets for a train. We have to keep 25 percent of tickets for online sale, five percent for VIPs and five percent for our staff. So, the number of tickets comes down to 520. If a person takes four tickets, so we can provide tickets to 130 persons."

"So, it is usual that tickets run out within three hours," he said, adding there was no possibility of ticket scalping.

The tickets for July 27 and 28 will be distributed today and tomorrow.

Bangladesh Road Transport Corporation (BRTC) yesterday distributed advance bus tickets for the third day. It will start special bus services today.

"This is a complete lie, aiming to defame me. How can a person of my stature demand dowry?" questioned the distinguished scholar, who now teaches mathematics and natural sciences at Brac University.

He further alleged that the complainant and her husband KH Masud Siddiqui, secretary to the Ministry of Liberation War Affairs, went to his house on July 4 and harassed him and his wife Prof Shamima Choudhury in front of guests.

Prof Shamima teaches physics at DU and is a former provost of Rokeya Hall. She is also the director of Bose Centre of the university.

Following the incident, Prof Naiyyum lodged a general diary with Shahbagh Police Station. The academic further said his son Sajid, who is studying abroad, issued his wife a divorce letter one month ago, which might be the reason why the case was filed.

The Daily Star could not contact Masud Siddiqui and his family despite repeated attempts.
