

# JSC exams start Nov 2


Junior School Certificate (JSC) examinations for class VIII students will begin on November 2 this year. Dhaka Education Board published routines of the examinations, introduced in 2010 replacing the junior scholarship exams or class final exams. The examinations will end on November 18. The schedule is available on the board's website at [www.dhakaeducationboard.gov.bd](http://www.dhakaeducationboard.gov.bd). All exams will be held from 10:00am to 1:00pm with a gap of one day except for holidays, according to the schedule. Last year, the test was supposed to start from Nov 4, but it was rescheduled for Nov 7 due to

# SC adjourns Kamaruzzaman's death penalty appeal hearing till Sept 2

The Supreme Court yesterday adjourned the hearing till September 2 on the appeal filed by Jamaat-e-Islami Assistant Secretary General Muhammad Kamaruzzaman challenging the death penalty given to him for committing war crimes. The adjournment order came after Kamaruzzaman's counsel Nazrul Islam prayed for it as the court will go for a 37-day annual vacation from tomorrow. The court has so far heard the appeal for 11 days since June 5. On May 9, International Crimes Tribunal-2 sentenced Kamaruzzaman, one of the key organisers of the infamous Al Badr force, to death. He filed the appeal with the SC on June 6.

# TB death rate falls by 6.7pc in 13 years in Bangladesh

## Says study of University of Washington

Bangladesh has made a remarkable success in reducing deaths from tuberculosis and malaria, says a study of the University of Washington. It says between 2000 and 2013, deaths from TB in the county have fallen by 6.7 percent compared to 3.7 percent globally, while deaths from malaria have fallen by 11.1 percent that is 3.1 percent globally. An international consortium of researchers led by the Institute for Health Metrics and Evaluation of the university conducted

it for Global Burden of Disease Study 2013. Findings of the study co-authored by icddr,b scientist Dr Aliya Naheed were published in a journal, The Lancet, on July 22, icddr,b said in a press statement yesterday. Dr Aliya said, "Now we need to prioritise our growing challenge with HIV/AIDS," she said in the statement, citing the growing number of people being infected with HIV/AIDS. Worldwide, deaths from HIV/AIDS declined at a rate of 1.5 percent between 2000 and 2013, while in Bangladesh it increased by 1.9 percent.

# RISE IN VIOLENCE AGAINST WOMEN

# 68 rights bodies worried

Sixty-eight women, human rights and development organisations yesterday expressed their concerns about the gradual increase of incidents of violence against women across the country. Under the platform of "Samajik Protirodh Committee", the organisations said the perpetrators go unpunished which leads them to repeat offences, said a press statement signed by Bangladesh Mahila Parishad (BMP)

President Ayesha Khanam. The organisations, citing statistics of BMP, said in the first six months of the year, there had been 304 rapes, 82 gang rapes, 45 murders after rape, 127 murders for dowry, 90 incidents of violence for dowry, and 80 suicides, among other incidents of violence against women. The platform placed a six-point demand, including social rejection of rapists. They urged the government to provide legal help to female victims of violence.

# Road crashes kill six

Countrywide road accidents killed six people and injured 28 others yesterday and Tuesday. Our Pabna correspondent reports, Jatiya Party Lawmaker Advocate Altaf Ali's housemaid was killed while Altaf and four of his family members were injured when a bus hit their microbus at Koddar intersection near Bangabandhu bridge on Dhaka-Sirajganj highway in Sirajganj yesterday. The injured were admitted to Sirajganj Sadar Hospital, said police. Our staff correspondent from Chittagong reports, Saifuddin, 18, was killed and 11 others were injured in a head-on collision


between a bus and a truck in Hathazari yesterday. Meanwhile, auto-rickshaw driver Razzak was killed and five others were injured when a bus hit his vehicle at Kashinathpur intersection in Pabna's Santhia yesterday. Our Moulvibazar correspondent reports, Dhonu Miah, 40, was killed while four others were injured when a truck hit a CNG-run auto-rickshaw in Habiganj's Madhabpur on Tuesday. Our Nilphamari correspondent adds, Shaheda, wife of Zahed; and Karimuddin, 50, were killed and three others injured when a battery-run auto-rickshaw collided head-on with a sand-laden truck at Chowdhury Bazar in Jaldhaka yesterday.



others to 43 years' rigorous imprisonment each and Abdul Aziz to 13 years in jail for the murders. The two condemned convicts are Abdus Salam alias Moti and Zahid Hossain alias Natka Babu. Abdul Alim alias Shaheen, Monir Patwary, Munna, Kalu alias Kailla, Delwar Hossain alias Aunda, Deel Mohammad alias Moti, Mahatab Hossain, Mozammel Hossain and Amir Hossain were given 43 years' in jail each. All the convicts other than Deel and Mozammel, who are on the run, filed appeals with the HC in 2008 and 2009 seeking acquittal from the charges, Deputy Attorney General Bashir Ullah told The Daily Star. Khurshid Alam Khan, a defence lawyer, said an HC bench started delivering the verdict on the appeals on Sunday, and it will finish passing the judgment today.
