30 hurt in BNP factional clash in Rangpur

At least 30 people, including a policeman, were injured when two factions of Bangladesh Nationalist Party (BNP) clashed at Shalban in Rangpur city yesterday.

The clash ensued when supporters of Momtaj Sherin Bharosa, vice-president of BNP Rangpur district unit, attacked an iftar party arranged in a community centre by the supporters of Emdadul Haque Bharosa, who is Momtaj's stepson, and Md Mozaffar Hossain, president of BNP Rangpur city unit, said police and witnesses.

Emdadul claimed that Momtaj's supporters carried out the attack as he was

selected president of the newly formed Rangpur district unit over her stepmother.

When contacted, Momtaj denied any involvement of her supporters in the attack. The activists were carrying machetes and iron rods, said witnesses.

On information, Rangpur Kotwali police went there and charged truncheons and fired 25 rubber bullets to control the situation. A constable, Shariful Islam, was also injured in the clash. The injured of both the factions with hack and head injuries were

It was Hasina's first visit to any Western country after the Awami League assumed office through January's controversial elections of which the Western powers were critical. The UK, however, did not say anything negative regarding

the elections during the meeting, Mahmood Ali told reporters. In the summit, Hasina spoke about advancement made by Bangladesh in the last five years in women empowerment, poverty alleviation, social safety net and in living standards of Bangladeshis.

State Minister for Women and Children Affairs Meher Afroz Chumki, who was in the delegation to the UK, said Bangladesh has ratified the Girl Summit 2014 charter, committing to end early, forced, and child marriage by 2041.

Farjana sustained 17 percent burns to her body and is being treated in Dhaka Medical College Hospital. "My daughter's condition has not improved yet. I can't think of anything else but her till she gets well," said Yasin, who lost six of his seven children in the arson. "Once she recovers, I'll discuss the next steps with my community leaders. I want justice."




