Two Rab men give judicial statement

Nur Hossain sued for not depositing unlicensed gun

Two members of Rapid Action Battalion yesterday gave judicial statements as witnesses to a Narayanganj court over the abduction and murder of seven people in the district in late April this year.

The court of Senior Judicial Magistrate Monwara Begum recorded the statements of Lance Nayek Md Abdur Razzak and Sepoy Md Azam of Rab-11.

Narayanganj Detective Branch of Police Officer-in-Charge Mamunur Rashid Mondol, also investigation officer of the case, said the two Rab men gave the statement under Section 164 in two cases filed for the murders.

Meanwhile, Shiddirganj Police Station Sub-inspector Azit Mitra yesterday filed a case against Nur Hossain, the key accused in the killings, under the arms act for not depositing his pistol after its licence had been cancelled.

OC Md Ala Uddin said the district administration had asked Nur Hossain to

deposit the gun following the seven murders. Nur Hossian, however, handed over the firearm to his brother-in-law Nur Alam, he added.

On Friday, a train rammed into a car at the capital's Malibagh rail crossing. Later, from the wreckage of the car

police recovered a pistol and police identified that the firearm belonged to Nur Hossain who was arrested in Kolkata of India on June 14.

Seven people including Narayanganj city panel mayor Nazrul Islam and laywer Chandan Sarker were kidnapped in two separate incidents on April 27 and found dead in the river Shitalakkhya on April 30 and May 1.

Three Rab-11 top officials were fired over their alleged involvement in the incident.

The three ex-Rab officials Lt Col Tarek Syed Mahmud, Maj Arif Hossain and Lt Commander MM Rana were later arrested and placed on remand.

Sohel's authority may get

committee, Goyeshwar Chandra Roy, first joint convener Abdul Awal Mintoo and joint-conveners Kazi Abul Bashar and MA Quaium strongly opposed Sohel.

In the last three days, they held a series of meetings with the BNP chief and expressed their discontent for making Sohel the member secretary. They argued that Sohel was too young for the post.

Apart from other reasons, Abbas and others also argued that senior leaders who were included in the convening committee would feel uneasy to work under Sohel.

In spite of Khaleda's argument that Sohel is an educated and qualified person for the post, Abbas and others remain rigid to their stance.

Against this backdrop, Mintoo and Goyeshwar proposed that Khaleda lessen the importance of Sohel's post and not give him any signing authority, regarding formation of the complete committee of the Dhaka city BNP.

Khaleda agreed in principle to this end. She will sit formally with the convening committee tonight at her Gulshan office to settle the issue, party sources said.

Khaleda approved the 56-member convening committee of BNP Dhaka city as part of the plan to strengthen and prepare the organisation to wage a tougher anti-government movement in the capital. But the new committee could not start its activities due to serious rift between Abbas and Sohel causing disappointment of party high-ups.
