Rape victim kills herself

Denied justice by the law, society and her own family, a rape victim in Kushtia killed herself early yesterday.

The thirty-year-old housewife from Hashimpur village in Kumarkhali upazila was raped allegedly by a quack on Sunday when she went to his chamber in the village bazaar to abort her 3-month old pregnancy, according to police.

Once in the chamber, quack Rafiquzzaman Jhantu injected her with a sedative for the abortion process but started raping her when she fell unconscious. But soon she regained consciousness and screamed for help. She was then rescued by people at the bazaar and sent home with assurances of justice, police said.

However, her cries for justice only met with obstacles and further insults.

The first blow came when she went to Kumarkhali Police Station the next day and police refused to take her case. Instead, they sent her to Abdul Hannan, general secretary of Jagannathpur union Awami Legaue, to seek justice.

According to locals, Jhantu has close ties with Hannan.

After the victim's husband Shahjahan met Hannan on that day, the latter arranged an arbitration on Tuesday where the rapist was fined Tk 50,000 for the crime.

filed or not.... As there is no assessor at the Marine Court, the accused often file appeals with the higher courts and secure acquittal," he pointed out.

Shipping Minister Shajahan Khan said it takes years to dispose of a case at the lone Marine Court. The court lacked mandatory marine experts due to a shortage of such specialists, he claimed.

All the Marine Court verdicts drag for years in appeals with higher courts, said Jahangir.

According to shipping ministry statistics, there had been 393 launch accidents in the country in the last 25 years, including the sinking of Pinak-6 in the Padma on Monday. The disasters claimed around 3,700 lives while another 490 went missing.

However, private organisation National Committee to Protect River, Road and Railway, put the death toll at around 5,500 and 1,500 missing in 658 launch tragedies over the last two decades.

The government so far filed 308 accident cases with the Marine Court. The accused in 187 cases were either handed imprisonment or fine, while the rest of the cases were either dismissed or pend-

According to Inland Shipping Ordinance, 1976, the court can hand down a convict a maximum jail term of five years or a maximum fine of Tk

50,000. The government formed over 500 probe committees, but only three probe reports have been made public, said official sources.

On making the probe findings public, the shipping minister said the government will publish all the reports if any-

one asks for it. The probe committees had been invariably dominated by non-technical

bureaucrats. Besides, the bodies included no independent technical experts despite the fact that the entire issue of vessel capsize is technical in nature.

Any technical person either at the shipping department or Bangladesh Inland Water Transport Authority (BIWTA) is involved someway or the other in the approval and operation of a vessel. So they are not supposed to reveal their own faults, said a BIWTA official.

He added: If any probe report holds the negligence and malpractice of some officials responsible for a launch accident, the accused start lobbying with the committee members and department high-ups or reach some underhand deals

with them to shelve the report. BIWTA Chairman Md Samsuddoha Khandaker said, "I've to look into the office records to say how many accident probe reports have been shelved and

The government, said the shipping minister, this year has identified 21,000 unregistered passenger and cargo vessels plying the waterways in six districts alone. The government doesn't take any responsibility for loss or damage of life and property from those vessels, he added.

seeing their loved ones alive, but they wished to get at least the bodies.

Many of them gave the names of their missing family members to the information centre set up by the district administration at Mawa Ghat yesterday. Some of them provided the centre with photographs of the missing.

Some of them were busy checking the luggage that was fished out of the river, trying to figure out whether any of those belonged to their loved ones.

Briefing reporters around 7:00pm, Shipping Minister Shajahan Khan said a total of 19 bodies had been recovered so far. Of those, eight bodies were handed over to their relatives.

The minister, however, didn't give the identities of the victims or say where the bodies had been found.

But the information centre said 22 bodies had been recovered so far. Of those, two were found on Monday, one on Tuesday and the rest yesterday. Identities of eight victims could be ascertained so far, said officials at the centre.

The body of Fahad, 24, of Jhalakathi was recovered in Bhola on Tuesday.

The bodies of Jannatul Lucky, 20, of Shariatpur, Jamal, 27, of Faridpur, and Mizanur, 35, and Ima Akter, 18, of Madaripur were recovered from Sureshwar of Shariatpur yesterday, while the body of Rita Akter, 25, of Faridpur was found in Chandpur.

Of the 13 unidentified bodies, three were recovered at Mawa, five in Bhola, two each in Barisal and Chandpur, and one each in Shariatpur and Laxmipur,

said the centre. Police confirmed the deaths of two female passengers -- Hasi Begum and Nusrat Jahan Hira -- within an hour of the launch disaster.

At least 137 passengers were still miss-

ing, according to officials at the centre. The double-decker vessel, which was on its way to Mawa from Kewrakandi, was carrying more than 200 passengers against a capacity of 85. It sank in the face of strong waves and high winds in

the mighty river near Louhajang around 11:00am on Monday.

Meanwhile, all government agencies concerned held a review meeting at the middle of the meeting.

He said a joint intensive search was carried out with side-scan SONAR machines yesterday, and it would

continue until the launch was located. Apart from this, the fire service would continue its efforts to locate the launch, said Shajahan.

The minister said survey vessel Kandari-2, which can locate a sunken launch even if it is covered in silt, would join the operation.

The vessel reached Mawa Ghat from

Chittagong at about 12:10am today. Shajahan said survey vessel Jarip-10 would be used in the operation if Kandari-2 fails to locate the ill-fated launch. Jirap-10 has side-scan SONAR and GPS systems that are used in ocean

"We are hundred percent sure that the launch will be located and pulled out of the river bed," Shajahan said.


Talking to The Daily Star, Bangladesh Mawa Ghat in the afternoon. The ship- Inland Water Transport Authority ping minister briefed the reporters in Chairman Shamsuddoha Khandakar said eight vessels from the BIWTA, coast guard, the navy and fire service are engaged in the intensive search with the involvement of around 200 people.

Asked about the delay in launching the operation, he said, "Initially, we thought we would be able to locate the launch with our existing equipment and manpower. But, as time wore on, we realised that we needed more support." Government high-ups were informed about it, and the operation started on Monday night, said the BIWTA chairman.

"We are trying our best," he said.

However, relatives and family members of the missing were extremely unhappy with the rescue efforts.

"How will we be able to identify the

bodies? The authorities could not locate the launch even three days after the disaster. We believe the bodies are stuck in the hull," said Shahidul Islam, whose wife, daughter and niece remained missing.

Shahidul, who was also on board the ill-fated launch, jumped into the river and survived.

Recalling the horrifying moments, when the double-decker started going down. His wife Ayesha Akter held his hand when the launch was tilting to the left side.

But her hand slipped from his clutch as the passengers jostled to escape.

He was then pushed towards a window, and he got out of the hull.

Ali Abbas of Narayanganj whose wife and two daughters were missing said, "I want the bodies of my wife and daughters. That will be my consolation. want to bury them."

Some aggrieved relatives of the victims assaulted several journalists for what they said was misleading people with wrong information. They also hurled brick chips at a makeshift control room of Munshiganj police and a camp of the Red Crescent Society.

Subhan linked to mass killing Pabna freedom fighter

testifies at war tribunal

A freedom fighter yesterday linked Jamaat-e-Islami leader Abdus Subhan to a mass killing of more than 100 people committed at Sujanagar upazila in Pabna during the Liberation War in 1971.

SM Shamsul Alam, 22nd prosecution witness in the case against Subhan, told the International Crimes Tribunal-2 that he had seen Pakistani army shoot four people to death immediately after Subhan's conversation with them at Fakitpur village in Sujanagar on May 12. "He [Subhan] was the ameer of

Pabna Jamaat-e-Islami during the

Liberation War. He, in conjunction

with the Pakistani army, tried to eliminate the pro-liberation people in our area [in 1971]," Shamsul told the tribunal. The Jamaat's nayeb-e-ameer faces nine charges, including genocide, committed in Pabna during the ninemonth-long war. The accused, how-

ever, pleads not guilty before the tribunal. During his 65-minute testimony, Shamsul of Tarabaria in Sujanagar said he had heard gunshots from a nearby village around 6:00am on May 12, 1971 and found people fleeing citing

attacks by the Pakistani army. The 66-year-old witness said he also had hidden inside a sugarcane field beside their Union Parishad office in

"Israel has no problem extending the ceasefire unconditionally," an official told AFP on condition of anonymity. The current truce, which came into effect Tuesday, is due to expire at 8:00am local time tomorrow.

There was no immediate comment from Hamas. But it is expected to accept an extension of truce amid growing international pressure.
