WARRANTS AGAINST 46 DESTINY STAFF Cops again ordered to make arrests

COURT CORRESPONDENT

A Dhaka court yesterday ordered police for the third time to arrest 46 staff of Destiny Group including its Managing Director Rafiqul Amin's wife Farah Diba in two money laundering cases involving around Tk 4,200 crore.

The court asked police to submit reports on execution of the order by September 17.

Earlier on June 11, the same court issued arrest warrants against the accused and directed officers-in-charge of different police stations concerned to submit reports on execution of the order.

On July 13, the court had ordered police to arrest the 46 for the second time.

The Anti-Corruption Commission (ACC) on May 4 pressed charges against 51 people accused in the two cases.

Of the accused, Destiny 2000 President Lt Gen (retd) Harun-Ar-Rashid is on bail, while Rafigul and three other accused are now behind bars and the 46 are fugitives.

On April 11, 2013, during an opposition's hartal three people were killed and around 200 were injured as Hefajat-e Islam and Jamaat-e-Islami activists along with locals clashed with AL men at Bhujpur following a rumour that the marchers killed a local madrasa principal.



treatment in three hospitals before being released without a full recovery. After 19 months, she was diagnosed with cancer from sores in the liver. Her treatment was primarily funded by an NGO but it could not afford it for long, Hosen said. Amena had been admitted to BSMMU in June.

Because of a lack of proper treatment, at least four injured victims, all females, living in Savar's Nischintapur, developed serious complications. Mukta Banu is suffering

from hearing loss, Nasima from neurosis, Halima Akter from kidney diseases, and Zarina Akter from a displaced backbone.

One injured victim, Sumaiya Khatun, 16, died on March 21 from a cancerous brain
