

# Dealers raise urea price in peak aman season

Fertiliser dealers in Dinajpur and Kurigram districts are allegedly charging higher than the government rate for urea during the peak aman cultivation season.

The government fixed Tk 800 for each 50kg urea bag but farmers in 12 upazilas of Dinajpur have to pay additional Tk 80 to 120 for each bag, reports our Dinajpur correspondent.

This year the Department of Agriculture Extension (DAE) has set a target to bring 2.5 lakh hectares of land in Dinajpur district under aman farming. The target is likely to exceed when the aman seedling sowing ends in mid

September, DAE officials said, adding that they appointed 163 fertiliser dealers for smooth supply of urea to the farmers across the district.

But farmers in different upazilas of the district alleged that dealers are charging extra money for the fertiliser.

"I purchased 15kg of urea from Katla Bazar on Saturday, which cost me Tk 300. But the actual price should be Tk 240," said Md Abdus Sattar, a farmer of Daudpur village under Katla union of Birampur upazila of Dinajpur.

Rawshan Parvez, another farmer of the same village, said the dealers charged him Tk 920 for a bag of urea.

"As I wanted to know the

reason for charging high price, they said urea supply shortfall in the upazila and transport cost added to the price," he said.

The dealers do not give vouchers for the additional charge, alleged the farmers.

Md Mozammel Haque, a urea dealer of Chirirbandar upazila in Dinajpur, refuted the allegation of taking additional charge.

He, however, said some sub-dealers in rural areas are allegedly charging extra money for their transport expense.

Md Abdul Hannan, deputy director of DAE in Dinajpur, said, "There is no reason for urea shortage in the district this season. Officials are strongly monitoring the

distribution and marketing of the fertiliser in the district. It has to be sold as per the government's fixed rate."

Our Kurigram Correspondent reports: Farmers in the district have to buy urea for additional prices.

Earlier this season, farmers had to irrigate their lands to cultivate T-aman paddy as there was much less than usual rain. Following rainfall during the last few days, farmers are now busy to put in the land.

"I bought a 50kg bag of urea for Tk 800 some days ago, now it has to be bought for Tk 900," said Zaman, 52, a farmer of Panthapara village of Omar Majid union under Rajarhat upazila.

Fertiliser trader Bimal Chandra of Kathalbari Bazar in Kurigram Sadar upazila said, "We are getting two to five kg less in per 50kg bag of urea. And so, we are selling urea at Tk 18 per kg to adjust the cost."

Golam Mostafa, general secretary of the district fertiliser dealers' association, said, "There is enough stock of urea in the district. But the bags of the imported urea from China contain less than the stipulated weight. So, the retail traders sell it for a bit higher prices."

Local DAE officials said dealers have already received 60 per cent of the 6,335 tonnes of urea allocated for the district for the running month.

Protip Kumer Mondal, deputy director of DAE in the district, said, "We will take action if anyone takes extra charge for urea."

## Two students, kid drown

Two students and a three-year-old boy drowned in Kishoreganj, Sylhet and Sunamganj districts yesterday.

Sahadat Hossain, 18, an HSC second-year student at Rajuk Uttara Model College in the capital, drowned in Dhonu River in Karimganj upazila of Kishoreganj yesterday, reports our correspondent.

Sahadat was son of Nur Hossain of Noakhali.

Police said, Sahadat along with some of his friends came to visit their friend Ziaur Rahman Emon at Guzadia village in the upazila.

They said the boy drowned after being driven by strong current in the river while he was bathing along with his friends yesterday.

Our staff correspondent in Sylhet reports, a school-boy drowned in a water body in Ratargul forest, a natural tourist spot in Gowainghat upazila yesterday.

The deceased, Nazim Uddin, 14, was a Class VIII student at Jalalabad Cantonment Public School and College.

Nazim, along with his other friends were roving round a water body in the forest around 11:30am. Later, he went missing.

After sometime, he was rescued from the water body and rushed to Sylhet MAG Osmani Medical College Hospital, where the doctors declared him dead around 1:30pm.

In Sunamganj, a three-year-old boy drowned in a ditch near his house at Maddhya Tahirpur village in Tahirpur upazila yesterday, reports Moulvibazar correspondent.

The deceased, Hushiar Mia, 3, son of Tapos Mia of the village, fell in the water body while he was playing near it around 2:30pm.

## Ankhi saves herself

A mobile court awarded three people 15 days' jail each for arranging marriage of an underage girl at Jagadishpur village in Taraganj upazila on Saturday noon.

The mobile court, led by Upazila Nirbahi Officer (UNO) and Executive Magistrate Golam Mawla, punished bridegroom Md Ratan Mian, 21, his father Md Shafiqul Islam, 55, of Rasulpur village in Sadar upazila and the underage bride's father Md Nazmul Mian, 35, of Jagadishpur village in Taraganj upazila.

Court sources and villagers said, Ankhi Akter, 12, a Class VII student at Ikorchali High School of Taraganj upazila, was set to be married with Ratan on Friday night.

As Ankhi did not agree to the marriage, she secretly informed the matter to the UNO through a mobile phone of her neighbour.

## Erosion threatens Sonahat bridge in Kurigram

52 houses of a village devoured in two days

Erosion by the Dudhkumar River has taken a serious turn, threatening collapse of Sonahat Bridge anytime in Bango Sonahat union in Bhurungamari upazila.

Following onrush of water from upstream in the last two weeks, the river swelled and within a span of two days from Saturday, devoured at least 52 dwelling houses of Bharater Chhara village.

Sonahat Bridge, its connecting road on the western part, Bharater Chhara Government Primary School

and at least 60 more dwellings at the village are in serious threat of erosion, said locals.

People in the area urged the local administration several times to take steps to save the connecting road. On August 16, they suspended vehicular movement on the bridge for around three hours to press home their demand.

In Jatrapur union under Sadar upazila, around 450 families have lost their homesteads due to the erosion by the Brahmaputra River.

About one kilometre of the river embankment from Farajipara to Garuhara village has already been devoured in

last two weeks, said chairman of Jatrapur union parishad Abdul Gafur.

Besides, another half a kilometre of the dyke, No 2 Jatrapur Government Primary School, a mosque and several dwelling houses in the union are also facing erosion threat, said locals.

Abdul Kader, Acting Executive Engineer of the WDB, said they were dumping sand bags to save the bridge from possible collapses.

To protect the two and half kilometre area from erosion we had placed a project proposal of Tk 14.8 cores to the ministry concerned. However, we got only Tk 30 lakh, the WDB official said.

# Jamaat men attack devotees at mosque in Rangpur

Police arrested five leaders and activists of Bangladesh Jamaat-e-Islami in Rangpur and Barisal districts yesterday and the day before.

In Rangpur, police arrested two Jamaat men on Saturday on charge of their alleged involvement in attacking devotees at Pawtana Haat Jame Mosque in Pargachha upazila after Juma prayers on Friday, reports our correspondent.

The arrestees are Md Abdul Awal, 50, of Pawtana Haat area and Md Mottalib Hossain, 37, of Shibdeb village in the upazila, both activists of Chhawla union unit of Jamaat.

Police and villagers said, after Juma prayers on Friday, a group of devotees, led by Aminul Islam, a sub-inspector of Lalmonirhat Police Lines and a resident of Pawtana Haat area protested against the Imam of the mosque Maulana Mahmudul for not offering prayers for the departed soul of Bangabandhu Sheikh Mujibur Rahman during the *munajat* as the day was the National Mourning Day.

Following it, another group of devotees,

including Jamaat-Shibir men, swooped on them, leaving at least five devotees including Aminul Islam injured.

Being informed police rushed to the spot and brought the situation under control.

Mokbl Hossain, officer in-charge of Pargachha Police Station, said Aminul Islam lodged a case accusing 25 people on Friday night in this connection.

In the case he also mentioned name of 12 leaders and activists of BNP and Jamaat-Shibir, including the arrestees.

Later, police raided different areas and arrested Md Abdul Awal and Md Mottalib Hossain.

In Barisal, Muladi police yesterday arrested three leaders and activists of Jamaat-e-Islami Bangladesh including municipality Jamaat secretary Abul Hossain alias Babul Master, reports our correspondent.

Md. Alauddin, officer in-charge at Muladi Police Station, said they arrested them from the residence of Maulana Golam Azam at Hosnabad village.

Police arrested them when they were holding a secret meeting to plan subversive activities, he added.

### Two shot by BSF

Two Bangladeshi cattle traders were shot as Indian Border Security Force (BSF) opened fire on them at Kushkhali frontier in Sadar upazila of the district early yesterday. They are Ziaur Rahman Mollah, 26, son of Atiaur Rahman Mollah of Choigharia village of Kaliani and Siddiquar Rahman. They were taken to Khulna Medical College Hospital. Kushkhali Union Parishad Chairman Abu Raihan said, a group of Bangladeshi cattle traders crossed the border on Saturday to bring cattle. As they were returning to Bangladeshi territory, BSF from Khalisha Camp opened fire on them at around 4:30am yesterday injuring the two. Fellow cattle traders brought them to the Bangladesh territory.

### Abducted woman found killed

An elderly woman, allegedly abducted four days ago, was found dead in Bhangharpur area of Habiganj-Sayestaganj Highway in Sadar upazila of Habiganj district on Saturday evening. Deceased Alom Chan Bibi, 52, was wife of Amir Uddin of Haripur area in Sadar upazila of the district. Informed by locals, police recovered the body of Chan Bibi from a pond around 7pm, police said, adding Chan might have been strangled. The woman remained missing from the village since Tuesday morning, said the victim's son Nasir Uddin.

### Housewife 'commits suicide'

A housewife allegedly committed suicide by taking poison following a family feud at Rajapur village in Jhikargaccha upazila on Saturday night. The deceased was identified as Fatema Khatun, 18, wife of Firoz Hossain, of the village. Police said, Firoz Hossain used to torture Sabina for dowry after their marriage one and half years back.

### Bullet-hit body recovered

Police recovered the bullet-hit body of an unidentified man from beside Dhaka-Tangail highway in Mirzapur upazila yesterday. Being informed by locals, a police team rushed to Rashid Deohata area in the morning and found the body of the man, aged about 40, lying along the road and a shotgun beside him. The law enforcers suspected that the man was shot dead at some other place and later his body was dumped beside the highway.

## 'Missing' college boy found murdered

The body of a college student, who went missing on Saturday afternoon, was found in the Brahmaputra River in Sadar upazila yesterday.

The deceased, Azharul Islam Hridoy, 22, son of Faruq Ahmed Ratan of Joyrampur village in the upazila, was a BBA student of Government Ashek Mahmud College in the town.

Family members said Hridoy went out of their house at around 4:00pm on Saturday. As he did not return home until 8:00pm, they started looking for him.

Some locals told the family members that they saw Hridoy along with his cousin Nishat and friend Konok of the same village in Banarpara area at around

4:30pm on Saturday.

Since family members put pressure on the duo to know Hridoy's whereabouts, they said that he drowned in the river near Banarpara area.

Being informed by the victim's family, police went to the village and detained Nishat and Konok early yesterday.

On the basis of their statements, police along with locals went to Banarpara area and recovered Hridoy's body from the river at around 5:00pm yesterday.

The body bore injury marks in the face, said Sub-Inspector Rafique, who led the search operation. The body was sent to Jamalpur General Hospital morgue for autopsy.

Police said they will take legal steps after getting autopsy report.
