HALLMARK LOAN SCAM Sonali Bank's ex-DGM dies in jail custody

A former deputy general manager of Sonali Bank, AKM Azizur Rahman, suspended over illegal lending of Tk 3,547 crore to Hallmark Group and five other companies, died in jail custody last night.

Senior Jail Super Farman Ali said Aziz died at 7:45pm at

Bangabandhu Sheikh Mujib Medical University where he with heart diseases had been admitted for about a month. His health condition deteriorated in the afternoon, said Farman. On October 14, 2012, Rab arrested Aziz over the loan

scam that surfaced in May the same year. The Anti-Corruption Commission accused Aziz, his four

colleagues and 22 people from the private firms in 11 cases

for the loan scam. Aziz had been the manager at Sonali Bank's Ruposhi

Bangla branch when the swindling took place between 2010 and 2012.

Hasan who is not active in politics now was once involved with Nezam-e-Islami, another anti-liberation organisation, which was banned immediately after the independence of Bangladesh but resumed its activities during the regime of late president Ziaur Rahman. AZHARUL'S CASE

The three-member tribunal yesterday expressed discontent over "callousness" of the investigation agency as it observed that the agency could have produce more evidence to prove the charges.

As per the charges brought against him by the prosecution, Rangpur Town Hall was used as a torture centre for civilian by the Pakistani occupation army where Azharul used to go and facilitated the army.

In his arguments, prosecutor Tapas told that a rape victim who was tortured at the Town Hall testified before the tribunal accusing Azharul for being involved in abduction, torture and detention which are "enough" to establish the charges.

The proceeding of the case was adjourned till today. Azharul, facing six charges for his alleged involvement in

crimes against humanity and genocide, was produced before the tribunal.

broadcast media.

He criticised the government for not mentioning in the policy how licences will be given and on what basis.

Bulbul, who was involved in drafting the policy, strongly objected to the provision which said editorial policy of broadcast media should get approval of the proposed broadcast commission.

Iftekharuzzaman, executive director of TIB, said there are many negative provisions in the policy which hopefully can still be amended. "The proposed broadcast commission

can do the job after consulting with the

stakeholders. The policy will be a complete one after that," he said, adding that a ban on broadcasting any item which demeans armed forces or law-enforcing agencies and government officials who punish others for criminal offences is contradictory to the Right to Information Act. According to the policy, anything that is

in favour of a country, but proves to be harmful to other countries and thus affects friendly relations cannot be published.

"So we will not be able to write on incidents like the murder of Felani by the Indian Border Force if the provision remains," he observed.

Barrister Sara Hossain said many provisions need to be defined. Prof Shafiul Alam Bhuiyan, chairperson

of film and television studies department at Dhaka University, said a policy can be explained in many ways, but the good thing here is that a policy was formulated and it can be modified with definitions and explanations. "The policy is a working document. We can

work on it through discussions and criticisms," said Alam, a member of the committee that prepared the draft of the policy.

Terming the policy a good step, Mustafa Jabbar, also a member of the draft preparing committee, said information ministry officials were to correct the policy's language but they did not do so.

Media expert and Pro Vice Chancellor of the University of Liberal Arts Bangladesh Prof Golam Rahman suggested a comprehensive mass media policy considering the advancement of the technology.

Moderated by Tahmina Rahman, director of Article 19, Bangladesh and South Asia, the programme was addressed, among others, by Kamrul Ahsan Monju of Massline Media Centre and Shamsuddin Haider Dali of Maasranga TV.




