### Abe sends support message to Japan war criminals service

Japanese Prime Minister Shinzo Abe sent a message to an April memorial service dedicated to World War II war criminals, organisers said yesterday, in a move that prompted a scolding from China.

In the ceremony organised by former Japanese military officers, some 220 people prayed before a cenotaph on which the names of around 1,180 suspected and convicted World War II war criminals are inscribed, organisers said.

They include 14 "Class A" war criminals, who are also enshrined at the controversial Yasukuni Shrine, a spot seen in mainland Asia as a symbol of Japan's past aggression. The service took place on April 29

at a temple in Wakayama prefecture in western Japan, and the master of the ceremony read the message from Abe, an organiser told AFP. In his message, Abe said: "I express

my grief at the death of martyrs... who sacrificed their lives to form the foundation of peace and prosperity in Japan today," according to two participants and a report by the Asahi Shimbun newspaper.

"I pledge to work towards the future harmonious coexistence of human beings, and hope for eternal peace," the message said. The ceremony has been held annu-

ally since 1994 when the cenotaph was established by Masashi Tsuno, a man arrested in the Philippines on suspicion of war crimes at the end of hostilities, but who was later acquitted. Tsuno's supporters believe that the

punishments meted out by the Tokyo Tribunals in the years after the war represented little more than victors' justice perpetrated in revenge.

Organiser Kazuaki Naka, 75, said the service has been held "to console the souls of war dead, who sacrificed their lives for their home country, whether their executions were fair or unfair."

Buddhism holds that descendents and those who outlive friends, colleagues or neighbours have a duty to care for the spirits of the dead.

The religion is practised alongside native Shintoism in Japan, an animistic belief system that also places obligations on the living to seek the repose of dead souls.

Abe's message to the ceremony could prove another thorn in the side of relations with China and South Korea, both of which have been angered by his visit to Yasukuni last December and his equivocation on Japan's wartime wrongdoing.

# Subhan abetted mass killing

### Witness tells war crimes tribunal

A prosecution witness yesterday testified how Jamaat leader Abdus Subhan had abetted and facilitated the Pakistani army in a mass killing at several villages in Sujanagar upazila of Pabna during the Liberation War. Abdul Baten, 60, 25th prosecution

witness in the case against the Jamaate-Islami nayeb-e-ameer, told the International Crimes Tribunal-2 that he had witnessed the killing of four people by the Pakistani occupation army at the instruction of Subhan on May 12, 1971. The army had attacked their village

at 6:00am that day and caught his father Madari Mondal and uncle Laskar Mondal, he added. The witness said he had taken

shelter at a garden behind Basu Saha's

house where many people including

Chetona, Ratna, Ghughori and Modon were hiding themselves. Baten added he along with Chetona, Ratna, Ghughori and Modon had decided to go to Narohati Beel. Four army vehicles had stopped

near them on the way and Subhan was in one of those vehicles, he said. "Showing Chetona, Ratna, Ghughori and Modon, Moulana Subhan told the Pakistani army 'Those ... [used a racial and derogatory word to mean Hindus are people of Joy

"The Pakistani army immediately opened fire and killed them on the spot," said Baten, who witnessed the killing from behind a rain tree on the west side of the road.

Bangla'," he said.

The witness said he had fainted seeing the cold-blooded killing. "After some time I regained consciousness and went to my cousin late Azhar Mondal's house in Upendranagar."

He returned to his house after the Pakistani army had left the village around 2:00pm and begun searching for his father and uncle.

"Around 4:00pm I heard that about 20-25 people were killed in Kondorpur village. I went there and adjourned until September 1.

found bullet-hit Afsar of Kuripara village and Obaidullah of Momrajpur village. I also found my father and uncle in a state of unconsciousness," he added.

The witness said he had rescued his father and uncle and taken them home with the help of one Naran Biswas. "On my way home I saw many

bodies on the bank of the river [Padma] near Sindurpur village," he added. The witness said he had known Subhan from before May 12, 1971

The motive behind the murder was unclear.

Faruki's wife Lubna, his motherin-law, nephew Maruf Hossain and a domestic help were tied up.

# 'Natural disasters caused \$41b losses in first half

Natural disasters caused total economic losses of \$41 billion in the first six months of this year, much less than usual, reinsurance group Swiss Re estimated yesterday. The figure released by the Zurich-

based group -- which combines both insured and uninsured losses -- was down from \$59 billion (45 billion euros) in the first half of 2013. It was also about half the average

first-half loss of the previous 10 years, which was \$94 billion. The insurance industry took a hit of

\$21 billion from disasters in the January to June period. That was down from the \$25 billion in payouts over the same period in

2013, and also below the \$27 billion

hail which hit the United States in mid-May, causing \$3.2 billion in damage, of which \$2.6 billion was insured.

Next came June's storms in France, Germany and Belgium, where losses reached \$2.7 billion, with \$2.5 billion of that covered by insurers.

February's snowstorm in Japan inflicted \$5.0 billion in economic losses, but only half of that figured was insured.
