

Expedite Rangamati tech university project

PM asks education ministry

BSS, Dhaka

Prime Minister Sheikh Hasina yesterday asked the education ministry to expedite the process of implementing the Rangamati Science and Technology University project for expansion of science and technological education in the hill district.

Addressing the officials of the ministry at Bangladesh Secretariat she also asked the officials to formulate a policy on enrolment of the schools and colleges under monthly pay order (MPO) for construction of schools and colleges in every district in a planned manner.

Hasina arrived at the Ministry of Education yesterday as part of her plan to visit every ministry after taking office in January this year for the third time.

Education Minister Nurul Islam Nahid was also present. Hasina laid importance on construction of residential schools in the inaccessible areas of the hill districts considering its complicated communication system.

She said she was unhappy with the delay in construction of the university.

The government has requested Bhutan to provide necessary help for designing of the university, she said, adding that the architectural view of the university should be designed in consistence with the scenic beauty of the local area and it would also be an attractive tourist spot.

Hasina on Saturday at a rally at Suhrawardy Udyan bashed Khaleda for celebrating her birthday on August 15, the day Father of the Nation Bangabandhu Sheikh Mujibur Rahman was assassinated with most of his family members in 1975 by some wayward army personnel.

If Khaleda Zia really did not have a sick mind, it would not be possible for her to celebrate birthday on the day, Hasina said.

Pointing to Hasina, Fakhrul asked, "Who was declared wrong headed by the court? That was not Khaleda; that was Hasina."

People are not safe even in their houses; they are being killed by the law enforcers who are paid by the peoples' taxes, alleged Fakhrul.

Echoing Jatiya Party Chairman HM Ershad, Fakrul said the country has become a "state of forced disappearances".

The BNP leader asked all to be united to wage a tough movement to oust the government and establish a government of the mass people.

The tribunal adjourned the contempt petition hearing until October 30.

A similar incident took place on February 27 when no prosecutor attended the tribunal during the hearing of a contempt petition against New York-based rights body Human Rights Watch.

Meanwhile, the tribunal yesterday adjourned the hearing of another contempt petition, filed against Fakhrul Islam, the lawyer for war crimes convict Salauddin Quader Chowdhury. Regarding their absence, prosecutor Zead Al Malum said the date was fixed for the appearance of Fakhrul. "So, we didn't need to attend the tribunal."

Fakhrul was arrested on November 20 last year and is now in police custody for his alleged involvement in leaking of the draft war crimes verdict against the BNP leader.

Fakhrul faces contempt allegations for asking the tribunal, through a petition in December 2012, whether it had learnt about the alleged Skype conversation between former ICT-1 chairman Justice Nizamul Huq and an expatriate legal expert, Ahmed Ziauddin.

The tribunal yesterday said they wanted to hear Fakhrul's version and hence adjourned it until October 30.

Two more accused, Faruk Shamim Hossain, 32, and Sohel Khan, 28, were placed on a five-day remand each on Saturday.

During primary interrogation, they said rows over land grabbing and extortion had led to the murders, said Krishna Pada Roy, deputy commissioner of DB (south).

They also confessed to their direct involvement in the murders and their close connection with Kailya, police said.

Int'l workshop on blue economy begins today

In an effort to ensure the protection and exploration of marine resources in a better way, Dhaka has arranged a two-day international workshop on blue economy that begins at Sonargaon Hotel today.

The workshop is also aimed to establish links and build relations with countries and organisations working in the field of ocean research and resources.

Prime Minister Sheikh Hasina will inaugurate the workshop at 10:45am.

Some 32 representatives from 20 countries, including eight global experts on blue economy, and local experts will attend the event.

Several ministers, including Finance Minister AMA Muhith, Foreign Minister AH Mahmood Ali and Industries Minister Amir Hossain Amu, will address its inaugural session.

There will be three working sessions -- ocean resources for sustainable development, access to acquire ocean resources and turning ocean resources for a prosperous future.

According to the foreign ministry officials, Bangladesh is in a process to identify elements and course of action for developing a maritime policy and a strategy for Bangladesh through better understanding the dynamics of ocean-based blue economy.

After consecutive wins with Myanmar and India, Bangladesh is trying to move ahead with a 'land and sea' strategy as the importance of sea is growing globally.

Eminent Radiologist, **Col. (Retd.) Dr. Ahmed Fazlul Matin**, died on 25 July 2014, at his residence in Uttara, Dhaka. He was over 87 years old. He was born in 1927 in Walipur Village in Chandpur District. He obtained his MBBS from DMC in 1952, and was commissioned in the Army Medical Corps in 1953. Afterwards he did his MCPS from Pakistan. In 1971, he became the Superintendent of Chittagong Medical College Hospital, and then the DG of NIPORT. Later, he became the Director of Medical Services of Bangladesh Navy, and then head of Radiology Department of CMH, Dhaka Cantt. He retired from the Army in 1987, and worked as a Radiology Specialist at Popular Diagnostic Clinic until 2012. He leaves behind the following family members to mourn his departure: his wife Mrs. Razia Khatoon, sons Dr. Shaukat Matin and Dr. Arif Matin, and daughter Meeta Quader.
