A Dhaka court yesterday fixed October 12 for hearing on charge framing against BNP acting secretary general Mirza Fakhrul Islam Alamgir and 25 other leaders and activists of the BNP-led 20-party alliance in a case for violence on March 2 last year.

The case was filed with Paltan Police Station for violence, vandalising and torching vehicles, and assaulting police during the then opposition's agitation on the day.

nels, at his house on August 27.

Reza said his younger brother Faisal Farugi had filed a case of murder and robbery after the incident when he and another brother were abroad.

LEBANON DEPORTING BANGLADESHIS

Their govt had no clue

Although a Human Rights Watch report on Tuesday claimed that Lebanon was deporting locally born children of Bangladeshis and five other countries and in some cases their mothers, the Bangladesh government apparently had no idea about it.

"We don't have any information about this. Besides, there is less scope for the Bangladeshis to live and work with their families in Lebanon," said Begum Shamsun Nahar, director general of the Bureau of Manpower Employment and Training (BMET).

Since May, nearly 12 female migrant workers, many of them longstanding residents of Lebanon, reported to rights groups of being turned down after seeking to renew residency papers for themselves and their children, said the report.

Claims defence at war crimes tribunal

ATM Azharul Islam was accused of crimes against humanity and genocide for assuming the role of Jamaat-e-Islami acting secretary general after former secretary general and war crimes convict Ali Ahsan Mohammad Mojaheed's trial started, stated defence lawyers yesterday.

Counsel Abdus Subhan Tarafder was placing closing arguments for the fourth day before International Crimes Tribunal-1, led by Justice M Enayetur Rahim and comprising Justice Jahangir Hossain Selim and Justice Anwarul Haque.

One of the six charges for involvement in crimes against humanity and genocide state that Azharul abducted 11 unarmed civilians on March 24 and 27, 1971 and took them to Rangpur Cantonment where they were tortured for seven days.

The then president of Islami Chhatra Sangha (ICS) of Rangpur unit, Azharul had carried out the abduction as per his conspiracies and was aided by armed members of Jamaat, ICS and the Pakistani army, it says.


All but one, Dr Deenesh Chandra Bhowmik alias Montu

Dakter, who survived with bullet wounds, were mowed

down after being taken to the Dokhiganj crematorium at the dead of the night on April 3, 1971, it adds. Before passing away in November 1989, Deenesh had passed this information down to his son, Rathish Chandra Bhowmik, the case's 13th prosecution witness who had seen


the March 27 abduction of his father by the Pakistani army. Subhan argued that the prosecution did not specifically state what Azharul's conspiracy was and how he had


