wrong in mentioning three million deaths and the number of 200,000 women raped in 1971".

In his submission on August 25 and yesterday,

Bergman's counsel Mustafizur Rahman Khan, however, said the write-ups were "definitely critical" but fell under the parameters of permissible fair criticism and had been made "bona fide and in good faith".

But, petitioner's lawyer Mizan Syeed yesterday said Bergman was a "habitual contemptner" as he wrote the "contemptuous articles" even after being cautioned seriously by a tribunal earlier for his other writings.

Bergman's blogposts cannot be considered "fair criticism", as those had a "tendency" to malign the dignity of the tribunal and "tended it and its members into public hatred", he added.

In his earlier submission, the defence lawyer said his client, upon receiving a notice from the tribunal, deleted two words from his write-ups expressing regrets. However, replying to a court's inquiry, he said Bergman did not mention in his blog why he had deleted the words. But, the petitioner's counsel said Bergman deleted the

words because he understood that it was "contemptuous" and "this is one sort of admission." Besides, the words were a very "little part of his contemptuous articles" and deletion was done lately, he said. Mizan also refuted the defence's claim that the peti-

tioner did not specify the parts of the articles, which amounted to contempt. "We specified the allegations, and even quoted from the articles of the contemptner in the ninth to 15th paragraph and the 25th paragraph of our petition," he said.

Meanwhile, the tribunal recorded the testimony of Azabuddin Miah, the 27th prosecution witness in the case against Jamaat-e-Islami leader Abdus Subhan.

Azaduddin, an assistant librarian of Bangla Academy, exhibited two newspapers reports—one of The Pakistan Observer and the other of the Dainik Azad.

The report of The Pakistan Observer, published December 9, 1970, testified that Subhan contested the 1970's election, while the Dainik Azad on September 7, 1971 published a statement of Subhan, said prosecutor Sultan Mahmud Simon.

The proceeding was adjourned till Sunday after the defence declined to cross-examine Azabuddin.

## Costly loans keep them poor: Study Initiative (PRDI), surveying 2,000 house-STAFF CORRESPONDENT

Majority of the people in haor and coastal areas have to take loans at high interest rates to cope with the impacts of climate change on their livelihood, and fall in a vicious cycle of poverty, according to a study. Eighty-eight percent of people of

Sunamganj haor areas and 73 percent of Satkhira and 50 percent of Cox's Bazar coastal areas said they took loans to "survive" after loss of livelihoods induced by climate change.

Majority of the respondents said they failed to overcome poverty and lead a normal life even after engaging their children in labour.

Climate Hot Spots", its findings were

disseminated in a seminar at Jatiya Press Club in the capital yesterday. Coastal fishermen are at the highest risk as they fish in the "rough sea" and live close

to the shore, found the study. It added that all respondents in the coastal areas believed that saline sea water had penetrated their croplands due to high tides and rise in the sea level.

"While cyclones and rough weather often cause deaths to many fishermen, others have to return to shore without any fish accepting a financial loss," read the study.

tal clinics and jailed five dentist impersonators for nine months each in the capital's Karwan Bazar yesterday. The court also fined them Tk 1 lakh each, in default, to suffer three months more.

The convicts are SM Ilias Hossain of Garden Dental Care, Hasanur Rahman of Al-Madina Dental Care, Akter Hossain and Tofazzal Hossain of Al Hera Dental Care and Md

Alauddin of Zannat Dental Care. AHM Anwar Pasha, executive magistrate of Rapid Action Battalion, who led the drive, said the four convicts had no qualification but they were using different degrees in their nameplates introducing themselves as "specialist dentists." They were prescribing medicines and conducting surgery in

Bangladesh Medical and Dental Council, the regulatory body, before the court, added Pasha. It is alarming that they were using equipment without

the clinics though they failed to show certificates of

sterilising those before the surgery, said the magistrate.

# One of ten injured dies

One of the 10 people injured in Monday's fighting between Bangladesh Chhatra League activists and supporters of a businessman in Gazipur's Kaliakoir upazila died in hospital yesterday.

Salim Hossain, 37, of Shibchar upazila in Madaripur, was a jhut (scraps of fabrics) trader and lived with his family in Mowchak area of Kaliakoir.

The clash occurred because of contention over a jhut business, shared by Sakhawat Hossain Ruben, an ex-BCL leader, and Md Juel Ahmed, a BCL supporter and younger brother of Mowchak Union Parishad Chairman Lokman Hossain, also an Awami League leader.

The victim did not take part in the clash but was attacked by BCL men because he was allied with Juel. He had suffered injuries to the head.

Two men including BCL Gazipur city unit President Masud Rana Ershad, who led the clash at the behest of Ruben, were arrested for the violence. Ershad was remanded for two days yesterday, said Officer-in-Charge of Kaliakoir Police Station Omar Faruq.


