Japanese PM's 21-hr busy schedule

Japanese Prime Minister Shinzo Abe, who arrives here this afternoon by a special flight, will spend a busy schedule during his twenty one and a half hours official tour.

According to the programme schedule, Abe is expected to arrive at the VVIP terminal of Hazrat Shahjalal International Airport at 1:00pm where Prime Minister Sheikh Hasina will receive him. He will be given a guard of honour by a contingent drawn from the three services.

The Japanese PM will visit National Mausoleum in Savar at 2:00pm to pay tribute to the martyrs of the Liberation War. From there, he will go to Bangabandhu Memorial Museum at Dhanmondi at 3:00pm. He will then go to Pan Pacific Sonargaon Hotel where he will be staying during his visit.

Shinzo Abe will address the Bangladesh-Japan Economic Forum jointly organised by Bangladesh Board of Investment (BOI), Federation of Bangladesh Chambers of Commerce and Industry (FBCCI), and Japan External Trade Organization (JETRO) at the Ballroom of Sonargaon Hotel at

around 3:00pm. He will leave for Prime Minister's Office at 4:00pm for summit meeting with his Bangladesh counterpart.

Later, the two leaders will join the delegation level official talks. After introduction of Japanese business delegation, signing ceremony and joint press conference at the PMO, the Japanese premier will

leave for Bangabhaban to call on President Abdul Hamid. After that, Abe is expected to meet the leader of the opposition Raushan Ershad and former Prime Minister

Khaleda Zia at Sonargaon Hotel.

Direct investment from Japan in Bangladesh is very low. In 2013, the inflow was only \$100 million, though three times higher than the previous year that saw around \$30 million in investment.

Remove barriers

In a joint statement during the visit, Hasina urged Japanese entrepreneurs to invest in Bangladesh and Abe made a positive response to this.

Last month, an investment promotion mission from Japan held several marathon meetings with the officials of Prime Minister's Office (PMO), Bangladesh Bank (BB) and other authorities concerned to discuss ways to remove the obstacles.

And on Thursday, Foreign Minister AH Mahmood Ali told reporters at his ministry that Dhaka expects Tokyo would invest in garments, pharmaceuticals and various other Association. sectors.

In a proposal submitted to the government last month, the Japanese investment promotion body asked Bangladesh to bring all the agencies, which deal with foreign investors, under the umbrella of the Board of Investment (BoI) so that they can start business quickly without facing any hassle.

They strongly requested that the BoI be given the authority to grant the major bond and factory licences; environmental clearance; TIN and VAT registrations; certificates for fire safety and tax exemption -- that are required for setting up a business.

The investors described foreign garment manufacturers' current incaindustry. The certificate is currently issued only by Bangladesh Garment Manufacturers and Exporters Association and Bangladesh Knitwear Manufacturers and Exporters

Meanwhile, Bangladesh plans to allocate 500 acres of land for a special economic zone for Japanese investors. Besides, 40 plots and two factory buildings have already been designated for them in the existing five Export Processing Zones (EPZs).

the criminals took away Tk 47 lakh but the deceased's uncle Mujibur Rahman yesterday in a case filed with Khilgaon Police Station said the muggers took away Tk 38 lakh.

He accused three to four unnamed people in the case, said Sub-Inspector Fazlul Haque.

Muggers on Thursday night shot Sharif Hossain Simon dead and wounded his father Israil Hossain, the owner of Universal Money Exchange, near Khilgaon Fire Station.

Morgue sources said Sharif received yesterday. two bullets.

Israil is now undergoing treatment at National Institute of Traumatology and Orthopaedic Rehabilitation. He received around six bullets and was expected to go into surgery, family sources said

quoting doctors. Israil has been informed about his son's death and he wanted to see the body. Sharif's body was kept at Birdem mortuary after a namaz-e-janaza held at his Khilgaon home after Asr prayer

Deceased's cousin Mosharaf Hossain Rubel told The Daily Star that Sharif and his father had no personal enmity with anyone. Criminals might have shot them for the money they were carrying.

The two were bringing the money home at Shantipur from their work in Motijheel as they ran out of time to deposit it in the bank that day.

The snatching of the money after shooting people has become a common phenomenon in the capital

recently. The law enforcer could not either trace the criminals or recover the money.

On August 17, muggers shot Mujibur Rahman and took away Tk 30 lakh from him in broad daylight in Mirpur-2. Mirpur police are yet to arrest anyone or recover the money.

Even though detectives claimed that they had arrested four suspects involved in the snatching away of Tk 31 lakh in Moghbazar last month, they could not recover the money.
