The Supreme Court yesterday extended its earlier order that stayed the bail of an accused in Tanwir Muhammed Taqi murder

A five-member bench of the Appellate Division headed by Chief Justice Muzammel Hossain gave the order.

On June 24, the High Court granted an adinterim bail to Saleh Rahman alias Simanta for six months and issued a rule upon the government to explain why the accused should not be granted regular bail.

The chamber judge of the SC on July 1 stayed the HC order for two weeks following a petition filed by the government seeking a stay on the HC's order.

Now the stay order will continue till the disposal of the HC rule, Deputy Attorney General Md Suhrawardy told The Daily Star yesterday.

Simanta, son of Bazlur Rahman alias Hazi Ripon, is a Jatiya Party leader of Chasara in Narayanganj.

Taqi, an A-level graduate and son of former president of Narayanganj Sangskritik Jote Rafiur Rabbi, was found dead on the bank of the Shitalakkhya on March 8 last year, two days after he

had gone missing.

Student unrest prompts closing of main campus

The BGC Trust University Bangladesh authorities have declared its main campus closed till September 15 following students' demonstration demanding clarification about its legality.

The decision came at a meeting of the university administration on Monday night, said its Assistant Registrar Aktaruzzaman Kaisar.

Students demonstrated on the main campus at BGC Biddyanagar in Chandanaish upazila of Chittagong for the fourth consecutive day yesterday demanding that the authorities make it clear whether their campus has the University Grant Commission (UGC)'s approval or not, said campus

Assistant Registrar Kaisar yesterday said, "We have discussed with the students today and tried to make them understand that as per the UGC advertisement published in different newspapers on Monday, only our city campus [at Nasirabad in Chittagong city] has been mentioned as not having the commission's approval."

Contacted, Reduanul Haque, one of the agitators and an LLM student, said at the meeting with the university authorities held yesterday, the students demanded that the authorities publish an advertisement in newspapers with reference to the UGC approval. The authorities assured them of doing so, he added.

employees in the hope that their promotions would be finalised later, said officials seeking anonymity.

The former two denied the allegations of taking bribes while the other was not available for comments.

Seven of the 10 joined BISER as class-III employees and were later promoted to class-II officers. The other three entered jobs as class-II officials.

Asked about the upcoming promotions, Chairman Rouf Mia told The Daily Star, "The process was actually initiated by my predecessor, and I am in a dilemma of what to do now. I am still discussing the matter with senior colleagues."

He, however, said the promotions would not be illegal. He explained the board had been promoting officials this way since 1995, and the Board Committee in March insisted on finalising the promotions of the 10.

Ex-chairman Tanbirul Alam, who had given the current charges to the 10 officials back in 2012, said he did it to deal with an emergency situation. "I also recommended filling the posts through a proper selection process."

BCS GEA chief Prof Nasrin Begum said it was not that the previous wrongs could not be corrected now.

The Islamic University authorities yesterday removed proctor Mahbubor Rahman from his post after widespread agitation by some student organisations on the campus against him.

Prof Talukdar Lokman Hakim was made the new proctor, said Registrar Moslem Uddin.

The decision to remove Mahbubor came as he failed to break the deadlock on the campus by yesterday when the university reopened after a closure for 15 days, officials said. On August 24, Mahbubor allegedly verbally allowed

Shibir activists of the university to bring out a procession on the campus defying the university rules. However, then the proctor denied the allegation. Protesting the proctor's alleged move, Bangladesh

Chhatra League brought out a procession and went on the rampage on the campus. Later, following an order from the proctor, police deployed there fired rubber bullets, injuring at least 30 BCL men.

Following the incident, the university was shut for an indefinite period. Since then, Chhatra Sangram Parishad, a forum of different student organisations, has been waging movements seeking the proctor's removal.

Why is their condition so dismal then?"

The prosecutors speak very well before the press, and they tried to attract the media but their performance is not reflected in the papers they present, the bench said.

The SC also castigated Kamaruzzaman's lawyer SM Shahjahan, saying the way he had placed arguments was not satisfactory, too. The defence was asked to submit written arguments today, when the attorney general is expected to place further arguments.

Kamaruzzaman, an Al Badr leader in 1971, was sentenced to death on May 9 last year. He filed the appeal with the SC a month later, on June 6, that year.


