DALIT, HARIJAN STUDENTS JnU likely to introduce quota for them this yr STAFF CORRESPONDENT

Responding to the demand of the students from the downtrodden Dalit and Harijan communities, the vice chancellor of Jagannath University (JnU) yesterday promised to introduce an admission quota for them in his institution this year.

VC Prof Mizanur Rahman said he would issue a "white paper" to the dean of every faculty and the admission committee the very day so that Dalit, Harijan students could enroll by obtaining the minimum qualifying score in the admission test in the 2014-15 academic session.

The admission test for one of the five units has been held, and the rest are due to take place in the next one month.

According to a press release by human rights organisation Paritran, the VC made the commitment yesterday following an advocacy seminar at JnU, organised by Paritran and Bangladesh Dalit Parishad (BDP) to ensure Dalit and Harijan students' access to higher education through quotas.

Bangladeshi dies in UK immigration detention

A Bangladeshi who was picked up by UK immigration police, died in its detention centre at Linconshire, some 140 miles away from London, on Saturday.

Rubel Ahmed, 22, son of Abdul Jalil, who hailed from Sangirai village in Bishwanath upazila, had been living in UK since

Rubel was held by the law enforcement agency on July 22 from a restaurant in the Kent city of UK. Since then Rubel had been in Morton Hall Immigration Detention Centre in Linconshire, Enamul Haque, a cousin of the deceased, told The Daily Star in Sylhet.

On Saturday, UK police informed about the death without saying any reason, said Enamul, quoting some locals in London.

"Later we lodged a complaint to the UK police requesting them to inform about the reason behind the death," he added.

Meanwhile, Bangladesh High Commission in London in a press release said the home office told them that, Rubel, who was found hanging from a door SEE PAGE 4 COL 2

WAR CRIMES CONVICT KAMARUZZAMAN'S APPEAL

SC reprimands state, defence lawyers for poor preparations

The Supreme Court yesterday reprimanded both the state and defence counsels for their lack of preparations in placing arguments during the hearing of an appeal that challenges the death penalty passed on Jamaat-e-Islami leader Muhammad Kamaruzzaman for war crimes.

When Attorney General (AG) Mahbubey Alam prayed for time to place the arguments, the court pointed out the fact that he was the only state lawyer present at that time.

Many competent lawyers usually accompanied the AG in dealing with many sensational cases earlier, but they have left him now, which is not a good sign, said the four-member bench of the Appellate Division headed by Justice SK Sinha. A deputy attorney general used to assist the AG in dealing

the war crimes cases but none was present in the courtroom at that moment yesterday.

'Bribe' makes 10 illegal

As per the board's rules, it is mandatory to fill 60 percent of vacant posts of class-I officers by putting BCS (education) officials on deputation, and the remaining 40 percent by promoting board officials based on their qualification, efficiency, and seniority, said Prof Abul Kashem, a member of the selection committee for the upcoming promotions.

"It'll be difficult for the board to provide

quality services if the rules are ignored," he

told The Daily Star. Meanwhile, BCS General Education Association (GEA) demonstrated on the board premises yesterday, demanding scraping of the promotion process.

GEA President Prof Nasrin Begum and Secretary General Prof Selimullah Khondoker also submitted a memorandum to the board chairman, Prof Abdur Rouf Mia, and threatened legal action if their demand is not met.

In June 2012, the 10 officials were put in the charge of the posts they may get promoted to.

The 10 paid Tk 1.5 lakh to Tk 2 lakh in bribe each to Prof Rouf, then secretary of the board, Prof Tanbirul Alam, then chairman of the board, and a then leader of the

The decision came as they were involved in beating up several management staff in the factory during a demonstration demanding salaries in the factory before Eid-ul-Fitr, Shahid Ullah, senior assistant director of Ashulia Industrial Police quoted the management as saying.

Following the incidents, the factory authorities sued 61 workers. Since then, the workers have been demanding that the

The Rab men also recovered Tk 5.28 lakh from their possession.

employers or the placement agencies.

According to the report, 46 percent were threatened, including threats of physical violence, denunciation to police, deportation, in addition to being denied basic rights, such as access to food, receiving due salary, or contacting people.

More than 10 percent of the interviewees claimed that they faced sexual violence like unwanted advances, molestation, or rape, while around 36 percent were subjected to physical violence such as beating, pushing, slapping, hair pulling, stick or belt beating, biting and hair cutting.

Besides, 62 percent faced verbal abuse by a household member, a relative, or someone from the recruitment agency.

The report said 81 percent were promised a specific salary, but 53 percent of them received a lower amount. It added that around 84 percent of workers were not informed of the working hours, weekly day off, employer's household composition, and facilities to communicate with their families.

It also mentioned that 77 percent of those interviewed worked at least 14 hours a day, 50 percent were locked inside the house, and 43 percent were not allowed to contact their families.

The placement agency in Lebanon or the recruitment agency in Bangladesh or Nepal exploits the victims in these ways, but neither the destination government nor the governments of the countries of their origin have proper monitoring to ensure the domestic helps' rights. In order to avoid being arrested, the workers are forced to forfeit their wages or any other compensations resulting from inflicted harm.

The Lebanese state agency's report recommended that the Lebanese, Bangladeshi, and Nepali governments must closely monitor placement and recruitment agencies to curb corruption and bribe to ensure domestic workers' rights.

Expatriates' Welfare and Overseas Employment Secretary Khondaker Showkat Hossain said they rarely received allegations from the female workers in Lebanon, but they would look into the issue.
