Basheer keeps painting at 83; set to exhibit new works next week

He is 83 years old, diagnosed with a lung disease. To survive each day, he inhales oxygen for six hours and spends another three hours pumping out carbon dioxide trapped in his lungs, using a respiratory machine.

Murtaja Basheer, one of the most renowned senior artists of the country, has been beset with such critical health conditions since December last when he was hospitalised. He, however, remains far from surrendering to old age or aggravating physical ailments compounded by excruciating, regular medical procedures.

With oxygen cylinder following him like a shadow, Basheer's brush keeps on stroking carefully nuanced textures and lines on canvases for an art exhibition next week.

"I have to make money. My treatment is very costly. I had some plans like conducting some research at the fag end of my life. But I have put these on hold. All

Defending the National Broadcast Policy 2014 again, Prime Minister Sheikh Hasina yesterday said the Broadcast Commission would be formed in light with the policy so that the country's flourishing broadcast media could be run properly.

Since the announcement of the National Broadcast Policy, she alleged, a certain quarter has been vehemently opposing it even though the draft policy was on the website for over three weeks and opinions were taken from the stakeholders concerned.

Muggers in guise of DB loot Tk 72 lakh

Criminals impersonating law enforcers snatched Tk 72 lakh from three staffs of a readymade garment factory from Jhajhor area in Gazipur City Corporation yesterday afternoon. They also kidnapped the trio but

later abandoned them while escaping. Accounts officer Saiful Islam and administrative officer Abbas Ali of Nahar Sweater Ltd withdrew the money from the capital's Uttara

Kaliganj police later rescued the three and seized the abandoned microbus from the spot.

The parliamentary standing committee on law ministry made the decision in a meeting after completing the scrutiny of the much-talked about bill that empowers the JS to impeach SC judges on grounds of misbehaviour or incapacity. The bill was placed in parliament on

Sunday. Emerging from the meeting at the JS Bhaban, Suranjit Sengupta, chairman of the committee, told reporters that the decision was taken to avoid controversy. But experts would be able to give their suggestions during the formulation of a law in this connection after the bill is passed.

The law will be enacted within three months of the bill's passage, he added.

Ziaul Haq Mridha, a Jatiya Party MP and member of the committee, said his party would not oppose the bill as "there was nothing objectionable in it".

"Those who are criticising the bill from outside of the parliament are wrong. We need this law for the sake of an independent judiciary. Therefore, the Jatiya Party will not oppose it," Mridha said after the meeting.

Emergency doctor Farid Uddin Ahmed at CMCH said none of them received bullet or splinters injuries. They were hurt by glass fragments.

The injured teachers said their buses came under attack on their way to campus from the port city around 10:30am.

Lying on CMCH bed with head injuries, Ashrafuzzaman said seven to eight attackers first opened fire and then hurled crude bombs. He could not believe students could attack teachers.

"We thought a tyre of the bus had exploded," he told The Daily Star, adding, "We hid behind the seats and the driver drove away quickly."

Traumatised Sonam Akter was not in a state to talk. Her ear was injured badly. Fatem-tuz-Zohura sustained injuries in her right hand and neck and Shirin on the left cheek.

"We were going to the university to impart lessons, to reduce session jams ... how could they attack us?" said Shrabonti Saha, a lecturer of Biochemistry who escaped injuries. Police arrested five Shibir activists --

Md Akteruzzaman, 22, Sabbir Hawladar, 22, Md Yusuf, 23, Imran Ali, 25 and Md Tauhid, 23 -- in Chhararkul and Fatehabad areas of Hathazari.

All of them are students of the university.

Officer-in-Charge Md Ismail of Hathazari Police Station said two of them were arrested at the spot and the rest from the nearby student messes.

Md Shahidullah, additional superintendent of police, Chittagong north, claimed that two of the arrestees had admitted to taking part in the attack. Police also picked up 15 people

from a cottage near Suhrawardi Hall around 6:30pm. Six sharp weapons, six crude bombs, a homemade gun, and leaflets and banners of Shibir were also recovered. MOTIVE

Yesterday's attack was a sequel to the feud between Chhatra League and Shibir over establishing supremacy on campus and CU dormitories.
