Gayle out of second Test

CRICINFO, St Lucia

Chris Gayle has been ruled out of the second Test against Bangladesh in St Lucia after being given permission to deal with a "personal matter" by the WICB.

His place in the squad has been taken by Leon Johnson, the 27-year-old Guyana batsman, who is uncapped at Test level but has played three ODIs. Johnson has a first-class average of 33.18 from fifty matches with two hundreds.

Gayle made 64 and 9 not out in the first Test, which West Indies won by 10 wickets, and bowled 17 overs in the second innings to claim 1 for 50.

Other than the absence of Gayle there are no other changes in a 13-man squad. Shane Shillingford and Jason Holder are the two players who did not appear in the first Test in St Vincent.

The match will mark West Indies' 500th Test.

Tigers in need of different approach

2nd Test at St Lucia begins today

Poor batting, puzzling tactics and an unreasonably defensive approach on the field; each of these limitations glared throughout the five days of Bangladesh's thumping Test defeat in the series opener.

And if the Tigers have any realistic plans of drawing the series—the second Test begins at St Lucia today-- they need major changes in all these departments.

Except for Mushfigur Rahim, every other batsman in the side seemed like they were part of a limited-over contest, thoughtlessly going at anything pitched outside the off-

The manner in which Shamsur Rahman got dismissed in the second innings - got caught at slips as he stood at his crease and swung his bat at a half-volley-perhaps best described the sordid affairs of the Bangladesh batsmen.

Tactical errors also played its part. Will the team management go in with just three specialist bowlers in the second Test and elect to field again? Or will they continue to depend upon the likes of part-timers Shuvagata Hom and Mahmudullah Riyad?

With Imrul Kayes out due to a skin infection, the Tigers will have to make a change. The left-hander is likely to be replaced by Anamul Haque. A change in the bowling is also on the cards after the toothless display in the first Test.

Robiul Islam, Shafiul Islam and Elias Sunny are the bowlers who were benched in the last Test. Of them Robiul has a high chance of making it to the eleven. The bowler has been Bangladesh's third highest wicket taker in the last two years and it was a surprise when Rubel Hossain was picked ahead of him in the last Test.

The management might even think of replacing Shuvagata, who although did bowl quite a handful number of overs, failed as a batsman. For the hosts, Chris Gayle won't be available who has been excused by the board for the player's 'personal reasons'.

Like St Vincent, St Lucia does not seem to have an apparent advantage for either the spinners or the pacers in Tests. Since 2003, 33 wickets were at this venue were taken by spinners and 38 went to pacers. In ODIs though, pacers have taken twice as many wickets as the spinners.

However, statistics won't make a difference as long as Bangladesh can't regain its form. It was an aspect that was witnessed in the last Test when the Tigers faltered twice on a flat track that barely had anything in it for the bowlers.

That is perhaps the reason why the team management stressed and discussed the mistakes of the first Test until Thursday evening, instead of chalking out their plans for the second Test.

There were a host of factors during the first Test which indicated Bangladesh's confused mindset—their bowling depended on part-timers; an impatient Mushfigur made five changes in the first 16 overs; they elected to bowl first with eight batsmen in the side; while Mahmudullah did get a half-century in the last innings, promoting him to number five after he scored just 60-odd runs in the six innings prior to this series seems like an audacious approach.

One wonders if these surprising tactics will be put into use again when the teams meet at St Lucia today.

Pistorious guilty of culpable homicide

Sentence hearing to start Oct 13

Oscar Pistorius was on Friday found guilty of culpable homicide and faced a potential lengthy jail term for shooting dead his glamorous girlfriend, in a case that

shattered the Paralympian hero's glittering career.

Pistorius was acquitted of a more serious charge of murder, but South African Judge Thokozile Masipa said on Friday that he had acted "negligently" in killing the blonde law graduate, named as one of the world's 100 sexiest women.

The judge agreed to release Pistorius on bail pending sentencing beginning on October 13.

His trial heard that in the early hours of Valentine's Day 2013 Pistorius fired four hollow point rounds into a locked toilet door, causing Steenkamp's head to "explode" and "amputating" her arm.

Dismissing swathes of state evidence as inconclusive or irrelevant, Masipa ruled that on the charge of murder "the accused is found not guilty and is discharged, instead he is found guilty of culpable homicide."

"A reasonable person," Masipa said, would have foreseen "that whoever was behind the door might be killed," adding that Pistorius did not take steps which I activated and gave a list of bowlers to avoid that.

Prosecuting authority 'disappointed' with verdict

With no mandatory sentence for culpable homicide, Masipa -- known for handing out stiff sentences -- will have a great deal of discretion over the punishment, which could range from a fine to more than a decade in jail.

"It all comes down to how she feels, how bad the mistake was," said Johannesburg lawyer David Dadic. "It's a very serious negligence crime." Speaking after the verdict,

Pistorius's uncle Arnold said the damage done to the athlete as a result of the trial had been "tragic." But crime-weary South Africans and

legal experts voiced anger and surprise that Pistorius was found not guilty of murder. "Everyone is a little surprised," said

lawyer Audrey Berndt.

Wits University criminal law professor James Grant said the state could appeal if they believe there has been a legal error.

The National Prosecuting Authority, said it was "disappointed" with the verdict, but had not yet decided on whether to appeal. Outside the court Trevor, a 52-year-

old pastor from Pretoria, expressed disgust at the verdict, and a sense that justice favours the rich. "If he didn't have money he would

be in jail," he said. "Real men don't do ₽ that."

Masipa -- whose career has taken her from a childhood in a poor Johannesburg township to the country's high court -- had described Pistorius as a "very poor witness" who was "evasive" when questioned.

The judge however found Pistorius guilty on just one of three gun charges that were also levelled against him.

Masipa said Pistorius was guilty of negligently handling a gun in a busy

Johannesburg restaurant. While Pistorius was having lunch with friends, he asked to see a friend's gun. While handling it under the table

the firearm went off, injuring a boxer Kevin Lerena.

Prosecution 'disappointed'

South Africa's state prosecutors said they were "disappointed" by Oscar Pistorius's acquittal on murder charges, but will wait before deciding whether to appeal the decision.

"We respect the court's decision to convict the accused on culpable homicide, which is in fact a serious crime," said National Prosecution Authority (NPA) spokesperson Nathi Mncube.

"We are however, disappointed that we were not successful in securing a conviction on the original charge of premeditated murder, negligent discharge of a firearm and possession of ammunition," he said in a statement.

Cairns to fight perjury charge

New Zealand cricketing great Chris Cairns vowed Friday he would clear his name shortly before British prosecutors confirmed they would charge him with perjury over

match-fixing allegations.

Former all-rounder Cairns has acknowledged previously that he is under investigation by British authorities for alleged fixing, but vehemently denied any wrong-doing.

The 44-year-old confirmed prosecutors had told him they intend to charge him with perjury and he would travel to Britain later this month to prove his innocence, New Zealand media reported.

"I'm obviously extremely disappointed, however, at least there will now be an opportunity to face my accusers in an open forum, with some rigour and proper process around that, so that I can clear my name

once and for all," he said in a statement cited by Fairfax Media and TVNZ.

Later Friday, the Crown Prosecution Service confirmed Cairns would face one count of perjury in relation to a libel action he brought two years ago.

"We can confirm that we have authorised police to charge Chris Cairns with one count of perjury, which arises from a libel trial held in the UK in March 2012," a CPS spokeswoman said.

In 2012, Cairns won 90,000 pounds (146,000 dollars) in a libel action against former Indian Premier League chairman Lalit Modi in London over a tweet alleging he was involved in match-fixing while playing for the Chandigarh Lions in the now disbanded Indian Cricket League.

The CPS have also charged London-based lawyer Andrew Fitch-Holland, a friend of Cairns who appeared as a witness at the libel trial, with one count of perverting the course of justice.

Zahid to replace Meshu

Winger Zahid Hossain is getting back to the national fold, after a break of one year, as he has been called up to the Bangladesh U-23 team for the Asian Games as a replacement for defender Atiqur Rahman Meshu, who returned home last night after being ruled out with an ankle injury.

The talented winger, who was out of national reckoning since the SAFF Championship in September 2013, is expected to fly within a couple of days for Incheon, South Korea.

"The coaches' first

choice replacement for Meshu, Mithun Chowdhury, will not be eligible to take part as he was not in the initial list of 30. So, according to the coaches' decision, we are arranging to send Zahid Hossain instead," confirmed BFF general secretary Abu Nayeem Shohag. "However, it will take a few days to get the procedure completed and he is likely to miss the first match on September 15 (against Afghanistan)."
