Injured supporter of Haji Selim dies after attack by "Mostafa Jalal's men"

A supporter of independent lawmaker Haji Mohammad Selim, who was injured along with two others in an attack allegedly by the people loyal to former Awami League lawmaker Mostafa Jalal Mohiuddin in the capital's Azimpur, died yesterday. Shahbuddin Shabu, 35, a TV cable service provider, died at Dhaka Medical College Hospital around 7:00am. On Friday, the incident took place over "controlling a kitchen market" on the footpath in Chhapra Mosque area around noon, said police. Mostafa denied the allegations.

Boy stabbed to death in capital

Unidentified miscreants last night stabbed a boy to death before his aunt's house at the capital's Mirpur-6. Emon Sarker, 14, son of Nazrul Islam Sarker of the area, was a class VII student of Mirpur Adarsha High School. Nurul Afsar, sub-inspector of Mirpur Police Station, told the Daily Star that Emon came under the attack when he went to buy cookies from a shop there. He was declared dead at Dhaka Medical College Hospital.

Subhan took part in Pabna massacres

Freedom fighter testifies at war crimes tribunal

Jamaat-e-Islami leader Abdus Subhan had planned and participated in the massacres carried out in several villages of Pabna on May 12, 1971, a freedom fighter testified yesterday, apparently corroborating the versions of several other prosecution witnesses.

SK Shahidullah, a resident of Nishchintapur village in the district's Sujanagar upazila, said he had seen the Pakistani army carry out atrocities and learnt about Subhan's involvement from locals and his elder brother, who was shot but survived on that fateful day. The 29th prosecution witness in

Subhan's case told the International Crimes Tribunal-2 that the Pabna Peace Committee, an anti-liberation platform, was formed in the first week of May 1971 with a Pakistani army captain, Jayedi, as its chairman and Subhan as secretary.

Earlier, several prosecution witnesses linked Subhan, then ameer of Pabna Jamaat, to the mass killings in the villages that left 170 to 175 people dead on May 12, 1971.

Subhan, a Jamaat naye-e-ameer, faces nine charges of crimes including genocide in Pabna. The accused, in his 80s, however, pleads not guilty in court.

He had been threatened with death

Father testifies in court

Seven months before his death, Himu was threatened with death by Tipu and Shaju for trying to stop Shaju from taking drugs in the locality, stated Himu's father before a Chittagong court yesterday.

A general diary was filed with Panchlaish Police Station in this connection on October 20, 2011, Prabir Majumder added while testifying before Judge Reza Tareque Ahmed of Chittagong Divisional Speedy Trial Tribunal.

The cross-examination of the ninth prosecution witness began yesterday and the court adjourned it till today, informed court sources.

An A level student of Summerfield School and College in Chittagong city, Himadri Majumder Himu, 18, was beaten up brutally and pushed off the fourth floor of Farhad Mansion in Panchlaish residential area on April 27, 2012.

ATTACK ON PROF MAHBUBULLAH SCBA condemns

The Supreme Court Bar Association yesterday strongly condemned the attack on Prof Mahbubullah, and demanded arrest and exemplary punishment for his attackers.

The association made the demand at a press conference held in its auditorium yesterday.

Mahbubullah, a pro-BNP former teacher of Dhaka University, was attacked on Saturday while he was leaving the SCBA premises after attending the launching ceremony of a book written by BNP leader Moudud Ahmed.

It is not possible for miscreants to attack Prof Mahbubullah without instigation of the government, said SCBA President Khondker Mahbub Hossain.

"We think Professor Mahbubullah was attacked as he made comments against the government on television talk shows," he said.

It is unfortunate that law enforcers have not taken any effective step to arrest the culprits even though 24 hours have passed since the incident, said the SCBA president.

He said police can identify the culprits though CCTV footage, as such cameras are installed at different points on the SC premises.

names and their parents' names and nothing more, said Bandana Rani Sarker, an assistant teacher at the shelter. The shelter has books and teachers to provide the children with education.

Abandoned babies are given new names at the shelter. One such child is three-year-old Sanjida Akter Mitu. Just a month old, she was abandoned in front of Sudharam Model Police Station in Noakhali in June 2011.

Hasan Masud, deputy superintendent of Chhotomoni Nibas, said they try to find out the addresses of children who somehow became lost.

"But it is difficult to find out about their parents as most of the children do not know their addresses," he said.

GRABBING OF GOVT LAND Court accepts charges against Moudud

A Dhaka court yesterday accepted the charges against BNP leader Moudud Ahmed and his brother Monjur Ahmed in a case filed allegedly for grabbing government land worth over Tk 300 crore in Gulshan of Dhaka.

After scrutinizing the case dockets and other relevant documents, the court took cognizance of the charges in the presence of Moudud.

It also issued an arrest warrant against Monjur as he was shown fugitive in the case. The court fixed October 22 for starting hearing on charge framing.

After an investigation that started during the period of caretaker government in 2008, Harun-ur-Rashid, deputy director of the Anti-Corruption Commission, lodged the case with Gulshan Police Station on December 17 last year.

Moudud and his brother grabbed the land, stretching over around one bigha and 13 katha, between 1978 and 2006, says

In the inaugural session, Saiful Alan, director (technical) of Warpo, presented the current status of the country's water resources highlighting trans-boundary river flows, groundwater depletion, and pollution and grabbing of the rivers around Dhaka city. Warpo has been conducting the water

resources assessment in association with IWM and some international experts. The study is financed by the World Bank under the Water Management Improvement Project.

The overall assessment of surface water includes both quantities and qualities in time and space with reasonable accuracy as required for updating the National Water Management Plan (NWMP). The Bangladesh Water Act 2013 made it mandatory to formulate the NWMP.
