already opposed the inclusion of alleged "illegal immigration" issue in the JCC agenda and it may not come up for discussion.

The Indian side will put maximum emphasis on security issues and some other issues including exemption of travel tax for Indian citizens.

The latest controversy of funding Jamaat-e-Islami of Bangladesh by the Trinamool Congress and Saradha may come up for discussion, said a senior official at the foreign ministry.

But he said the official spokesperson of India Syed Akbaruddin at a press briefing on September 12 in New Delhi confirmed that the government had not received any report of the sort that was mentioned in news reports.

Ali is expected to elicit Indian leadership's views on the progress made towards reaching a national consensus on the Teesta water-sharing, said the source.

Meanwhile, a constitution amendment bill to ratify the LBA is awaiting Indian parliament's approval. The bill was placed in the Rajya Sabha, upper house of parliament, during Congress-led UPA rule last year, but is yet to be

The bill has already been referred to parliamentary standing committee.

After Rajya Sabha clears the bill, it will go to the Lok Sabha, the lower house of parliament whose members are directly elected by people. The next session of parliament is due in December.

The issues of extradition of ULFA leader Anup Chetia from Bangladesh and Bangladeshi convicts Subrata Bain and Sajjad Hossain from India could also be discussed at the JCC meeting, said

Indian Bangla daily Anandabazar Patrika on Friday said crores of money from Saradha chit fund was invested to spark violence in Bangladesh. Citing "intelligence reports of Bangladesh", the newspaper said the money made its way to Jamaat-e-Islami in 2012-13 through Ahmed Hassan Imran, a Rajya Sabha member from West Bengal's ruling TMC.

In a new development, Babul Supriyo, a BJP MP from Asansol, on Sunday alleged that the charges against Imran playing a leading role in receiving funds from Bangladeshbased political party Jamaat-e-Islami to help TMC win the 2011 Assembly polls, were "not merely allegations, but are facts", according to a report published yesterday in leading Indian daily Hindustan Times.

The report also says all opposition parties in West Bengal -- the Left, BJP and the Congress-- upped the demand for West Bengal Chief Minister Mamata Banerjee's resignation over the Saradha chit fund scam.

The CPI(M) demanded that the Central Bureau of Investigation (CBI) should interrogate Mamata and Union Finance Minister Arun Jaitley in connection with the scams, claims the report.

Suryakanta Mishra, leader of the opposition in the Bengal assembly and CPI(M) politburo member, also passed the blame on the BJP for the chit fund scams, alleging that Jaitley's tough stand on the scams in his first budget speech as finance minister stood in stark contrast with his decision to "have lunch on the same day with Trinamool Rajya Sabha MP KD Singh".

UN troops withdraw from Syrian Golan

AFP, Golan Heights

Hundreds of UN troops withdrew from the Syrian to the Israelioccupied sector of the Golan yesterday, an AFP correspondent said, two weeks after Al-Qaedalinked rebels kidnapped dozens of the peacekeepers.

They crossed in a UN convoy in the afternoon into the Israeli-occupied sector, the correspondent said. There was no confirmation from

the United Nations Disengagement Observer Force (UNDOF), which monitors a 1974 ceasefire between Israel and Syria on the Golan Heights.

In late August, rebels on the Syrian side including Al-Qaeda affiliate Al-Nusra Front seized the Quneitra crossing and kidnapped more than 40 Fijian UNDOF troops, before they were released two weeks later.

They also clashed with 75 Filipino members of the force, who eventually fled a nearby outpost.

Rebels including Al-Nusra have now taken control of most of the Syrian side of the Golan Heights from forces loyal to Syrian President Bashar al-Assad, a Britain-based Syria monitoring group said on Saturday.

The fighting has driven thousands of Syrian families in the area from their homes, the Red Cross said.

"Clashes between government forces and the armed opposition have intensified in recent days in Quneitra governorate -- in Quneitra city in particular, where access to clean water, food, and health care is limited," the International Committee of the Red Cross said in a statement.

The ICRC said it has provided emergency relief for more than 50,000 people, but warned the number of displaced people was "expected to grow."

The post of the chief executive of BASIC Bank fell vacant in May this year after the central bank fired Kazi Faqurul Islam for presiding over a period of serious irregularities at the state-run scheduled bank that cost the taxpayers Tk 4,500 crore in the last four

In another development, the government has decided to appoint a retired judge to oversee the election of nine women directors of the Grameen Bank board. The finance ministry has taken opinion

from the law ministry on the issue, said another official.

The ministry has also decided to extend the time for holding the election of the nine

directors by a year, as the deadline for holding the polls expires in the first week of October.

The Grameen Bank (Election of Directors) Rules 2014 will soon be amended to this effect, said the second official.

The rules were introduced in April to transfer the power of appointing members of Grameen Bank board from the microcredit organisation itself to the central bank, a move that brought the micro-lender in the grip of the government.

The new rules gave six months to the central bank to form a commission to elect the nine directors of the 12-member board.

Paleontologists discovered the massive fossil during fieldwork in the Rukwa Rift Basin in southwestern Tanzania.

Political instability in certain parts of Africa can prevent dinosaur digs, but fossils in this part of the world are also elusive for geological reasons. As the continents drifted apart, Africa did not move as much as the other continents did, leaving its fossils buried instead of pushed up by plate tectonics, said Patrick O'Connor, a professor of anatomy at Ohio University in Athens, Ohio, and one of the researchers on the new study.

Africa also had fewer ideal areas where sediment could quickly bury a creature and begin the fossilization process. Politics and geology, "those two things together account for why we don't know so much about continental Africa as we do about other parts of the world," O'Connor said.

Joseph Sertich, then a graduate student at Stony Brook University in Long Island, New York, and now a paleontologist at the Denver Museum of Nature & Science, was the first to spot the bones in the Rukwa Rift Basin.

"He scrambled into a gully and found the skeleton coming out [of] the cliff surface," O'Connor said.

A careful excavation by local coal miners and paleontologists in 2007 and 2008 suggests that muddy elements had buried the dinosaur's remains - not once, but twice, O'Connor told Live Science. About 100 million years ago, the dinosaur likely died on a muddy floodplain. Mudstone eventually covered its body, but shortly after, a river running through the plain cut away at the mudstone, exposing part of the skeleton and encasing it in sandstone.

A river still runs near the site, and its drainage through the cliff face had begun to uncover the ancient skeleton, O'Connor

lot of specimens," Gorscak said. Titanosaurian remains are found on every continent including Antarctica, but "the early evolutionary history outside of South America is fuzzy." The new finding helps bridge that gap, said Matthew Lamanna, a curator of verte-

brate paleontology at the Carnegie Museum of Natural History in Pittsburgh, who was not involved with the study. Rukwatitan is important because it's

"one of the very few Cretaceous-aged dinosaurs known from Africa south of the Sahara Desert," Lamanna told Live Science in an email. "That part of the world is one of the biggest 'black holes' in our understanding of dinosaurs," he said.

Previously, paleontologists found thetitanosaurian Malawisaurus dixeyi in Malawi, but the Rukwatitan fossils are markedly different in shape and size from that specimen and other titanosaurians found in northern Africa, O'Connor said.
