SUBHAN'S TRIAL

Recording of IO's deposition suspended

The International Crimes Tribunal-2 yesterday suddenly stopped recording testimony of an investigation officer in the case against Jamaat-e-Islam leader Abdus Subhan and decided not to consider his 38-minute deposition as evidence.

The tribunal took the decision as it was revealed that IO Noor Hossain had investigated last part and Motiur Rahman first part of the case.

The three-member tribunal headed by Justice Obaidul Hassan with members Justice Md Mozibur Rahman Miah and Justice Md Shahinur Islam expressed discontent over the prosecution for bringing Noor first for deposition instead of Motiur Rahman.

The court also directed the prosecution to bring Motiur today for testimony and said it would take Noor's testimony later.

Yesterday was fixed for recording testimony of the investigation officer and Noor started testifying at 11:12am. At one point, he appeared to have investigated only the last part of the case.

"You should have brought the first IO [investigation officer] first," said Justice Hassan, while Justice Shahinur Islam asked: "Why did you bring the second IO first instead of the first IO?



Yet the business kept flourishing. About a hundred factories in Hazaribagh now produce feed daily out of some 75 to 200 tonnes of solid waste that includes salt, bone, leather shavings and trimmings.

Though the Rapid Action Battalion or the Department of Environment conducted one or two drives, things have hardly changed. The Department of Livestock

Services and the Department of Fisheries are entrusted with maintaining quality of animal feed. But they did not take effective steps. "I was not aware of the use of tan-

nery waste in fish feed until recently,"

fisheries department Director

General Syed Arif Azad said, following a report in The Daily Star mid-July this year. He, however, said that in the last six months, the department tested over 1,200 fish feed samples from

across the country and found short-

age of protein in some samples. The department warned the manufacturers but lodged no criminal cases. All it did was getting the manufacturers to apologise and pledge

The department also did not test heavy metals in the feed. However, Arif said they would do this now as the reports of animal feed being mixed with tannery-based protein are coming out.

BUS TRIPS BEFORE EID

Operators hike ticket prices

Like the previous years, many private bus operators have started to charge higher fare from the passengers ahead of the upcoming Eid-ul-Azha and Durga Puja compared to the usual time.

This correspondent visited different bus terminals in the capital yesterday where many passengers alleged they had to pay Tk 50 to Tk 70 more than the standard ticket price. "Usually, it costs TK 420 to go to

Bogra from Dhaka but now they are charging Tk 470," said Saidur Rahman, who bought the ticket for October 1 from the Mazar Road counter of Shyamoli Paribahan. Sujan Mandal, another passenger

who wanted to travel to Rajshahi on

the same day, said Hanif Paribahan charged him Tk 620 for a Tk 550 ticket. He bought the ticket from the Gabtoli counter.

"It has become a common trend of the bus operators to charge extra ahead of the Eid and we have become accustomed to this nuisance," said Jubayer Rahman, a ticket-seeker, at the SR Paribahan's Kallyanpur counter. In response to the allegations, the

bus operators yesterday said they were charging the passengers as per the government directions. "Throughout the year, we charge less than the fare set by the govern-

ment. But during the Eid, we charge as per the government rate. Because of this, the fare increases slightly," said Romesh Chandra Ghosh, managing SEE PAGE 11 COL 5

empowered parliament with the authority to remove a SC judge. But the fourth amendment to the constitution in January 1975 abolished the Jatiya Sangsad's power and empowered the president with the

Then military ruler Gen Ziaur Kazi Firoz Rashid of the JP and Fazle Rahman had introduced the SJC by amending the constitution through a martial law order which was ratified by the fifth amendment to the constitution in 1979.

> The High Court in 2005 had declared the fifth amendment illegal and void. The Appellate Division of the Supreme Court in 2010 upheld the HC verdict, but condoned the introduction of the SJC until December

> The AL-led government however introduced afresh the SJC through the 15th amendment to the charter in 2011. The government's move to

> empower parliament to remove SC judges has drawn huge criticism from different quarters. Many jurists and opposition political parties feared that the latest amendment to the constitution will appear as a threat to an "independent" judiciary. In efforts to get the bill passed unan-

> imously in parliament, Prime Minister Sheikh Hasina has already met lawmakers of Workers Party, Jatiya Samajtantrik Dal, and Bangladesh Tarikat Federation seeking their support in this regard.

> The main opposition Jatiya Party has already announced that it will support the bill.

> The ruling Awai League however commands more than three-fourth majority in the House which is more than enough to pass the bill.

This is the second time the apex court is delivering a verdict in a war crimes case.

On September 17 last year, the SC handed down death penalty to another Jamaat leader, Abdul Quader Mollah, for committing crimes against humanity during the 1971 Liberation War. Mollah was executed on

December 12 last year. On conclusion of the hearing that went on for 50 days, the SC on April 16 said it would deliver its verdict on the appeals any day.

The International Crimes Tribunal-1 on February 28 last year sentenced Sayedee to death for killing Ibrahim Kutti and Bisa Bali in Pirojpur in 1971. It found the Jamaat leader guilty on eight criminal charges.

On March 28 last year, Sayedee filed an appeal with the SC, seeking acquittal on all charges. The same day, the government lodged a separate appeal seeking Sayedee's punishment on the eight charges.

Both the state and the defence counsels yesterday expressed optimism that the apex court's verdict would go in their favour.

Attorney General Mahbubey Alam was hopeful that the SC would uphold the verdict of the ICT-1, as Sayedee was directly involved in the killing of Bisa Bali and Ibrahim Kutti in 1971. "I have prayed to the Supreme Court looting and setting fire to houses of
