The provost was also responsible for the dilapidated state of the roads on the premises, absence of street lights and an underdeveloped reading room, he added.

However, several hall residents, requesting anonymity, informed that the BCL men were harassing the provost as he did not entertain their demand to appoint people they recommended as hall staff.

Moreover, the BCL leaders had tried and failed to extort from the provost a portion of the money allocated for renovation of a hall building and were annoyed for not having been consulted over the purchase of chairs for the reading room, they added.

The president denied the aforementioned allegations. Prof Amzad Ali said they suspended the gate-keeper.

Blame game bars preservation

Ataur quoted Shakil as saying, "Nobody can vacate this building; if anyone even tries, I will teach them a good lesson."

Samir Chandra Saha, a member of the executive committee of Bihari Lal Geo Temple on BK Das road, said, "If the authorities concerned follow the SC order, the owners will never dare to build high-rises on their land."

"Why the heritage site will have to struggle for its existence while the constitution of Bangladesh and the Antiquities Act 1968 both state that the government should take necessary steps to preserve any urban site, street, group of buildings or public-squares with special historical or artistic values?" asked Taimur. However, the act did not mention any clear direction about the protection process.

If necessary measures are not taken immediately to protect Baro Bari, it may be knocked down anytime like Kalachand Temple, an endowed property enlisted in the 2009 heritage sites' list, in Shankhari Bazar, said Taimur, adding that the locals have witnessed demolishing of over 50 structures of Mughal and British era in the last seven months.

Contacted, AZM Shafiu Hannan, authorised officer, zone 7, Rajuk, which is also liable to protect the site, said the four-storey temple was demolished after getting a clearance certificate from the UDC.

"Moreover, the vulnerable condition of the century-old building compelled us to bulldoze this," he added.

The blame runs in a cycle when Dr Ataur of DoA said, "Clearance from UDC was not enough to demolish the temple which could easily be renovated. Moreover, the DoA was not even informed before about demolishing the building."

About Ataur's claim, Shafiu of Rajuk said they demolished it as a similar building will be constructed at that place.

But the locals and the priest, Bijay Bhattachariya, who was forced out of the temple amid threats from the leader, claimed that the temple was knocked down in July to meet the ill motive of a developer company blessed by a local leader of pro-AL Swechchashebak League.

Taimur also mentioned that just a day before last Eid, a portion of Old Dhaka's Bhawal Raja's residence was demolished taking the advantage of Eid holidays.

The historic residence could have been turned into a beautiful heritage site.

Another building with heritage status, holding no 13/14, in Rupchand lane was demolished in August, he added.

If the list was updated soon after the SC order, many historic structures, including Baro Bari and Bhawal Raja's residence, would have definitely been declared protected archaeological sites, said Taimur, adding that everyone is taking advantage of negligence of the authorities concerned for own benefits.

Enough is enough, now the government should take clear stance to protect the century-old buildings with heritage status and restore those, stressed the architect.

Road crashes kill 7, injure 6

Pickup crashes into grocery shop leaving 4 dead in Tangail

Seven people were killed and six others injured in road accidents in Dhaka, Tangail, Rangpur, and Dinajpur on Saturday and yesterday.

Staff correspondent reports, motorcyclist Yunus, 38, was killed instantly when a bus ran him over on the capital's Shyamoli intersection yesterday afternoon, said Sher-e-Bangla Nagar police.

Our Tangail correspondent reports, four people were killed and four others were injured when a pickup and a covered van collided head-on and later the former crashed into a grocery shop beside Dhaka-Tangail highway at Jamurki in Mirzapur upazila early yesterday.

The deceased were the pickup passengers

Ismail Hossain, 60, Abdur Rashid, 65, Shohel Miah, 30, and the shopkeeper Lebu Miah, 40.

The injured--the pickup driver and three bystanders--were undergoing treatment at Tangail Medical College Hospital where the other four succumbed to their injuries, said highway police.

Our Rangpur correspondent reports Nahid, 4, was killed and his parents Md Kibria and Sharmin Begum were injured as a truck hit their motorcycle on Rangpur-Kurigram highway in Kaunia upazila on Saturday evening.

Our Dinajpur correspondent adds, bicyclist Md Sirajul Islam, 25, was killed after a truck hit him in Birganj upazila of Dinajpur yesterday.

"Billah also tried to forcibly take me to his room at gunpoint. But on duty police of the hall rescued me...Billah ordered me to leave the hall in 24 hours," added Hatem.

Mustakim tried to justify his actions by making an irrelevant connection, stating that he had "only threatened Hatem" for being a "mole of Shibir".

Prof Zahid said he had informed Proctor Prof Tarikul Hasan of the matter.

Both the proctor and Vice Chancellor Prof Muhammad Mizanuddin have several times in the past, including yesterday, stated that they had verbally informed police of the matter.

Probe committees earlier "could not find

any evidence" against the third year student of political science, said the VC yesterday.

Newspapers had run photos showing Mustakim brandishing firearms during the February 2 violence on agitating students who were demonstrating against a fee hike and evening master's course.

Witnesses say that on May 13, because one BCL leader was "ill", Mustakim, alongside other BCL men, forced the Islamic history and culture department to postpone an examination by locking and vandalising the exam hall, threatening teachers at gunpoint and hurling abuses at them.

Alamgir Hossain, officer-in-charge in Motihar Police Station, rhetorically said they would "take stern action after investigations".
