# Hundreds of aman farmers suffer due to water-logging

Farmers have failed to cultivate aman on around 500 hectares of land in Mirukhali union of Mathbaria upazila under the district this season as they could not cut an earthen embankment to release stagnant water allegedly due to interference by local influential person.

Four years ago, local farmers made an embankment on Bhuter Khal (canal) at Badura village in Mathbaria upazila to save their ripe aman paddy from

tidal water. At the beginning of aman seedling cultivation this year, they wanted to cut open the embankment to let stagnant water flow down from their fields.

But Abul Kalam Sharif, principal of Begum Sheikh Fazilatunnesa Fazil Madrasa, prevented the act, saying that his institution, situated near the canal, will be affected if the embankment is removed.

He has also arranged planting some betel nut and wood producing trees there, apparently to make the embankment permanent, locals said.

"This year I could not cultivate my four bighas of aman land as it remained flooded and I could not grow any seedlings," said Soula village.



#### 2 footbridges, a weighbridge to open on Bogra highway

Two footbridges and a weighbridge on Panchagarh-Dhaka highway via Bogra are going to be opened soon for public and vehicles as their construction has been completed.

The bridges and weight control points were set up at a cost of Tk 3.81 crore, said sources at Roads and Highways Department

(RHD) office in Bogra. Of the bridges, one has been built at Gokul on Rangpur-Dhaka highway in Sadar upazila while the other at Majhira "B' block near Bogra Majhira Cantonment on Bogra-

Dhaka highway in Shajahanpur upazila. Meanwhile, the weighbridge has been installed in Gokul area on Rangpur-Dhaka

RHD officials said the weighbridge will help check and control the loads by the heavy vehicles which will protect the high-

way from early and repeated damages. The footbridges were constructed to facilitate the movement of pedestrians and reduce the risk of accident as heavy vehicles from 10 districts of the northern zone of the country ply the highway everyday, said executive engineer of Bogra RHD Jahangir

A student of TMSS Medical College, Nibir Wares, said due to the footbridge, they can now easily go to the hospital from the college without the risk of any accident.

Earlier, a footbridge was built on the west side of Bogra Railway Station during the tenure of President H.M Ershad.



KILLING OF 4 COPS Charges pressed against 234,

Police have pressed charges agasint 234 people, including former Jamaat lawmaker of Gaibandha-1 constituency Moulna Abdul Aziz, in a case filed for killing four policemen during the violence of Jamaat-Shibir over the verdict of Delwer Hossain Sayeedi.

Mozammel Huq, officer in-charge of Sunderganj police station, yesterday said he submitted the charge sheet before the Senior Judicial Magistrate Court in the district on September 17 but it remained undisclosed in fear of further violence. On February 28 last year,

as soon as the International Crimes Tribunal (ICT) awarded death penalty to Sayeedi, Jamaat-Shibir men locked in violence at Bamondanga rail station.

They carried out arson attack at the rail station and set fire to a police outpost where they beat four policemen dead and injured four others.

The deceased are Tozammel Huq of Rahamat char village in Rangpur district, Hazarat Ali of Kishamat Godhra village in Kurigram, Bablu Mia of Thakurpara village in Bogra and Nazimuddin of Dhanaruha village in Gaibandha.

The then investigation officer Abu Hanif filed a case against 89 identified and 2,500 unidentified people in connection with the killings said the OC.

#### Robbers kill 5-year-old girl

A gang of robbers shot dead a minor girl and injured her grandmother during a robbery at a house in the district's Boalkhali upazila early yesterday.

They also looted Tk 6,000 in cash and around three tolas of gold ornaments from the house at Pathanpara village, said police. The dead, Shamima

Akther Isma, 5, was daughter of Abu Taher. Her grandmother Fatema Begum, 45, has been undergoing treatment at Chittagong Medical College Hospital (CMCH).

Quoting the family, Shoaib Reza, chairman of Charandwip union parishad, said some seven to eight robbers came to the village by a CNG-run autorickshaw and entered the house of Ismail Khan by cutting its steel gate around 2:30am. One of them wielded locally made gun while the rest sharp weapons.

Taking hostage the family members at gunpoint, the robbers broke open the almirah and took away the money and gold ornaments,

he added.

According to the family members, as Shamima began to cry in fear, the robber shot her in the head and in the face, leaving her seriously injured. He also opened fire on her grandmother when she came to save Shamima.

The victims were rushed to CMCH where Shamima died later.

Police seized the autorickshaw in the afternoon.

## Fishermen demand security from robbers in Bay

Human chain in Patuakhali town

Fishermen of Kuakata area formed a human chain in front of the deputy commissioner's office in Patuakhali town yesterday to press for their six-point demand. The demands include

security of fishermen in the Bay, Rehabilitation of the families of 86 fishermen of Patuakhali, Bhola, Barguna and Pirojpur who were killed by robbers in the Bay in the last nine months, and steps to rescue 400 fishermen abducted by the robbers during the period.

Over 100 fishermen immediate steps to rescue joined the programme that continued for an hour from 11:30am. They later submitted a memorandum to the prime minister through the deputy commissioner.

In the memo, the fishermen stated that 11 robber gangs swooped on at least 2,000 fishing trawlers in the January and killed 86 fishermen. The gangs also abducted around 400 fishermen from the Bay for ransom during the period.
