BANGLADESHI'S DEATH IN UK IMMIGRATION DETENTION CENTRE

London protesters demand full enquiry

The friends and family of Rubel Ahmed, a Bangladeshi student who died in immigration custody in the UK two weeks

ago, demonstrated outside the British Home Office in London Tuesday, demanding an independent enquiry into the circumstances surrounding his death. The 26-year-old was picked up

by UK immigration police on July 22 and kept at a Morton Hall detention centre in Lincolnshire. He was found dead on September 9 in mysterious circumstances.

Though the authorities have launched an enquiry, the protesters demanded that the Home Office conduct a full investigation. The demonstration was organised by

Justice for Rubel Campaign, supported by a host of organisations including Movement for Justice, Movement Against Xenophobia, RMT, Bangladesh Human Rights

Commission, Voice for Justice, Students League, Youth Union, Greater Lamakazi Welfare Association, Jalalabad Probashi Kallayan Parishod, Greater Sylhet Development & Welfare Council, and Voice for Change.

After his death, the authorities concerned said Rubel had committed suicide, but his inmates said he was complaining of chest pains on the night

of his death. Rubel had been banging on his cell door asking for help for at least two hours before

anybody came to attend him, said the

GOPIBAGH-6 MURDER Four 'JMB operatives'

Four alleged operatives of Jama'atul Mujahideen Bangladesh (JMB) have been accused of killing six people in the capital's Gopibagh area in December last year.

Besides, a Dhaka court yesterday granted a fourday remand for each of the four -- Syed Ziaul Islam, Al Amin, Golam Sarwar Rahat and Azmir Alias Amit.

They are also accused in three other cases under Anti Terrorism Act 2009, **Explosive Substance Act** and Arms Act with Ramna Police Station.

Inspector Abual Khaier Matubbar of Detective Branch (East) of Police produced the four before the court yesterday and

Wilms' tumour most often occurs in just one kidney, though it can sometimes be found in both kidneys at the same time. This tumour doesn't always cause other signs and symptoms unless advanced. Children with Wilms' tumour may appear apparently healthy, or they may experience:

- · Abdominal flank swelling
- Abdominal pain
- Fever
- Blood in the urine

Factors that may increase the risk of Wilms' tumour include:

- · Being female. Girls are slightly more likely to develop Wilms' tumour than are boys.
- · Having a family history of Wilms' tumour. If someone in a child's family has had Wilms'

tumour, then that child has an increased risk of developing the disease. Raisa's surgery was planned without delay. More than two hours of meticulous surgery was done; after surgery, removed right kidney was sent for microscopic examination. Raisa had an absolutely uneventful recovery. Few things including

histopathological report came out favorable, there were no residual tumour near or far away in the body and the left kidney was found to be absolutely fine. Following surgery, Raisa had a course of chemotherapy & they went back to Rajshahi. Life is as colourful and joyful now for them like before. On her follow up visits with the Paediatric

Raisa was found absolutely okay in all examination and investigation. She is now in class two studying in a Rajshahi school. She still loves rain and loves to shower. Do not ignore any lump or swelling if you observe

Refusing to marry her, Mithu took up a job and started living in Gazipur in February this year. The girl followed him there and they started living together. Police, following complaints by locals, raided their residence on June 2 and got to know from the girl that Mithu had tried to engage her into prostitution, he added. The girl was handed over to her parents

and Mithu was sent to jail with two cases filed against him, one over rape and another over conducting "unsocial activities", said Firoj.

Getting bail on September 14, Mithu, alongside his parents, asked the girl to come over to their residence on Monday to reach an understanding, he added.

When the girl refused to withdraw the case, they chained her up to a tree and a lamppost on their courtyard and tortured her. None of the passers-by and neighbours came to her assistance during the whole ordeal, he said. Police detained and then questioned five neighbours -- Palash Khan, Shipon Haoladar, Md Ripon, Abdul Huq and Delwar Hossain -before releasing them.
