Flash flood disrupts work at Hili port

Schools, colleges suspend classes

Normal life of Hili townspeople in Hakimpur upazila has been disrupted in three days since Monday as rainwater from across the border triggered flash flood in land port and other areas.

Activities at Hili land port remained suspended as the lone road of India and Bangladesh went under waist-deep water.

Besides, water-logging due to heavy rain suspended academic activities at different educational institutions in the land port and its surrounded areas, said UNO Md Azaharul Islam.

The entire area of Hili land port went under water due to incessant rain since Friday, said AK Azad, a resident of Churipotty area in the upazila.

Local people blamed the improper drainage system in Hili for the water-logging. Harun Ur Rashid, con-

vener of Importer Groups of Hili Land Port, said at least 10 warehouses were flooded, causing Tk 1 crore damages to the traders. As the link road between

India and Bangladesh remained under the rainwater since Monday, the traders incurred huge loss, said Abul Kashem, president of the Land Port Clearing and Forwarding Agents Association. Earlier, the port remained

closed for five consecutive days due to hartal and weekend holiday, he added. Our Bogra correspondent

adds: Rainwater and onrush of water from the upstream and hills across the border have triggered flash flood due to sudden swelling of the Jamuna in Dhunat upazila.

The river devoured houses of at least 50 families

in Koiyagari village of Bhandarbari union of Dhunat upazila.

Local farmers said, after the receding of floodwater they had started to cultivate different types of vegetables, spice and gainja aman. But they are now frustrated as their crops again went under water.

Meanwhile the flood situation in Durgapur upazila of Netrokona has started improving while it remained static in Kalmsakanda upazila, reports our correspondent.

Four people drowned in floodwater in Durgapur upazila, locals said.

The dead were identified as Azam Khan, 50, of Korchowki village, Sirajul Islam, 55, of Suknakuri village, 3-month-old Faruk Mia of Garaikandi village and Sabikunnahar, 30, of Maskanda village.

ACTIVITIES IN 'ABANDONED' BUILDING

Shishu Academy puts lives of kids at risk

All the activities of Shishu Academy in the district are being done in a century-old risky building, putting lives of around 500 children under risk.

The authorities have been using the building, formerly knows as Basic Democracy Hall, in the district town for conducting different programmes of children, following permission from the district administration in 2004.

Surprisingly, they ignored the matter that the Public Works Department in 2000 identified the building as risky and local municipality declared it 'permanently abandoned'.

Shishu Academy authorities started using it to run pre-schooling and other programmes like singing, recitation, drama, dance, drawing etc for around 500 children.

Visiting the building on Monday (22 September), this correspondent saw rainwater trickle down the roof, making the entire building damp.

Plaster of most part of the roof has already fallen, exposing rusty iron rods. Chunks of concrete and cement often fall off the roof, causing injuries to children,

said several guardians.

"We remain worried during class hours, as particles of sand, cement, and iron rods, even chunks of concrete fall off," said Razia Sultana, teacher of pre-schooling centre.

Several little kids including Abrar, Swarna and Orchi told this correspondent that they feel afraid while attending classes

"I wait amid anxiety outside the Shishu Academy building when my grandson attends classes there," said Laily Begum, a guardian.

Mostaque Ahmed, district children's affair officer, said, "It is true that we are conducting children's activities in the risky building. We sent a project proposal to the department concerned of the government much earlier, seeking fund allocation for construction of a new Shishu Academy complex. We hope to get it soon."

Ahsan Rahim Manzil, a member of Shishu Academy managing committee, said, "The district administration allotted a 55-decimal plot in the existing place and we are waiting for allocation of fund from the government for starting construction of the complex."

2 siblings held over murder

Members of Rapid Action Battalion (Rab) arrested two siblings in Mazampur gate area of the district town on Tuesday night on charge of killing a college boy. The arrestees are Tushar Ahmed, 18, and his elder brother Nishan Ahmed, sons of Farid Karim, an industrialist of Aruapara area in the town, said Ali Haider, commander of Rab-12. The deceased is Ashlamul Haq Zelin, 17, son of Mahbubul Haq of the area and a second-year student at Kushtia Government College. Tushar, a friend of Zelin, allegedly stabbed him when he was gossiping with four friends at Babur Ali Gate in the town around 3:30pm on Tuesday. Zelin was rushed to Kushtia Medical College campus where he died around 4:30pm, said police.

PDB engr's office besieged

Residents of Dhanharia and Udoypur villages yesterday laid a siege to the office of Power Development Board (PDB) Chief Engineer in the town and ransacked the office demanding uninterrupted power supply. Anwar Hossain, sub-inspector of Sadar Police Station, said around 11:00am, agitated locals from the two villages surrounded the PDB office first and later began to vandalise the computers, chairs, tables and other furniture of the office. Locals alleged that frequent power outage and low voltage have virtually paralysed life in the two villages. Students and elderly people are the worst sufferers as power goes frequently, they said.

5 'Allar Dal' men arrested

Police arrested five activists of banned Islamist outfit 'Allar Dal' from a mess inChandpur area under Phultala Police Station on Tuesday night. The arrestees are Parvez Hossain, 26, Abdur Rahim, 28, Md Selim, 23, and Ali Hossain of Jessore and Biswajit Devnath alias Mahin Ahmed, 27, of Satkhira districts. The law enforcers also seized leaflets, four crude bombs, bomb making materials and a diary containing guidelines to implement the organisation's ideals from the arrestees.

Mobile court drive resisted

Police said a special mobile court, led by magistrate Saifur Rahman along with four other executive magistrates, went to conduct a drive against smuggled Indian goods and low quality, sub-standard products at Goshala Road in Railway Bazar of Uttaron Super Market and Goshala Bazar. As the mobile court started conducting drive, the traders agitated, protesting the drive. Later, the mobile court returned without doing its job in face of the protest.

Padma about to devour two Pabna schools

'Permanent' protection work demanded

The Padma is about to devour Arambaria High School and Arambaria Primary School at Arambaria village in Shara union of Ishwardi upazila under the district, much to the worry of students, teachers and guardians. "A two-storied classroom

building of Arambaria High School went into the bed of the Padma two years ago and the science room and the Shaheed Minar borrowed the same fate last year. Major portion of school ground was eroded during the last few weeks," said Ranajit Kumar Bishwas,

headmaster of the school.

"The river, now only three metres away from the lone two-storied building of my school, also threatens the primary school located on the same ground," he

"We are attending classes amid fear as the river has come close to the school building," Koushik Kumar Roy, a student of Class X.

Jerjis Hossain, chairman of Shara union parishad, said the mighty river devoured more than 300 dwelling houses and 500 acres of cultivable land in Arambaria village within two years. Ten dwelling houses and 50 acres of land Pabna.

A permanent protection work is essential to save the two schools as well as the village, he said.



Charges pressed against 3,500

Charges were pressed against 3,500 Jamaat-Shibir and BNP men in the cases for carrying out destructive activities in the district during national elections on January 5 and the day before.

Rly demolishes illegal structures

The authorities of railway west zone yesterday demolished around 500 illegal shops and establishments built on railway land in eight northern districts.

The illegal structures, owned by general people were demolished but those owned by political leaders and their musclemen remained untouched due to unknown reason, locals alleged.

Railway officials said, around 9,700 illegal structures have been marked for demolition in eight districts--Lalmonirhat, Rangpur, Kurigram, Gaibandha, Bogra, Dinajpur, Thakurgaon and Panchagarh under the railway division.

Earlier, the owners of these illegal structures were served notices for one month.

town, said he had been running a small business in a tinshed shop on railway land.

"Our structures were demolished yesterday but the eviction team did not touch a single brick of structures owned by political leaders and musclemen in the town," he said.

"A large number of illegal structures on railway land are owned by identified political leaders but the railway authorities are not demolishing these," said fruit trader Nuru Mia at the railway gate.

Lalmonirhat Railway Divisional Estate Officer (DEO) Ashish Kumar Chakrabarty said that the eviction drive would continue and the railway authorities will free all the railway lands.
