Sramik League office on school ground

Surprisingly though, an office of pro-ruling party Sramik League runs on the ground of 'Free Amin Government Primary School' at Rasulpur in Saidpur municipality under the district.

Set up on a railway land in 1952, the school was nationalised in 1973.

Around 300 kids read at the school where nine teachers are serving now.

A couple of years ago, local leaders of Railway Sramik League (open line) constructed an office building on the school ground, informed locals.

The school achieves almost 100% pass rate in primary school certificate (PSC) examinations and usually does well in inter primary school games and sports competition in upazila and district levels, school sources said.

The education directorate in 2007 arranged for the school a new three-storied spacious building.

But school children hardly get any opportunity to play in leisure periods or after classes as the field has become too narrow and many people gather due to various programmes at the party

44 held while crossing

Members of Border Guard Bangladesh (BGB) arrested 36 people while they were illegally entering Bangladesh from India through Putkhali border under Benapole Police station on Sunday night.

The border guards later arrested eight others while they were going to India without valid documents through the border point the same night.

Shamsur Rahman, incharge of 23 BGB Battalion camp in Putkhali, said a BGB patrol team, acting on a tip-off, raided the border point at around 9:00pm and arrested 36 people, including 16 women and eight children, while they were entering Bangladesh.

Later, the BGB personnel arrested five men and three women while they were going to India through the border point illegally.

All the arrestees hail from different areas of Gopalganj, Khulna, and Narail districts, BGB sources said, adding that the human traffickers fled the scene, sensing the presence of BGB team.

Apurbo Hasan, officerin-charge of Benapole Port Police Station, said the arrestees were handed over to Benapole Port Police Station yesterday morning.

Three women brutally tortured at jeweller's

Employees of a jewellery shop in the town beat up three women, cut off their hair and kept them detained for four hours on suspicion of stealing gold ornaments yesterday, sources said.

The three women wearing yashmaks came to Faruk Jeweller's at Chawkbazar in Dinajpur town, to buy gold ornaments at around 11:00am yesterday, said witnesses.

Md Nixon, manager of the shop, was helping them to see required items.

Around 20 minutes later, locals heard a chaos as the shop employees downed the shutters and closed the collapsible gate and started beating the three women

mercilessly, accusing them of stealing a gold chain.

Locals said Md Munna, his brother Md Razu, and Md Rana -- all employees of Faruk Jeweller's, beat up the women, cut off their hair with scissors and kept them confined to the shops.

The cut hair was thrown outside the shops.

Visiting the spot around 1:40pm, this correspondent found a large number of people thronging there while hair was lying in the street and in front of the shops that were kept locked from outside.


Md Razu said, "The three women's hair was cut off as they stole a gold chain."

Two drown, 13 hurt as 2 boats capsize

Two women drowned and at least 13 others were injured when two passenger boats capsized in Rasulpur beel (water body) and Titas River in Nabinagar upazila at the same time on Sunday evening.

The deceased are Kohinoor Begum, 36, wife of Abdul Bari, and Begum Akhter, 40, wife of Phul Mia of Kurighar village in the capsize. upazila.

Local sources said two engine driven boats, each carrying 50 to 55 passengers, were heading towards Kurighar village and Nabinagar upazila headquarters from Gukarna Ghat in Sadar upazila on Sunday afternoon.

As the Kurighar-bound boat reach the middle of the water body around 5:30pm, it overturned due to strong current and sank. Two women went missing and at least 10 others were injured in the incident.

At the same time, the other boat, which was heading for Nabinagar sank in Titas River duo to the same reason. At least three passengers were injured in the boat

Seeing the boats sinking, four engine boats from nearby places rushed to the spot and rescued the injured passengers. The boatmen, later, recovered the bodies of the two women.

The other passengers of the two boats, however, managed to swim ashore.

On Sunday morning, the situation turned vulnerable as the water from the river started entering the area through the breach points.


Finding no other alternative, people of the area voluntarily started repairing the breach portions by putt-

If the dyke collapsed, vast Kochashaher, Shibpur, Rakhal Bruj, Kamardaha

"Finally we repair the breach portions by erecting bamboo spars and dumping sand bags," said Mokhles, a farm labourer.

It could be difficult to save the dyke if the villagers did not do the job on a voluntary basis, said Abdul Latif Prodhan, chairman of Mohimaganj union parishad.
