## JOURNALIST DIPANKAR MURDER 'Bring culprits to book without further delay'

The newsmen of the district formed a human chain at Satmatha in the town yesterday, demanding exemplary punishment to the killers of noted journalist Dipankar Chakrabarty, former vice president of Bangladesh Federal Union of Journalists (BFUJ).

Chaired by president of Bogra Union of Journalists (B U J) A H M Akhtaruzzaman, the programme was organised to mark the 10th death anniversary of the newsmen.

The participants urged the government to carry out fresh investigation into the murder case and bring the 'real' killers to book.

They also threatened to go for tougher movement if the demand was not met without further delay.

On October 2 in 2004,

Dipankar, 54, was hacked to death by criminals at Shannalpara in Sherpur municipality area.

The following day, the son of the deceased Partho Sarothi Chakrabarty, filed a murder case with Sherpur police station, accusing some unidentified people.

Nine IOs so far had been assigned to probe the killing of Dipankar, but none could unearth the clue to the murder and identify the killers, said Partho.

Contacted, the last investigation officer of the case and ASP (CID) Abdus Samad Mia said police submitted the final report releasing seven suspected arrestees last year as they had no connection with the killing.

Senior Judicial Magistrate ATM Tofael Ahmed yesterday fixed November 17 for fresh hearing in the case.

## Brutality by in-laws: Acid attack on housewife

A housewife sustained burn injuries in an acid attack allegedly by her in-laws following a family feud at Binonderpara village in Sadar upazila on Wednesday.

The injured, Shikha, 28, wife of Masud Rana of the village, was admitted to Jamalpur General Hospital with injuries in shoulder and knee.

Police arrested her brother-in-law Shakil Ahmed alias Babu, 20, and sister-in-law Sabina Yasmin Shila, 25, on charge of attack.

Victim's father Alal Uddin filed a case against Babu and Shila in this connection yesterday afternoon.


According to the case statement, the accused threw acid at Shikha while she along with her domestic help Sonia, 16, was watching television in her room on Wednesday night.

Sonia saw Babu and Shila running away after the incident, it added.

At that time, Shikha's husband Masud Rana was not at home as he works at a garment factory in Dhaka.

## 2 hacked to death in Rangpur, Bogra

Two people were hacked to death by unknown gangs in Rangpur city and Bogra town yesterday.

The victims are Shafiqul Islam, 30, son of Mujibur Rahman of Fokirtari area in Rangpur city and Ziaul Haque, 32, son of Late Raich Uddin of Dharampur area in Bogra town.

Our Rangpur correspondent quoted locals as saying that a gang of four waylaid Shafiqul at Kadamtoli area at around 7:00am and hit him with sharp weapons, leaving him critically injured.

Locals rushed Shafiqul to Rangpur Medical College Hospital (RMCH) where the doctors declared him dead.

Officer-in-Charge Md Abdul Qader Jilani of Rangpur Kotwali Police Station said Shafiqul might have been killed over previous enmity.

In Bogra, a gang swooped on Ziaul in Rajabazar area of the town at around 2:30 pm and hit him with sharp weapons. He died instantly, reports our correspondent.

There had been a long-standing dispute between Ziaul and some of his neighbours over a land in Dharampur area and he recently filed a case with Sadar Police Station over the issue. The accused in the case killed him while he was going to a relative's shop in the area, claimed relatives.

Contacted, Nazir Ahmad Khan, ASP (Circle-A) of Bogra, said Ziaul might have been killed over a land dis-

pute. The body was sent to Ziaur Rahman Medical College Hospital morgue for autopsy.

Police are investigating the matter and trying to arrest the killers, the ASP added.
